Whereas, Smt Manjeet Kaur [001390], the then Principal, Government Senior Secondary School, Mohri Bhanokheri [29] (Ambala) now posted at Government Senior Secondary School, Ballana [12], Ambala was charge sheet under Rule-7 of HCS (P&A) Rules, 2016 on 19.03.2018/06.04.2018 and the following allegations were leveled against her:-

“That in the school Sh. Satish Kumar, Punjabi Teacher was the in-charge of the mid-day-meal and three cooks i.e. Smt. Naibo, Smt. Mahinder Kaur and Smt. Satya Devi were for preparing the mid-day-meal. While preparing the mid-day-meal on dated 16.05.2017 Smt. Mahinder Kaur, Cook called two students namely Ashwani Kumar and Ajay to lift the cooker, whereas due to twist of the foot of Ajay, the cooker fell down and the student Ajay got skin burns. As such, she i.e. Smt. Manjeet Kaur failed to supervise/monitor the preparation of mid-day-meal as taking help/involving the students in preparation of the mid-day-meal is against the rules”.

Aggrieved by above said charge-sheet the delinquent submitted her reply on dated 19.03.2018 wherein she denied the allegations leveled against her but her reply was not found satisfactory in the light of comments provided by District Education Officer, Ambala on 17.05.2017. Resultantly, Shri V K Verma, Joint Director Prosecution (Retd) was appointed as Inquiry officer vide order dated 16.09.2019/01.10.2019 to conduct regular departmental enquiry. The enquiry officer submitted his report dated 19.11.2019 with remarks that charges leveled against the delinquent were not found proved.

Keeping in view the above said facts, report of the DEO, Ambala and finding of Inquiry Officer, the Governor of Haryana is pleased to file the present disciplinary proceedings against Smt Manjeet Kaur, Principal.

Whereas, Mrs. Sunita Goswami has filed CWP No. 26907 of 2019 before the Hon'ble Punjab & Haryana High Court, Chandigarh praying therein to direct the respondents to exclude the present temporary posting period from the counting as provided under the transfer policy of 2016 specifically under sub clause IV of clause 9, so that the petitioner may not be deprived of the zone 2 in future and a further prayer to direct the respondent to allot the petitioner a permanent station by opening the transfer drive

The above said writ petition was disposed of on 23.09.2019 and the operative part of the order is reproduced as under:

“Learned counsel contends that the petitioner, at this stage, would be satisfied if the present writ petition is treated as a representation and direction issued to the respondents to consider and decide the same within some specified time.

In view of the statement made by the counsel for the petitioner and without going into the merit of the case or commenting thereon, the present writ petition is disposed of with directions to the respondents to treat the same as a representation and decide the same within a period of one month from the date of receipt of certified copy of this order.

In case the claim of the petitioner is not to be accepted, then a well-reasoned and speaking order be passed and conveyed to the petitioner forthwith.

It is made clear that in case the representation is not decided within one month, there shall be costs of 25,000/- to be paid to the petitioner.”

In compliance of the above said orders the case of the petitioners was examined and it was found that the petitioner is currently working as PGT Home Science and the cadre strength of Home Science is less than 500 and the respondent department has already taken decision to not to include the teachers who have cadre strength less than 500 due to the fact that the posts of the teachers in which the cadre strength is less than 500 are mainly situated in Zone 1 or Zone 2 areas as provided in the Teacher Transfer policy, 2016 and the online web portal designed for the purpose of online general transfer drive is not developed to deal with such type of cases. Furthermore , the Chief Secretary to Government of Haryana issued the instructions bearing memo No. 45/15/2004-1GS-II vide dated 27.11.2019 wherein the directions were given regarding the general transfers, the operative part of the same is reproduced as follows:-

“Where the Sanctioned strength of a category of posts is less than 500 –

The Minister-in-charge would be competent to effect transfer in their respective department/ Board/ Corporations from 1st December,2019 to 15th December, 2019 of those Categories of posts of Group B,C, and D where the sanctioned Strength of a category of posts is less than 500 and on line transfer system is not being contemplated. All such transfers shall be consistent with the guidelines contained in sub paras (i) to (vii) of para 1 of policy and guidelines dated 7th April, 1989 as amended by guidelines dated 19.11.1998. These guidelines inter-alia pertain to the maximum period on a post, special relaxation for those who would retire within the next one year, non-posting in home districts, couple cases, specially abled employees. Further, the composite Transfer

Grant and joining time will not be admissible on transfer from one station to another except where the transfer is in public interest'

The claim of the petitioner for excluding the period spent by her in Zone-2 (her present posting) for the purpose of transfer on the ground that her present posting is temporary, is not maintainable as there is no provision in the Teacher's Transfer Policy, 2016 as amended on 01.06.2017 by which her tenure of temporary posting could be excluded from counting for the purpose of General Transfer Drive, 2019.

Moreover, the petitioner has claimed the benefit of couple case' for the purpose of the transfer, but in this regard it is to be noted that the petitioner has not been included in the General Transfer Drive, 2019 per se, and thus, the issue of considering the petitioner in the category 'couple case' does not arise at all. It is integral to mention here that the score points were awarded to the employees for various categories, including couple case, for the purpose of General Transfer Drive, 2019 but as the petitioner belongs to the category of PGTs whose cadre strength is less than 500, the petitioner has not been included in the General Transfer Drive, 2019.

In the light of above mentioned facts the claim of the petitioner is not maintainable and there is no substance in the representation of the petitioner and the same is liable to be rejected, being devoid of any merits.

I order accordingly.

ORDER No. 13/217-2019 PGT-II (6) DATED, PANCHKULA, THE 19/6/2020

Whereas, Mr. Jai Singh (Emp ID No.: 214111) PGT Hindi has filed the CWP No. 32503 of 2019 before the Hon'ble High Court along with one Suman Lata for issuance of a writ in the nature of Certiorari for quashing the impugned transfer orders dated 22.08.2019 (Annexure P-10 & P-11) respectively issued by the respondents to transfer the petitioners with further prayer to send back the petitioners at their previous place of posting and also with a prayer to directing the respondents to take a decision on the representations of the petitioners dated 30.10.2019 & 01.11.2019 (Annexure P-16 & P-17 respectively).

The writ petition came for hearing before the Hon'ble Court on 08.11.2019 and the Hon'ble Court was pleased to dispose of the same with directions to respondents as under:

“Prayer in the writ petition is for quashing of impugned transfer orders dated 22.08.2019 (Annexures P-10 & P-11 respectively)

Learned counsel for the petitioners submits that he will be satisfied if direction is issued to respondent No.2 to consider and decide representations dated 30.10.2019 and 01.11.2019 (Annexure P-16 & P-17 respectively) within a stipulated period.

Without going into the merits and demerits of the claim of the petitioners, I deem it appropriate to direct respondent No.2-Director of Secondary Education, Haryana, Shiksha Sadan, Sector 5, Panchkula to consider the representations dated 30.10.2019 and 01.11.2019 (Annexure P16 & P-17 respectively) within a period of two months from the date of receipt of certified copy of this order and pass a speaking order thereon, failing which respondent No.2 shall be liable to pay costs of `25,000/-

to the petitioners. This condition of imposing costs is only to prevent petitioners running from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court.

The writ petition stands disposed of with the above direction.”


Whereas, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of administrative or litigational nature.

The case of the petitioner is examined and it was found that he was rightly transferred vide order dated 22.08.2019 as he was given a temporary manual posting due to new appointment and also a condition was specified in the appointment letter that he has to keep his MIS profile updated for participation in the next online transfer drive and also the representation dated 30.10.2019 has been perused and it has been found that the submission of the petitioner that certain number of posts have been kept blocked by the Department and have been unblocked at a later point of time for manual adjustment of other teachers does not hold any ground as no teacher has been allotted a post/station which was kept blocked except for those who were granted benefit of interim stay on their transfer by the order of Hon'ble High Court. Moreover, the submission of the petitioner, through the representation dated 30.10.2019, that the petitioner has not been allotted any station out of the options he opted for in the online drive stands vitiated by the fact that the petitioner obtained a score of 40.0932 and the mentioned stations in the representation have been allotted to the employees who obtained score higher than that of the petitioner.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended time to time) and there is no substance in the representation of the petitioner and the same is liable to be dismissed, being devoid of merits.

I pass order accordingly.

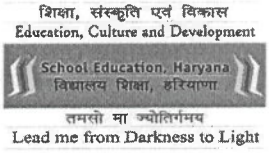

1. यह कि राम अवतार, लिपिक ने स्व. श्री कृष्ण लाल (ESHM) तत्कालीन गणित अध्यापक रा0व0मा0वि0, दुलहेड़ी, भिवानी की सेवापंजी उनके वर्तमान विद्यालय को नहीं भेजी, जिस कारण सम्बन्धित कर्मचारी ए0सी0पी0 तथा वेतन वृद्धि के लाभ से वंचित रहा। जिस वजह से कर्मचारी को न्यायालय में सिविल सूट दायर करनी पड़ा। न्यायालय के आदेश उपरान्त भी राम अवतार, लिपिक ने प्राचार्य द्वारा कर्मचारी स्व0 श्री कृष्ण लाल की सेवापंजी उपलब्ध नहीं करवाई। जिस कारण विभाग को कोर्ट की अवमानना का नोटिस प्राप्त हुआ।
2. यह कि राम अवतार, लिपिक ने स्व. श्री कृष्ण लाल (ESHM) तत्कालीन गणित अध्यापक रा0व0मा0वि0, दुलहेड़ी, भिवानी को उनकी सेवापंजी उपलब्ध न करवाकर उनके साथ अभद्र व्यवहार किया गया तथा अभद्र भाषा का प्रयोग करके उनको मानसिक रूप से परेशान किया।

कर्मचारी द्वारा चार्जशीट का उत्तर दिनांक 18.11.2019 को दिया गया। जिसमें कर्मचारी द्वारा तर्क दिया गया कि स्वर्गीय श्री कृष्ण लाल (ESHM) तत्कालीन गणित अध्यापक द्वारा सेवापंजिका डिस्पैच न0 1490 दिनांक 18.03.2011 के तहत स्वयं प्राप्त करने के बाद अपना ए0सी0पी0 तथा वेतन के लाभ भी प्राप्त कर लिए थे क्योंकि सेवापंजिका उनके पास थी और वो खुद उस समय विद्यालय के मुख्य अध्यापक थे। प्राप्त किये गये लाभों (ACP and arrear of payment) की कापी साथ संलग्न की थी। इसके बाद स्वर्गीय श्री कृष्ण लाल ने दिनांक 15.08.2011 को स्कूल में चोरी होने की एफ0आई0आर0 भी पुलिस थाने में दर्ज करवा दी गई थी जिसमें उन्होंने मुख्य अध्यापक का बैग जिसमें जरूरी दस्तावेज थे, चोरी होने के बारे रिपोर्ट दर्ज करवाई थी। इसके बाद स्वर्गीय श्री कृष्ण लाल की नई सेवापंजिका दिनांक 01.05.2018 को बना दी गई थी और कोई भी देय लाभ उनके विद्यालय और विभाग में लम्बित नहीं है।

दोषी कर्मचारी श्री रामअवतार, लिपिक से उत्तर प्राप्त होने उपरान्त मैं सक्षम अधिकारी द्वारा दिनांक 17.03.2020 को निजी सुनवाई का अवसर प्रदान किया गया। कर्मचारी द्वारा दिये गये उत्तर, और निजी सुनवाई के दौरान उस द्वारा दिये गये स्पष्टीकरण के आधार पर, मैं सक्षम अधिकारी होने के नाते कर्मचारी की नियम-7 की चार्जशीट को निरस्त करते हुए भविष्य में सचेत रहने की चेतावनी देने के आदेश पारित करता हूं।


