Whereas Smt. Kanta Devi widow of Sh. Aman Kumar (ESHM), Govt. Middle School Garhi Sikandarpur, (Panipat) approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.23043 of 2018- Kanta Devi Vs. State of Haryana & others praying therein for issuance of a writ in the nature of mandamus directing the respondents to grant benefit of monthly financial assistance as per the Haryana Compassionate Assistance to the Dependents of the Deceased Government Employee Rules, 2006, notified on 01.08.2006. This writ petition came for hearing before the Hon'ble High Court on 21.11.2018 wherein Ld. Counsel for the petitioner submitted that the petitioner would be satisfied, at this stage, in case a time bound direction is given to the respondents to decide the said representation. The Hon'ble High Court, keeping in view this request and without expressing any opinion on the merits of the case and the claim being made in the said representation, disposed of the writ petition. The operative part of this order dated 21.11.2018 is reproduced as under:-

"Keeping in view the request made by counsel for the petitioner, without expressing any opinion on the merits of the case and the claim being made in the said representation, the respondents are directed to decide the representation/application dated 31.05.2018 (Annexure P-6) by passing a speaking order within a period of three months from the date of receipt of certified copy of this order. In case, it is found after the decision that the petitioner is entitled for any monetary relief, the same should also be released to her within a period of next three months."

After having certified copy of this order dated 21.11.2018, the concerned District Elementary Education Officer, Panipat was directed to submit relevant record of the case. The concerned authority produced the record and the same is perused. After due consideration of the representation (P-6) and record made available found that the petitioner was 2<sup>nd</sup> wife of deceased Govt. employee, namely, Sh. Aman Kumar, ESHM died on 19.11.2017. The petitioner has been found a legally wedded wife since the deceased got divorce from his 1<sup>st</sup> wife but it has been observed that there is a son, namely, Abhishek from the 1<sup>st</sup> wife. It has also been observed that the petitioner has two daughters, namely, Anshika & Kashish born from present marriage but the petitioner, after death of her husband, relinquished these daughters and started residing with her father at Village & Post Office- Alewa, District- Jind. All the three children have been brought up by their father's sisters (Buas).

It has also been noticed that a civil suit has been filed by these three children to have the ex-gratia benefits of their father's service before the Ld. Civil Court at Panipat and the same is still pending. In present representation, the petitioner has concealed this civil suit. Accordingly, it has been found that the petitioner has not approached the Hon'ble High Court with true mind, accordingly, not entitled to any relief under law of equity.

However, the Govt. of Haryana has notified the Haryana Compassionate Assistance to the Dependents of the Deceased Government Employee Rules, 2006 to assist the family of a deceased/missing Government Employee, in tiding over the emergent situation, resulting from the loss of the breadearner while in regular service by way of granting financial assistance. In the present case, both the parties have been granted opportunity of personal hearing twice on 07.01.2020 & 11.02.2020 to have a settlement between opposite parties. After having two opportunities, it has been observed that the children are not interested to live with petitioner, namely, Smt. Kanta Devi. It has also been observed that Smt. Kanta Devi

Jus -

failed to produce any claim or proof or document which may prove that she has ever tried to have guardianship of her two daughters.

It has also been noticed that while granting ex-gratia benefits under the Haryana Compassionate Assistance to the Dependents of the Deceased Government Employee Rules 2006, the rules defined in Family Pension Scheme, 1964 have to be pursued. Rule-4 of Family Pension Scheme 1964, says as under:-

#### "4. This scheme is administered as below:-

- (i) The family pension is admissible in case of death while in service or after retirement on or after the 1st July, 1964, if at the time of death, the retired officer was in receipt of a compensation, invalid, retiring or superannuation pension. The family pension will not be admissible in case of death after retirement if the retired employee at the time of death was in receipt of gratuity only. In case of death while in service a government employee should have completed a minimum period of one year of continuous service without break.
- (ii) "Family" for the purposes of this scheme includes the following relatives of the officer:-
  - (a) wife, in the case of a male officer;
  - (b) husband, in the case of a female officer;
  - (c) minor sons;
  - (d) unmarried minor daughters;
  - (e) widowed/legally divorced daughters; and
  - (f) the parents of an unmarried officer.

#### (iii) The pension is admissible—

- (a) in the case of widow/widower up to the date of death or remarriage, whichever is earlier;
- (b) in the case of son/unmarried daughter until he/she attains the age of twenty five years;
- (c) in the case of parents who were wholly dependent on the Government employee when he/she was alive, up to the date of death provided the deceased employee had left behind neither a widow nor a child;
- (d) in the case of children in the order of their birth and younger of them will not eligible for family pension unless the elder next above him/her has become ineligible for grant of family pension:
- (e) in the case of divorced/widowed daughter till they are alive:

Provided that an unmarried daughter including widowed/divorced daughter will become ineligible for pension from the date of her marriage/remarriage:

Provided further that the son/unmarried daughter including widowed/divorced daughter shall become ineligible for pension if he or she starts earning livelihood.

The income criteria in respect of parents and widowed/divorced daughter shall be that their earning is not more than Rs. 2550/- per month.



Provided also that parents and widowed/divorced daughter shall produce an annual certificate to the effect that their earning is not more than Rs. 2550/- per month The upper ceiling of family pension shall be 30% of basic pay of the deceased employee, subject to a minimum of Rs. 1913/- per month."

It is evident itself from this Rule-4 (ii) (supra) that beside the wife, minor son(s) and daughter(s) are equally entitled to property or family pension of deceased person. During both opportunities, no claim from parents' side has been received. Accordingly, it has been presumed that the parents' of deceased Govt. employee were not dependent upon him. It has also been noticed that the son, namely, Abhishek has now attained majority, therefore, entitled to have this benefit as per rule. However, the two daughters are still minor.

After considering the above submitted facts and circumstances and taking a view that the dependents (wife and children) deserve financial assistance to tide over this situation, accordingly, it has been concluded that all the four dependents be granted assistance in equal parts as per statutory provisions of Family Pension Scheme, 1964 read with Hindu Succession Act, 1956. Separate Bank Saving Account of each and every dependent be got opened and share of each be got deposited in these accounts separately by the Drawing & Disbursing Officer. The saving account in name of minor daughters be opened under guardianship of their elder brother, namely, Abhishek. It has also been concluded that the amount deposited in account of minor daughters be withdrawn for their benefit after having special permission from Hon'ble Competent Civil Court under the appropriate law so that the possibilities of misuse of deposited amount be nullified. However, claim of petitioner for ex-gratia benefits of her deceased husband as defined in representation (P-6) is decided and she would be entitled to have one fourth of the ex-gratia amount only. However, it is clarified that the guardianship of minor daughters is not decided herein. The claimant may approach the concerned Drawing & Disbursing Officer with proper legal and valid documents.
