ORDER

In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education, Rules, 2003, sanction is hereby accorded for permanent recognition to Gyan Deep Sr. Sec. School, VPO, Saman (Rohtak) run by Managing Committee, Gyan Deep Education Society, VPO, Saman (Rohtak) for classes 11th to 12th in subjects of (Arts Stream) under BOSE pattern with effect from 01.04.2020 under the following terms and conditions:-

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn
17. If any information at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

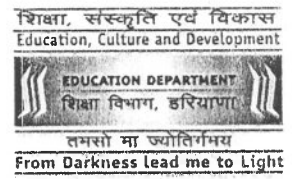

Order No. 13/100-2019 HRME-I (4)

Dated, Panchkula, 23/06/2020

Whereas, the petitioners have filed the CWP No. 12206 of 2019 titled as Kuldeep & others Vs State of Haryana and others, for issuance of a writ in the nature of certiorari for quashing the impugned action of the respondent authorities in not granting the arrear of pay since the deemed date of appointment by ignoring fact that the petitioner have been deprived of the status of Govt. Employee due to the pendency of the litigation and not due to fault of the petitioners as well as in compliance of various judgments passed by this Hon'ble Court as well as by the Hon'ble Supreme court of India and further in not taking any decision over the application/reminder presented by petitioners and further for issuance of a writ in the nature of mandamus directing the responding authority to grant the arrear of pay along with interest in compliance of various judgment passed by this Hon'ble court as well as by the Hon'ble Supreme Court of India and the petitioners had already been granted the benefit of deemed date of appointment, seniority, pay at par with their juniors and arrear thereof had already been granted. The above mentioned CWP came up for hearing on 18.10.2019 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 18.10.2019 is as under:-

"Without going into the merits and demerits of the claim of the petitioners, I deem it appropriate to direct respondent No.2-Director Secondary Education Haryana, Plot No.1B, Shiksha Sadan, Sector 5, Panchkula to consider the representation dated 16.09.2018 (Annexure P-8) within a period of two months from the date of receipt of certified copy of this order and pass a speaking order thereon, failing which respondent No.2 shall be liable to pay costs of `25,000/- to the petitioners. This condition of imposing costs is only to prevent petitioners to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court.

The writ petition stands disposed of with the above direction."

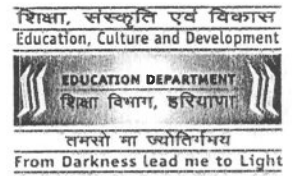
In compliance of the above said order, the case record and legal notice of the petitioners were examined and it was found that the petitioners were appointed on 8.5.2013 as per the recommendation of the Haryana Staff Selection Commission Sector-2, Panchkula vide letter no. HSSC/Conf./CL89/2010/311 dated 20.3.2013 on the post of Clerk Field Cadre (Group-C). Thereafter some of the candidates filed a

bunch of writ petition i.e. CWP No. 3429 of 2009 and CWP No. 53 of 2009 which were disposed of on 3.8.2010. The operative part of the order dated 3.8.2010 is as under:-

"These petitions are, accordingly, disposed of with a direction to respondents to appoint the petitioner against 12 ESM category vacancies on the basis of their inter se merit from the merit list dated 15.10.1989. The first 12 meritorious petitioners would be appointed against these vacancies irrespective of the category within a period of two months."

It is pertinent to mention here that thereafter petitioners and non petitioners of CWP Nos. 3429 of 2009 & 53 of 2009 challenged the judgment and order dated 3.8.2010 by filing LPA Nos. 1509, 1579 and 1768 of 2010 which were disposed of on 9.11.2012. The operative part of order dated 9.11.2012 is as under:-

"We thus set-aside the direction of the learned Single Judge given in the order dated 03.08.2010 or other orders which confined to the filling up the posts on the basis of the inter-se merits of the writ petitioners alone. Instead, it is directed that 103 numbers of vacancies which according to the State of Haryana still exist pertaining to the period 15.10.1989 to 18.11.1995 shall be filled up strictly on the basis of the merit position in the merit list prepared by the respondents.

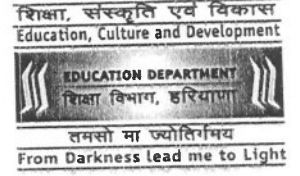
With the aforesaid directions, all the aforesaid Letters Patent Appeals and Civil Writ Petitions are disposed of."

Thus, in compliance of the above said order dated 9.11.2012 passed by the Hon'ble Punjab and Haryana High Court, the petitioners were given appointment on the post of Clerk Field Cadre (Group-C) vide order no. 13/80-2013 HRME-I (5) 8.5.2013 and in continuation of this office order, the petitioners of the present writ petition and the petitioners in CWP No. 3429 of 2009 and CWP No. 53 of 2009 & LPA Nos. 1509, 1579 and 1768 of 2010 were granted the benefit of appointment from deemed date i.e. 12.4.1990, seniority and fixation of pay from the date their junior in rank were appointed vide order no.13/265-2013 HRME (5) dated 15.6.2015. Further it is worthwhile to mention here that neither in original writ, nor in CWP No. 3429 of 2009 and CWP No. 53 of 2009 & LPA Nos. 1509, 1579 and 1768 of 2010 there was no order regarding arrear or pay of the intervening period. Further it is stated that the petitioners are claiming benefit of arrear of pay along with interest through the instant writ petition which is not tenable. Thus, the petitioners are not entitled for the arrears of the pay along with interest for the period from 1989 to 2013 during

which they were not in the service on the principle of No Work No Pay. Hence the claim of petitioners is hereby rejected.

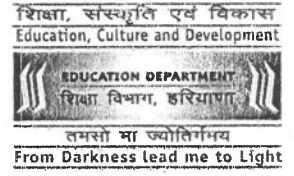
