While being posted as Principal, Government Senior Secondary School, Bastil (Karnal) from 11.09.2017 to 25.09.2019, Shri Rajiv Kumar committed following acts of omission and commission:-

That District Education Officer, Karnal submitted report dated 12.09.2019 wherein it was mentioned that FIR No. 164 dated 26.05.2019 was registered in Police Station Rewari under section 120-B, 201, 420, 467, 468, 471 of Indian Penal Code 1860 and 66, 66b, 66d of Information Technology (Amendment) Act, 2008 against him i.e. Shri Rajiv Kumar for leaking the paper i.e. Naib Tehsildar being conducted by the Haryana Public Service Commission. He i.e. Shri Rajiv Kumar got bail on 31.08.2019 from the Hon'ble Sessions Judge Rewari. He i.e. Shri Rajiv Kumar remained absent without approval from duty w.e.f. 27.05.2019 and joined at Government Senior Secondary School, Bastil, Karnal on 01.09.2019. Thus, following lapses were found on his part i.e. Shri Rajiv Kumar:-

It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, Shri Jitender Gaur, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to Shri Jitender Gaur that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

While being posted from 07.09.2017 to 03.12.2019 as Principal, Government Senior Secondary School, Nindana (Rohtak), Shri Jitender Gaur committed certain acts of omission and commission for which he is charged as under:

That Smt Vandana Gupta, Deputy Director Office of Director Secondary Education, Haryana, Panchkula, was appointed as Inquiry Officer vide order dated 11.06.2019/14.06.2019 to enquire the complaints dated 22.04.2019 made by Smt Sarita, Post Graduate Teacher Political Science Office of Government Senior Secondary School, Nindana (Rohtak) and report dated 13.08.2019 was submitted by Smt Vandana Gupta wherein she concluded that allegations leveled by the complainant in complaints dated 22.04.2019 against him i.e. Shri Jitender Gaur, found to be proved and following irregularities/lapses were found on his part i.e. Shri Jitender Gaur:-

- That he i.e. Shri Jitender Gaur withheld the salary of Smt Sarita, Post Graduate
 Teacher, Political Science for one month i.e. January 2018 which was paid to her i.e.
 Smt Sarita in February 2018.

HARYANA GOVERNMENT SCHOOL EDUCATION DEPARTMENT ORDER

Whereas, Shri Pawan Kumar Beniwal, the then Principal, Government Senior Secondary School, Seria [3181], Jhajjar [under suspension] was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules , 1987 on 12.12.2014/18.12.2014 and the following allegation was allegation was leveled against him:-

रिपोर्ट कमांक स्था—1—14/2038 दिंनाक 18.02.2014 के अनुसार श्री पवन कुमार बेनिवाल ने अपने आवेदन दिंनाक 03.08.2012 द्वारा दिनांक 05.09.2012 से 31.03.2016 तक घरेलू परिस्थितियों के कारण अवैतनिक अवकाश हेतु प्रतिवेदन दिया, परन्तु प्रतिवेदन के साथ सेवापंजी नहीं भेजी। पुनः दिंनाक 02. 10.2012 से 30.11.2012 तक विदेश जाने के लिए छुटटी हेतु आवेदन दिया, परन्तु वे बिना अवकाश स्वीकृत करवाए तथा बिना सक्षम अधिकारी की अनुमित के विदेश चले गए।

Shri Pawan Kumar Beniwal, Principal did not submitted his reply to the charge sheet dated 18.12.2014. Thereafter, Shri B K Srivastva, IAS (Retd) was appointed Inquiry Officer on 01.08.2018/14.08.2018 to conduct regular departmental enquiry and report dated 09.01.2019 was submitted by him wherein charges were found proved against him. In this context, the operative part of findings dated 09.01.2019 is reproduced as under:-

"In conclusion, he is a person so irresponsible that he goes and stays ex-india for such long period. Further, he was dishonest too, as he did not convey his purpose of leave in both the leave applications which was very much required if he was to go abroad".

Further, the findings dated 09.01.2019 were forwarded to the delinquent on 03.05.2019/10.05.2019 under sub rule (C)(1) of Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 with direction to make representation within 30 days but no representation was made by the delinquent on the findings of I.O.

Thereafter, the Charged Officer was granted opportunity of personal hearing on 27.108.2019 and he submitted representation dated 30.09.2019 at the time of personal haring. It is was mentioned by the delinquent that his family was green card holder of USA and he wants to education his wards from USA for their better future for which he applied for Extra Ordinary Leave on 03.08.2012 for the period 05.09.2012 to 31.03.2016 but he proceeded abroad on 18.09.2012 as approval was not granted to him. It was also mentioned by him that he also got tangled in medical emergency on 19.09.2013 and survived Heart Attack in December, 2014 for which he got treated in USA and recovered in August-September 2017.

On examination of the facts of the case, submission of the delinquent and findings Inquiry Officer, I find no force in the submission of the delinquent. In fact, the delinquent willfully proceeded abroad without obtaining prior approval of the Government for sake of his personal interest and his submission that he tangled into medical exigency is also not acceptable. It is thereby proved that he remained absent from duty from 05.09.2012 till 31.03.2016 and thus, no leniency should be afforded to him for remaining abroad without approval.

In view of the above, the Governor of Haryana has ordered to dismiss Shri Pawan Kumar Beniwal [058190], Principal from the service. In this context, Secretary, Haryana Public Service Commission has given their concurrence vide no. DIS/33/2019/12940 dated 10,02.2020.
