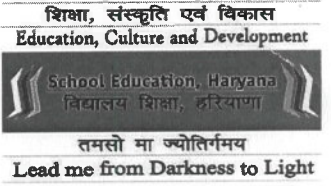

Order No.13/185-2019 PGT-II (6) Dated, Panchkula, the 14.2.2020

Whereas, Sh. Manoj Kumar [208558] PGT Hindi has filed the CWP No. 27248 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of Certiorari quashing the impugned transfer order dated 22.08.2019 (Annexure P-6) and to stay the operation of impugned order (Annexure P-7) during the pendency of the petition or to issue any writ, order or direction which the Hon'ble court may deem fit in the facts and circumstances of the case.


Whereas the above mentioned writ petition was disposed of on 22.10.2019 and the operative part of the order is reproduced as under:

"Prayer in the present writ petition is for quashing of impugned transfer order dated 22.08.2019 (Annexure P-6).

The impugned order is dated 22.08.2019, thus, it would be not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy/

With aforesaid direction, the writ petition stands disposed of."

Whereas, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him,



across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

Whereas, in compliance of the above directions of the Hon'ble High Court the petitioner was provided opportunity of personal hearing on 26.11.2019. During the personal hearing the petitioner has submitted that he participated in the Transfer Drive as his post was put in 'blocked list'. The case of the petitioner is examined and it was found that he was been rightly transferred as his post was declared surplus due to the process of rationalization/normalization in light of teacher/student ratio in the particular school as per Teachers Transfer Policy, 2016 dated 29.06.2016 and as amended on 01.06.2017 and no postings can be done on surplus posts. The process of rationalization is carried out prior to the Transfer Drive on the basis of student enrolled in a particular school and the posts sanctioned of that subject and certain number of seats are blocked for allocation during transfer drive and teacher already posted at such posts are made to participate in the transfer drive compulsorily so as to maintain an optimum student-teacher ratio across the schools in the State of Haryana and for best usage of teachers rather than posting/keeping at a station where there is no requirement of a teacher due to lesser number of students in the school.



In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended time to time) and there is no substance in the representation of the petitioner and the same is liable to be dismissed, being devoid of merits.

I pass order accordingly.

Whereas, Smt Bhupesh Kumari [023809], Principal, GSSS, Shamgarh, Karnal has preferred present appeal against the order of Director General Secondary Education, Haryana dated 24.06.2019 issued under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016.


That while working as Principal at Government Girls Senior Secondary School, Gharaunda [1781], Karnal (25.05.2012 to 07.09.2017) Smt. Bhupesh Kumari was charge-sheeted under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 22.05.2017 due to her failure to file reply in the Hon'ble Court within time even after having clear instructions from higher authority. Smt Bhupesh Kumari submitted reply against her charge sheet on 05.06.2017, wherein she denied the charges levelled against her with prayer that said chargesheet may be dropped in the interest of justice. Thereafter, she was granted an opportunity of personal hearing by the competent authority i.e. DGSE on 19.04.2019 wherein she reiterated the submissions already made in her reply to the charge sheet. After examining the case of appellant the competent authority (DGSE) ordered on 24.06.2019 to inflict upon her punishment of stoppage of one increment without cumulative effect along with one step downgrading of ACR for the year 2017-18.

Against the order of Director General Secondary Education, Haryana, the appellant preferred present appeal to which she was granted opportunity of personal hearing on 03.02.2020. During the course of hearing, appellant stated in her defence that summons were received in her office on 03.12.2016 and she requested to District Education Officer, Karnal for assistance in preparation of written reply but her request was refused but she failed to prove that what kind of assistance she required from higher authority even after clear instructions to file the reply. Further, she denied the fact that there was delay on her part to file the reply in the court even after clear instruction from higher authority i.e. DEO which is not expected from responsible Govt. officer as it will be matter of both embarrassment and economical loss to the government if any adverse order were passed in the said case.

Keeping in view the above said facts and circumstances, contents of appeal submission of made by appellant and documents relied upon by her, it is observed that there was delay in filing the reply within time and further, there was dereliction in duty by the appellant by not following the instructions of the higher authority.

Therefore, the Governor of Haryana, is pleased to uphold the order passed by the competent authority (DGSE) as the case has rightly been decided on merits by following the due process of law. Hence, the present appeal is dismissed being devoid of merits.

It is ordered accordingly.

Whereas, Smt Bhupesh Kumari [023809], Principal, GSSS, Shamgarh, Karnal has preferred present appeal against the order of Director General Secondary Education, Haryana dated 24.06.2019 issued under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016..


That While working as Principal at Government Girls Senior Secondary School, Gharaunda [1781], Karnal (from 25.05.2012 to 07.09.2017) Smt. Bhupesh Kumari was charge-sheeted under rule -8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 14.12.2017. Smt Bhupesh Kumari submitted reply dated 28.12.2017 against her charge sheet dated 14.12.2017 wherein she denied the charges levelled against her with prayer that said charge sheet may be dropped against her in the interest of justice. She was granted an opportunity of personal hearing on 03.05.2019 by the competent authority (DGSE) and punishment of stoppage of one increment without cumulative effect along with one step downgrading of ACR for year 2016-17 was inflicted upon her vide order dated 24.06.2019.

Thereafter, against the order of Director General Secondary Education, Haryana, the appellant has preferred present appeal wherein she was granted opportunity of personal hearing on 03.02.2020. During the course of hearing, the appellant relied upon salary bills for the period June, 2012 to June, 2013 and stated that proportionate salary was given to Shri Siddarth Mishra, SS Master. The appellant further denied charging of Rs 25/- per students as photograph fee and regarding the charge of maintaining cash book and she retriated that the same was incomplete as the post of Clerk was vacant in the school and Lab Assistant was inexperienced to carry out such work.

On examination of the contents of appeal, submissions made by the appellant, examination of the salary bills along with other record, it is found that Shri Siddarth Mishra, SS Teacher was paid proportionately instead of full salary during the above said period. Further, letter dated 21.08.2017 addressed to SDO(C), proves that the record of the school was not in possession of the appellant. Beside that the charge of collecting Rs. 25/- per student is not proved as incharge of class 9th have given in writing that no funds were collected from the students by the appellant. But the contention of the appellant that cash book was not maintained because the Lab Assistant was inexperienced, is not justified.

Keeping in view the above said facts and circumstances, it is observed that no financial irregularities has been proved against the appellant and no financial loss to state ex -chequer has been caused by her. Therefore, Governor of Haryana is pleased to set aside the order passed by the DGSE and she should be censured.

It is ordered accordingly.

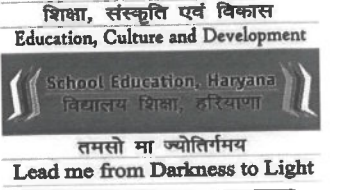
