ORDER No.13/225-2019 PGT-IV (3) DATED, PANCHKULA, THE 27.02.2020

Whereas, Mr. Amit Kumar (Employee ID 202775) PGT Mathematics has filed the CWP No. 29032 of 2019 before the Hon'ble High Court challenging the transfer orders dated 22.08.2019 whereby the petitioner is transferred from GSSS Dhareru (354) to GSSS Baliaala (3265) issued by the Department with further prayer to stay the relieving order or to issue any writ, order or direction which the Hon'ble court may deem fit in the facts and circumstances of the case.

Whereas the above mentioned writ petition was disposed of on 04.10.2019 and the operative part of the order is reproduced as under:

***"In view of statement made by learned counsel for the petitioner and without going into merit of case or commenting thereon, present writ petition is disposed of with a direction to respondent No.2 to decide the representation dated 14.09.2019 (Annexure P-12) or any additional representation which petitioner intends to make by passing a well reasoned and speaking order within a period of one month from the date of receipt of certified copy of this order.***


***In case, representation is not decided within aforementioned specified time, there shall be costs of Rs. 25000/- to be paid by the concerned officer to the petitioner. "***

Whereas, the Government of Haryana framed Teachers Transfer Policy, 2016 dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended

policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

Whereas in compliance of the above directions of the Hon'ble High Court the case of the petitioner is examined and it was found that he was transferred as he had completed the minimum required years of service in a single zone i.e. 5 years and same has been done as per policy. It is pertinent to mention here that the petitioner has



opted for 100 stations and the 100<sup>th</sup> station is allotted to the person named as Sunil Kumar (091667), who has 37.0384 points as per the teacher transfer policy whereas the petitioner has obtained 35.7836 points as per the teachers transfer policy, so petitioner has been transferred in 'Anywhere in state' category. Hence the petitioner has allocated seat as per the merit of the petitioner as well as the 100 stations opted by the petitioner were allocated to the persons higher in merit than the petitioner in a transparent & fair manner.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended time to time) and there is no substance in the representation of the petitioner and the same is to be dismissed, being devoid of merits.

I order accordingly.

Whereas, the petitioners have filed the Civil Writ Petition No. 20423 of 2011 titled as Chander Bhan & Others V/s State of Haryana and others in the Hon'ble Punjab and Haryana High Court, Chandigarh under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of Certiorari quashing the impugned order/letter dated 13.05.2010 (Annexure P-5) being violative of the Haryana Civil Services (Revised Pay) Rules, 2008 and Haryana Civil Services (ACP) Rules, 2008 with all consequential benefits of re-fixation of pay accordingly; and further for issuance of a writ in the nature of Mandamus directing the respondents to re-fix the pay of the petitioners as per the rules issued/framed under Article 309 of the Constitution of India prior to the issuance of the order/letter dated 13.05.2010 (Annexure P-5) with all consequential benefits; and further during the pendency of the present writ petition, order of recovery from the petitioners may kindly be stayed.

The said writ petition was decided on 08.10.2018 and the operative part of the order dated 08.10.2018 is re-produced as under:-

***"The present petition is disposed of in the light and in the same terms of the order passed in CWP No. 9322 of 2011, Narender Pal Singh Arya and another Vs. State of Haryana & others and other connected writ petitions disposed of on 03.10.2016. Consequential benefits be calculated and disbursed to the petitioners.***

***Ordered accordingly."***

Further, stated that the present civil writ petition was listed in the Hon'ble High Court on 02.11.2018 and passed the following order. The operative part of the orders dated 02.11.2018 is reproduced as under:-

***"The Registry has pointed out that in the final order dated 08.10.2018 passed in the aforementioned writ petition the number of reference writ petition has wrongly been mentioned as CWP 9322 of 2011 instead of CWP No.3922 of 2011. The correct number is CWP No. 3922 of 2011.***


***In view thereof, the mistake is ordered to be corrected. The number of CWP No. 9322 of 2001 in the body of order be read as CWP No.3922 of 2011."***

Further, stated that earlier the CWP No. 3922 of 2011 titled as Narender Pal Arya Vs. State of Haryana & Others was filed in the Hon'ble

High Court in which orders/letters dated 09.04.2010 and 13.05.2010 issued by the Finance Department were challenged. The said letters were challenged being violative of the Haryana Civil Services (Revised Pay) Rules, 2008 and Haryana Civil Services (ACP) Rules, 2008. CWP No. 3922 of 2011 was allowed along with other writ petitions connected with same matter vide dated 03.10.2016 by the Hon'ble Court.


Whereas, against the order dated 03.10.2016, LPA No. 2460 of 2017 filed by the department was dismissed vide Order dated 31.07.2018. Further, against the order dated 31.07.2018 passed by the Hon'ble High Court, the State has filed the SLP No. 47523 of 2018. The SLP was listed in the Hon'ble Supreme Court on 06.05.2019 and impugned order dated 03.10.2016 has been stayed and the SLP is still pending for final adjudication. Keeping in view of the pending SLP in the Hon'ble Apex Court in the matter, the claim of the petitioners is kept pending till the final adjudication of SLP.
