Whereas, Dharamveer, filed C.W.P. No. 32370 of 2019 titled as Dharamveer Vs State of Haryana & Others praying therein for issuance of a writ in the nature of mandamus directing the respondent no. 2 to consider and promote the petitioner to the post of TGT English with all consequential benefits as junior to the petitioner has already promoted and case of the petitioner is squarely covered by the judgment dated 12.09.2018 Annexure P-6(Colly). The petitioner has further prayed for direction to be given to the respondent to consider and decide the legal notice dated 19.08.2019 (Annexure P-8) in view of the judgments Annexure P-6(Colly) and promotion order Annexure P-7 (Colly).

The Hon'ble High Court vide order dated 07.11.2019 disposed of the said writ petition with the following orders:

"Petitioner herein seeks issuance of a writ in the nature of mandamus directing respondent No.2 to consider and promote him to the post of TGT English along with consequential benefits arising therefrom.

Learned counsel for the petitioner submits that junior to the petitioner has already been promoted. He further submits that case of the petitioner is squarely covered by the judgment dated 12.09.2018 (Annexure P-6).

In the premise, petitioner submitted a representation dated 08.06.2018 (Annexure P-5), but the same has not been adverted by the respondents till date. Hence, the writ petition.

Notice of motion.

On advance service of the petition, Mr. Sunil Kumar Vashisth, DAG, Haryana appears and accepts notice on behalf of the State.

Given the nature of order being passed, there is no necessity to seek return by the respondents as no

further proceedings and/or pleadings are required.

Without commenting on the merits of the case, the writ petition is disposed of with a direction to the respondents to objectively consider the representation dated 08.06.2018 (Annexure P-5) and also by keeping in view the contentions stated in the present writ petition by treating it as a supplementary representation and pass a speaking order in accordance with law.

It is expected of the respondents that while passing a speaking order on the representation of the petitioner, the respondents shall also take into consideration the judgment passed by this Court contained at Annexure P-6.

Let the needful be done within a period of 3 months from the date of receipt of a certified copy of this order.

Disposed of in above terms”.

In compliance of order dated 08.11.2019 of the Hon'ble High Court, legal notice dated 19.08.2019 of the petitioner has been considered. As such in pursuance of the memo dated 24.05.2018, all the petitioners who are possessing the qualification of Matric with Hindi and 2 years Diploma in Education as well as qualification of B.A and B.Ed. and as such are eligible for promotion from the post of JBT teachers to the post of TGT (English) approached the DEEO Sirsa to send their cases for promotion to the post of TGT (English) to the Directorate Elementary Education Haryana.


It is mentioned that vide memo dated 27.04.2018, it is directed by the Directorate Elementary Education to all the DEEOs to send the cases of the JBT and C&V teachers for promotion to the post of TGT English and Punjabi etc and as per this memo case to be submitted up to 24.05.2018.

it is pertinent to mention here that petitioner has passed B.A. and had secured 47.5% and in Elective subject i.e. English secured 47% which does not fulfill the requisite qualification. The petitioner has also

passed D.Ed and had secured First Division. As per the Civil Service Rules, 2012, the petitioner does not fulfill the requisite qualification, Accordingly the claim for promotion to the post of TGT (English) has been rejected.

Considering all facts and circumstances of the case, the present representation is found devoid of merits, accordingly, his claim of the petitioner for the promotion to the post of TGT (English) cannot be accepted.

Order accordingly.


