for Director General Secondary Education, Harvana, Panchkula Statement of allegation against Smt. Raj Bala Yadav [055388] the then Block Elementary Education Officer, Narnaul [6789], Mahendergarh [now posted at Deputy District Education Officer (4098), Mahendergarh]

While being posted as Block Elementary Education Officer, Narnaul (Mahendergah) from 26.03.2012 to 18.06.2014, Smt Raj Bala Yadav committed following acts of omission and commission:-

That Additional Director, Mid-Day-Meal Office of Director, Elementary Education, Haryana, Panchkula was appointed to enquire into the non-provision of Mid Day Meal to students of ASD High School, Narnaul from 01.02.2012 to 06.07.2014 and an enquiry was conducted on 22.07.2019, 24.07.2019 and 30.07.2019. In this context, report dated 09.09.2019 was submitted by the Inquiry Officer and concluded that no demand of Rice was made by ASD High School on or after last supply of Rice on 23.12.2013. Further, the District Authorities failed to inform about this fact to the Directorate i.e. Director Elementary Education, Haryana, Panchkula and thus, the District Education Officer, Narnaul and Block Education Officer, Narnaul were found to be negligent. Thus, following lapses were found on her part i.e. Smt Raj Bala:-

- 1. That she i.e. Smt Raj Bala failed to prepare the record of demand and supply of Mid-day-Meal at Block level while working as Block Education Officer, Narnaul
- 2. That she i.e. Smt Raj Bala neither prepare or examine the record for the demand or disbursement of honorarium to be paid to the helpers in private school i.e. ASD High School, Narnaul under Mid-Day-Meal scheme nor any efforts were made by her i.e. Smt Raj Bala for promotion of Mid-Day-Meal scheme.
- 3. That she i.e. Raj Bala neither made any surprise inspection of private schools nor examine the authenticity for honorarium being given to Mid-Day-Meal helpers.
- 4. That she i.e. Raj Bala while working as Block Education Officer, Narnaul failed to make arrangement for preparation, distribution and demand of Mid-Day-Meal for ASD High School, Narnaul and thus, gave promotion to mismanagement. Resultantly, deserving beneficiary of Mid-Day-Meal were remained deprived from benefits of this scheme and as such, complaint was made before the National Human Right Commission, New Delhi.
- 5. That she i.e. Smt Raj Bala hide the factual position while filing the reply of complaint made before the National Human Right Commission, New Delhi and penalty of Rs 2 Lac per student was imposed by the National Human Right Commission, New Delhi vide order dated 13.03.2019.

In this way, she i.e. Smt Raj Bala as such, committed an act unbecoming of a Government officer acted in a negligent, irresponsible manner with malafide intentions and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services, (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part Smt. Raj Bala Yadav [055388] the then Block Elementary Education Officer, Narnaul [6789], Mahendergarh [now posted at Deputy District Education Officer (4098), Mahendergarh] rendering her liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statement of charges against Smt. Raj Bala [055388] the then Block Education Officer, Kanina [5079], Mahendergarh [now posted at Deputy District Education Officer (4098), Mahendergarh]

While being posted as Block Elementary Education Officer, Narnaul (Mahendergah) from 26.03.2012 to 18.06.2014, Smt Raj Bala Yadav committed following acts of omission and commission for which she is charged as under:-

That Additional Director, Mid-Day-Meal Office of Director, Elementary Education, Haryana, Panchkula was appointed to enquire into the non-provision of Mid Day Meal to students of ASD High School, Narnaul from 01.02.2012 to 06.07.2014 and an enquiry was conducted on 22.07.2019, 24.07.2019 and 30.07.2019. In this context, report dated 09.09.2019 was submitted by the Inquiry Officer and concluded that no demand of Rice was made by ASD High School on or after last supply of Rice on 23.12.2013. Further, the District Authorities failed to inform about this fact to the Directorate i.e. Director Elementary Education, Haryana, Panchkula and thus, the District Education Officer, Narnaul and Block Education Officer, Narnaul were found to be negligent. Thus, following lapses were found on her part i.e. Smt Raj Bala:-

- 1. That she i.e. Smt Raj Bala failed to prepare the record of demand and supply of Mid-day-Meal at Block level while working as Block Education Officer, Narnaul
- That she i.e. Smt Raj Bala neither prepare or examine the record for the demand or disbursement of honorarium to be paid to the helpers in private school i.e. ASD High School, Narnaul under Mid-Day-Meal scheme nor any efforts were made by her i.e. Smt Raj Bala for promotion of Mid-Day-Meal scheme.
- 3. That she i.e. Raj Bala neither made any surprise inspection of private schools nor examine the authenticity for honorarium being given to Mid-Day-Meal helpers.
- 4. That she i.e. Raj Bala while working as Block Education Officer, Narnaul failed to make arrangement for preparation, distribution and demand of Mid-Day-Meal for ASD High School, Narnaul and thus, gave promotion to mismanagement. Resultantly, deserving beneficiary of Mid-Day-Meal were remained deprived from benefits of this scheme and as such, complaint was made before the National Human Right Commission, New Delhi.
- 5. That she i.e. Smt Raj Bala hide the factual position while filing the reply of complaint made before the National Human Right Commission, New Delhi and penalty of Rs 2 Lac per student was imposed by the National Human Right Commission, New Delhi vide order dated 13.03.2019.
