Whereas, Sh. Mool Chand Yadav, Deputy Director (Retd.) office of Director Secondary Education Haryana, Panchkula was charge-sheeted under rule -7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide Order No. 5/116-2008 HRG-I(1)/2967 dated 03.03.2016, wherein the following allegation was leveled against him:-

"यह कि चतुर्थ श्रेणी कर्मचारियों का वांछित रिकार्ड भेजने हेतु सतर्कता विभाग द्वारा उनके पत्र क्रमांक 13963/राज्य चौकसी ब्यूरो, हरियाणा, पंचकुला दिनांक 21/24.09.2007 के अनुसार अनुरोध किया गया परन्तु उन द्वारा सतर्कता विभाग के पत्र का कोई जवाब नहीं दिया तथा न ही सतर्कता विभाग द्वारा चतुर्थ श्रेणी कर्मचारियों के रिकार्ड सम्बन्धि जांच में उन द्वारा कोई सहयोग नहीं दिया गया "

Sh. Mool Chand Yadav submitted the reply to charge-sheet on 31.03.2016 in which he refuted the charges leveled against him and requested to consider the reply sympathetically in view of the justification given by him in the reply. In view of the reply, personal hearing was granted to him for 15.11.2018, 27.11.2018, 19.12.2018, 17.01.2019 and 24.01.2019 before ACSSE. But Sh. Mool Chand Yadav failed to appear before Competent Authority.

Thereafter Sh. Vijay Kumar Verma, Joint Director Prosecution (Retd.) was appointed an Inquiry Officer vide order no. 5/80-2016 HRG-I(1) dated 17.09.2019/11.10.2019. The Inquiry Officer has submitted enquiry report on 25.12.2019 to this Department. The operative part of the findings/report is as under:-

"The perusal of Cross-examination of Shri Dharam Chand, Retired DSP, PW1, clearly shows that the delinquent in the capacity of the principal did not appoint Shri Parmod Kumar, but only allowed him to join the duties on his transfer by the orders of District Primary Education Officer, Narnaul. He also stated that medical examination is done at the time of First entry in the service. Therefore, it was not necessary to get Shri Parmod Kumar, Class-IV employee to get him medically examined again. The perusal of Ex. P1 clearly shows that Block Education Officer, Ateli had given regular appointment to Shri Parmod Kumar and the delinquent has nothing to do with this. The service book entry Ex. P2 at Page 93 of this file corroborates this version. The perusal of the statement of Shri Sumit Kumar, Clerk PW-3 also clearly reveals that Shri Parmod Kumar was appointed as Kahar-cum-Chowkidar vide letter Ex. P-3 by Block Education Officer, Ateli. He had also produced LPC Ex. P5. The delinquent also in his cross-examination by the presenting officer stated that he never made any appointment. He stated that Shri Jai Dayal Singh, Block Education Officer, Ateli had made the appointment on 01.12.2003. He had also relied on the documents already produced and relied by the department. The perusal of the certificate dated 22.03.2016 of the present principal at Page 139 of the file also clearly shows that Shri Parmod Kumar, Kahar-cum-Chowkidar, was not appointed by the office of the Principal, GSSS Dholera.

In the light of facts and circumstances explained in the foregoing paras, the charges against the delinquent are not proved."

Keeping in view of facts of the case, findings of Inquiry Officer and documents relied upon by delinquent, the Governor of Haryana is pleased to file the present charge sheet against Sh. Mool Chand Yadav.

It is ordered accordingly.

Statement of charges against Sh. Jai Parkash [007833], the then District Elementary Education Office, Bhiwani [now suspended]

While being posted as District Elementary Education Officer, Bhiwani from 08.03.2019 to 31.12.2019, **Sh. Jai Parkash** committed certain acts of omission and commission for which he is charged as under :-

That he i.e. Sh. Jai Parkash approved/ made deputation of 25 (Twenty Five) deputation orders although he i.e. Sh. Jai Parkash was incompetent to pass such orders and he i.e. Sh. Jai Parkash also failed to seek prior approval of the competent authority. Thus, he i.e. Sh. Jai Parkash violated the provisions of Teacher Transfer Policy, 2016 and Chief Secretary, Haryana instructions no. 15/16/2017-1GS-II dated 18.07.2019.

In this way, he i.e. Sh. Jai Parkash committed an act unbecoming of a Government officer by performing his duty with malafide intention and in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016, Teacher Transfer Policy, 2016 and Chief Secretary instruction dated 18.07.2019.

The lapses detailed above constitute grave misconduct on the part of Sh. Jai Parkash [007833], the then District Elementary Education Office, Bhiwani [now suspended] rendering him liable for strict disciplinary action under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statement of allegations against Sh. Jai Parkash [007833], the then District Elementary Education Office, Bhiwani [now suspended].

While being posted as District Elementary Education Officer, Bhiwani from 08.03.2019 to 31.12.2019, Sh. Jai Parkash committed following acts of omission and commission :-

That the Education Department framed Teacher Transfer Policy, 2016 to regulate transfers to ensure equitable, demand based distribution of teachers/Heads to protect academic interest of students and optimise job satisfaction amongst its employees in a fair and transparent manner. Further, the transfer of various teaching faculties are being carried out by initiating transfer drive and the Administrative Secretary, School Education, Haryana with the prior approval of the Chief Minister, Haryana, shall be competent to transfer any teacher to any place in relaxation of any or all of the provisions after recording reasons justifying such relaxation. In addition to this, Chief Secretary, Haryana issued instructions no. 15/16/2017-1GS-II dated 18.07.2019 that temporary transfer or short term deputation shall be exercised only with prior approval of Hon'ble Chief Minister. On examination of the said facts, following irregularity was found to be committed on his part i.e. Shri Jai Parkash:-

That he i.e. Sh. Jai Parkash made following deputation although he was incompetent to pass such orders:-

As such he i.e. Sh. Jai Parkash failed to seek prior approval of the competent authority for such deputation and thus, he violated the provisions of Teacher Transfer Policy, 2006.

In this way, he i.e. Sh. Jai Parkash committed an act unbecoming of a Government officer by performing his duty with malafide intention and in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016, Teacher Transfer Policy, 2016 and Chief Secretary instruction dated 18.07.2019.

The lapses detailed above constitute grave misconduct on the part of Sh. Jai Parkash [007833], the then District Elementary Education Office, Bhiwani [now suspended] rendering him liable for strict disciplinary action under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Shri Suresh Kumar [002245] the then District Elementary Education Officer, Yamuna Nagar now Principal, DIET Tejli (Yamuna Nagar) was charge-sheeted under rule -8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/88-2019 HRG-I(2) dated 13.02.2020 with the following allegations levelled against him:-

"यह कि दिनांक 28.03.2019 को प्रातः 11.00 बजे उपायुक्त महोदय द्वारा लघु सचिवालय के कमरा नं० 203 में जिले के सभी विभागध्यक्षों के साथ मीटिंग आयोजित की गई थी, जिस बारे बैठक में भाग लेने हेतु आपकी ई-मेल आई डी पर कार्यालय के पत्र क्रमांक 257/ए.एम.सैल दिनांक 19.03.2019 सूचना भेज दी गई थी। परन्तु आप इस मीटिंग में निश्चित समय तथा तिथि पर उपस्थित नहीं हुए। जिस कारण उपायुक्त महोदय के द्वारा कार्यालय के पत्र क्रमांक 264/ए०एम०सैल दिनांक 01.04.2019 के द्वारा कारण बताओ नोटिस भेजकर दो दिन के अन्दर - अन्दर अपनी स्थिति स्पष्ट/जवाब देने हेतु कहा गया था, परन्तु आप द्वारा न तो मीटिंग में भाग लिया तथा न ही अपनी स्थिति स्पष्ट करते हुए जवाब दिया गया।"

Shri Suresh Kumar has given the reply to the charge-sheet and submitted that a meeting was fixed by the Director Elementary Education, Haryana, Panchkula on 28.03.2019 through video conference regarding the admission under 134-A of Right to Education Act vide memo no. 33/1-2017 PS(E-1) dated 27.03.2019 and the Deputy DEO office of DEO Yamuna Nagar was deputed by him to attend the meeting of Deputy Commissioner, Yamuna Nagar. The same reply was also given to the Deputy Commissioner, Yamuna Nagar. The Deputy Commissioner, Yamuna Nagar while considering the reply case has been filed.

Keeping in view the above said facts and circumstances and documents relied upon, the Governor of Haryana is pleased to file the above said charge-sheet against Sh. Suresh Kumar, the then District Elementary Education Officer, Yamuna Nagar now Principal, DIET Tejli (Yamuna Nagar)

Whereas, Vedpal Singh and others approached the Hon'ble Punjab & Haryana High Court at Chandigarh by way of filing a Civil Writ Petition No. 22500 of 2019- Vedpal Singh and others Vs State of Haryana & others praying therein for granting the benefit of proportional increment to the petitioners for the service rendered by them after getting their last increment in light of the law laid down by the Madras High Court in CWP No. 15732 of 2017- P. Ayyamperumal versus Union of India (Annexure P-2).

The writ petition came for hearing before this Hon'ble Court on 26.08.2019 wherein the Hon'ble Bench pleased to dispose of the same with directions to respondents to decide the legal notice dated 01-06-2019 (Annexure P-6) within a period of three months. The operative extract of order dated 26-08-2019 is reproduced herein for ready reference as under:

"Learned counsel for the petitioners further states that petitioners will be satisfied, in case a time bound direction is given to the respondents to decide their claim raised in the legal notice dated 01.06.2019 (Annexure P-6).

Without commenting upon the merits of the case or about the entitlement of the petitioners for the relief which has been claimed by them in the legal notice dated 01.06.2019 (Annexure P-6), the present writ petition is disposed of with a direction to the respondents to decide the legal notice dated 01.06.2019 (Annexure P-6) within a period of three months from the receipt of copy of this order. In case, it is found that the petitioners are entitled to any monetary benefits after the decision of the legal notice, the same should also be paid to the petitioners within three months thereafter.

However, it is made clear that the arrears will be restricted from the date when the legal notice was served by the petitioners i.e. 01.06.2019 (Annexure P-6).

Present writ petition stands disposed of."

On receiving copy of above-said judgment, the grievance of the petitioners as unfolded in legal notice dated 01-06-2019 has been considered. After due consideration, it has been found that all the petitioners have already been retired from service on attaining age of superannuation on 30.06.2016, 30.06.2013, 30.06.2013, 30.06.2008, 30.06.2008, 30.06.2015 and 30.06.2006 respectively. Whereas the Date of next increment in the revised pay structure as defined under Rule-10 of the Haryana Civil Services (Revised Pay) Rules, 2008 is 1st of July every year. The relevant Rule-10 is produced as under:

"10. Date of next increment in the revised pay structure:—

There will be a uniform date of annual increment, viz. 1st July of every year. Employees completing 6 months and above in the revised pay structure as on 1st of July will be eligible to be granted the increment. The first increment after fixation of pay on 1.1.2006 in the revised pay structure will be granted on 1.7.2006 for those employees also for whom the date of next increment was between 1st July, 2006 to 1st January, 2007:

Provided that in the case of persons who had been drawing maximum of the existing scale for more than a year as on the 1st day of January, 2006, the next increment in the revised pay structure shall be allowed on the 1st day of January, 2006. Thereafter, the provision of rule 10 would apply:

Provided further that in case where an employee reaches the maximum of his pay band, shall be placed in the next higher pay band after one year of reaching such a maximum. At the time of placement in the higher pay band, benefit of one increment will be provided. Thereafter, he will continue to move in the higher pay band till his pay in the pay band reaches the maximum of PB-4, after which no further increments will be granted."

Further, as per version of the petitioners, on 1st July (year of retirement), the petitioners concerned were not an employee. On date of retirement i.e. 30th June, the relationship of employer and employee came to an end. The Rule-2(2) defines the persons to whom the provisions of Revised Pay Rules, 2008 are not applicable. Such persons are described as under:

"2(2) These rules shall not apply to:-

- (a) Members of All India Services working in connection with the affairs of Government of Haryana;***
- (b) Officers of judicial services working in connection with the affairs of Government of Haryana;***
- (c) Persons not in whole time employment;***
- (d) Persons paid otherwise than on monthly basis, including those paid on a piece-rate basis or on daily wages basis or on contract basis;***
- (e) Persons employed in Government service after retirement;***
- (f) Persons re-employed in Government service after retirement;***
- (g) Government servants who are drawing their pay in a pay scale as personal measure (other than the functional pay scale prescribed for the post held by the Government servant) with effect from the date on which he started drawing his pay in the pay scale as a personal measure and till the time he draws his pay in the pay scale as a personal measure;***
- (h) Any other class or category of persons whom the Government may, by order, specifically exclude from the operation of all or any of the provisions contained in these rules.***

So on 1st July (as per petitioner), the petitioners are not covered under definition of Government Servant as on 1st July, the petitioners are pensioner(s) and not the employees of the govt. and they are eligible to get

pension as per rule 2(2) of 2008 Rules as mentioned above on that date.

It is also relevant to submit further that as per Rule 6.19(C) of Punjab Civil Service Rules, Volume-II defines the emoluments which have to be reckoned for pension. This Rule 6.19(C) says as under:

6.19-C.(i) [The term "emoluments" for these purposes shall mean "pay" as defined in rule 2.44(a)(i) of Punjab Civil Services Rules Volume I, Part I. If a Government employee immediately before his retirement or death has been absent from duty or on leave with allowances his emoluments for the purpose of calculating service gratuity or death-cum-retirement gratuity should be taken at what they would have been had he not been absent from duty.]

- (ii) Pay drawn in tenure appointment(s) will count provided the service in tenure appointment(s) does not qualify for grant of special additional pension.**
- (iii) There will be no change in the existing principle of reckoning those emoluments for pension which are paid by the Government. In other words the entire amount drawn as emoluments by a Government employee while on Foreign Service will not count for pension and gratuity. In such a case, the pay which the Government employee would have drawn under the Government had he not been sent on Foreign Service will alone be taken into account.**
- (iv) In the case of employees on deputation to any other State Government or the Central Government, the emoluments which he would have drawn, had he not proceeded on deputation, will alone be taken into account.**

Since on date of retirement, the petitioner was getting a specific pay, therefore, he is entitled to get his pension fixed on basis of that

specific pay. It means that the relief claimed by the petitioners is away from true statutory provisions, therefore, deserves to be declined/rejected, being a hypothetical one.

Besides the above statutory provisions, the contents of judgment passed in **CWP No. 15732 of 2017- Ayyamperumal versus Union of India & others**, decided on 15-09-2017, have also been construed. After due construction, it has been observed that the Hon'ble Division Bench has construed the provisions of pay and date of increment only. The Hon'ble Division Bench has not construed the statutory provisions applicable on fixation of pension; therefore, this judgment serves no help to petitioners for benefit of pension.

It is relevant to state further that every Administrative Department has to abide by the financial provisions made by the Finance Department of the State or Union of India. The Finance Department Haryana vide its Instructions No. 6/183/2018- 4PR(FD) dated 27.08.2019 has considered the above-said judgment of Hon'ble Madras High Court. The Finance Department Haryana vide its letter dated 28-03-2019 has already requested the Centre Govt. to apprise of the latest position in this respect to the Haryana Govt. so that appropriate policy decision may be taken accordingly. Now, Ministry of Finance, Department of Expenditure, government of India has informed the State Government vide letter no. 08-09/2019-E-III A, dated 25.06.2019 that issue regarding grant of one notional increment, is under examination in Department of Personnel and Training (DOPT). Further, the remedy of Review Application and Curative Petition still subsists, therefore, the judgment cannot be considered as final one.

Considering the legal notice dated 01-06-2019 from all corners, it has been found that the contents of legal notice are mixture of conjectures and surmises of the petitioners. The petitioners have not

construed the statutory provisions of pension properly; therefore, they are not entitled to any relief on partly submissions. The legal notice has been found devoid of merits; consequently, the relief claimed therein is hereby declined/rejected.
