

Whereas, Mr Ved Parkash Yadav (Emp ID No.: 201698) PGT Geography has filed the CWP No. 32998 of 2019 before the Hon'ble High Court challenging the transfer orders issued by the Department with further prayer to stay the relieving order or to issue any writ, order or direction which the Hon'ble court may deem fit in the facts and circumstances of the case.

Whereas the above mentioned writ petition was disposed of on 15.11.2019 and the operative part of the order is reproduced as under:

"At the very outset, learned counsel for the petitioner states that the petitioner has submitted a representation on 29.08.2019 to respondent No.2 vide Sugam Sampark ticket No.201698-FSE01 dated 29.08.2019 but the same has not been decided till date

Learned counsel contends that the petitioner would be satisfied if at this stage, the petition is disposed of by directing respondent No.2 to consider and decide the aforementioned representation keeping in view the Teacher Transfer Policy, Annexure P-1, dated 29.06.2016 in accordance with law, in a time bound manner.

In the light of the position as noted above, the writ petition is disposed by directing respondent No.2 to consider and decide the aforementioned representation as submitted in Sugam Sampark vide ticket No.201698-FSE01 dated 29.08.2019 in accordance with law as expeditiously as possible preferably within a period of four weeks from the date of receipt of certified copy of this order along with copy of representation, as referred to above."

Whereas, the Government of Haryana framed Teachers Transfer Policy, 2016 dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.



c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

Whereas the case of the petitioner is examined and it was found that he has been rightly transferred as he had completed the minimum required years of service i.e. 5 years and has been transferred to his preferred station during the General Transfer Drive, 2019 i.e. station preferred at Sr. No. 73 i.e. Government Senior Secondary School Rewasan [815], NuhMewat, Nuh as the petitioner had obtained a score of 41.1507 and the station preferred by the petitioner at preference no. 72 i.e. Government Senior Secondary School KharakKalan [363], Bhiwani, has been allotted to another employee namely Mr. RakeshKumar, who had secured a score of 47.4575 for the purpose of General Transfer Drive, 2019. Despite this position, the petitioner still had certain grievances and for redressal of the same he raised his grievance through Sugam Sampark Portal. The petitioner was allowed to participate in the Grievance Redressal Transfer Drive but he chose not to opt for any preferences for Grievance Redressal Transfer Drive, 2019. So, his participation was deemed to be removed from the Grievance Redressal Transfer Drive, 2019 and he was retained at GSSS, Rewasan(815), which was allocated to him in the General transfer Drive, 2019.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no substance in the representation of the petitioner. Moreover, the plaintiff has not approached the Hon'ble Court while filing the Civil Writ Petition No. 32998 of 2019 with clean hands as the petitioner himself chose not to prefer any stations while participating in the Grievance Redressal Transfer Drive, 2019. Hence the representation of the petitioner is to be rejected being devoid of merits.

I order accordingly.
