Whereas, Shri Anil Sharma the then Principal, Government Senior Secondary School, Majri (Ambala) now posted at Government Senior Secondary School, Bichpari, Sonepat was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 28.10.2017/09.11.2017 and the following charges were leveled against him:-

- 1. That grant of Rs 14,53,250/- and of Rs 5,29,500/- under Rashtryia Mahyamik Shiksha Abhiyan for construction of rooms in school. Thus, he received total grant of Rs. 19,82,750/- for the construction but the construction work was found below specification. Accordingly, it was ordered by Consultant O/o SPD, HSSPP to dismantle the said construction work and he was ordered to deposit Rs. 12,85,250/- as recovery and it was also ordered that FIR may be got registered against him.
- 2. That an amount of Rs. 1,45,500/-, Rs. 1,92,000/- and Rs 1,92,000/- were received by him i.e. in the year 2011-12 respectively for construction of three rooms under Rashtryia Madhyamik Shiksha Abhiyan. As such, he received total Rs 5,29,500/-. The said construction work was inspected by the team i.e. Block Education Officer, Shehzadpur, SDE O/o SSA, Ambala and Account Officer O/o DPC Ambala, on 14.07.2016 and found that you he had spent Rs 6,76,000/- on the said construction. In this way, Rs. 1,46,500/- were spent in excess on the construction.
- 3. That on perusal of the pass book of account number 3257000100053433 of PTA, it was found that he had received Rs 4,21,000/- on 24.01.2012 on account of auction of trees, which was also misappropriated by him. In this regard, he was unable to produce any record regarding utilization of the same.
- 4. That he was unable to explain his position for not handing over the Parent Teacher Association charge to any official and thus, he found guilty for manipulation of the record and as such he misappropriated /embezzled the Government money.
- 5. That all the above mentioned allegations prove that you are responsible for all the financial misappropriation / embezzlements.

Shri Anil Sharma submitted his reply dated 01.10.2018 to the charge sheet and denied the allegation against him. Thereafter, Shri Om Parkash Garg, Addl Dist & Session Judge (Retd) was appointed as an Inquiry Officer vide order dated 07.03.2019/14.03.2019 to conduct regular department enquiry and. The inquiry report dated 19.06.2019 was submitted by the Inquiry Officer wherein the charge no. 2, 4 & 5 were stand proved against him. Resultantly, the findings of Inquiry Officer were forwarded to him on 20.09.2019 and the charged officer had made the representation dated 14.10.2019 against the findings of the Inquiry Officer.

Thereafter, the Charged Officer was granted opportunity of personal hearing on 04.02.2020. During the course of hearing, he reiterated the contentions already made in his defence by saying that decision to make expenditure was taken by the SMC/SMDC independently and the excess expenditure incurred in the construction of class rooms was

as per permission of JE and SDO. He further contended that no financial embezzlement was done and the extra expenditure was made due to increase in the cost of raw material but no such proof had been submitted by him except oral submissions. As regard, charge pertaining to handing over of PTA fund is concerned, the charged officer had nothing to say except the submission that PTA funds were maintained by the fund incharges and it was their duty to maintain the record.

On examination of the records, it is found that the charged officer spent excess funds amounting to Rs 1,46,500/- on the construction by diverting the funds received from other construction work without prior approval of the competent authorities. Further, he tried to escape from his responsibility by saying that the maintenance of record of PTA fund was done by some other teachers and they are responsible for lapses in maintenance of PTA fund. This is not tenable as the principal is equally responsible for not getting records of the school maintained as he was the administrative head of the school.

Keeping in view the above said facts and circumstances, findings in the inquiry report and submissions made by the charged officer during course of hearing, the Governor of Haryana is pleased to inflict the punishment of stoppage of pensionary benefit @ 25 % as the charged officer is going to retire in March, 2020.

It is ordered accordingly.

Whereas, the petitioner has filed the CWP No. 14521 of 2018 titled as Ramesh Kumar Vs State of Haryana and others, praying therein for the issuance of a writ in the nature of Mandamus commanding the respondents to consider the case of the petitioner and decide the legal notice dated 1.3.2018 (Annexure P-5) by passing a speaking order within a stipulated period. The above mentioned CWP came up for hearing on 31.5.2018 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 31.5.2018 is as under:-

"The petition is disposed of with direction to respondent No. 2 to objectively consider the legal notice (Annexure P-5) and pass a speaking order. There upon, within a period of eight weeks from the date of receipt of certified copy of this order".

In compliance of the Hon'ble High Court direction dated 31.05.2018, the legal notice dated 01.03.2018 served by the petitioner has been examined at length on the basis of record received from the O/o District Education Officer, Hisar, who is competent authority for conducting the services of fourth class employees. After due examination it has been found that the petitioner was engaged as class IV employee on part-time basis by the department in the year 13.8.1992 in GHS Khokha, Hisar and the services of the petitioner were terminated on 28.02.1999 due to his misbehavior & bad intention towards the girls students. Aggrieved, the petitioner filed a civil suit challenging his termination orders and the same was allowed on 31.08.2004 by Ld. Civil Judge (Senior Division), Hisar. Thereafter, the petitioner was reinstated in the service on 07.05.2013 and was posted at GSSS Masoodpur, Hisar. However, on the joining of regular employee, the petitioner was relieved on 01.01.2018.

It is relevant to mention that again on the representation of the petitioner by giving a sympathetic view, the petitioner was allowed to join GSSS Bhatla on 16.05.2018 but still the petitioner did not change his behavior due to which the he was earlier terminated on 28.02.1999, also he did many other activities against the direction given by the concerned Principal. In view of which, a meeting of SMDC was held on 06.12.2018 under the chairmanship of President Sh. Rajender Berwal in the presence of Smt. Sudesh Berwal, Sarpanch of Gram Panchayat, Bhatla and concerned Principal. On the report of

committee, the services of the petitioner were terminated permanently on 12.12.2018 vide order no. 231 to 234 from the office of Principal, GSSS Bhatla, Hisar.

It is also pertinent to mention here that the seniority list of Class IV employees at District level was prepared in the year of 2003 and the name of the petitioner was not in the seniority list prepared at District level because he was not in service at that time. Also, that the examples given by the petitioner in the present writ petition are from another district. Therefore, the claim of the petitioner is not maintainable and hence rejected.

I order accordingly.
