Whereas Smt. Santosh Devi (ID No.081144), age 49 years, Hindi Teacher, Government Middle School Santokhpura, Block Baund Kalan (5674), District- Charkhi Dadri approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.30646 of 2019- Santosh Devi Vs. State of Haryana & another praying therein for issuance of a writ in the nature of certiorari to get quashed impugned order of transfer dated 06.09.2019 where she has been transferred from Government Girls Senior Secondary School, Chirya, Block Dadri (386), District Charkhi Dadri to Government Middle School Santokhpura, Block Baund Kalan (5674), District Charkhi Dadri in the mid-session in violation of provisions of Teachers Transfer Policy, 2016. This writ petition came for hearing before the Hon'ble High Court on 22.10.2019 and the Hon'ble High Court pleased to issue directions as under:-

"Prayer in the present writ petition is for quashing of impugned transfer order dated 06.09.2019 (Annexure P-5).

Petitioner has been transferred from Government Girls Senior Secondary School, Chirya, Block Dadri, District Charkhi Dadri to Government Middle School Santokhpura, Block Baund Kalan, District Charkhi Dadri.

The impugned order is dated 06.09.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case, such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.

With aforesaid direction, the writ petition stands disposed of."

After having certified copy of this order, the petitioner Smt. Santosh Devi has been granted opportunity of personal hearing on 27.02.2020. She appeared in person and heard. After considering her submissions, the office record has also been considered. After due perusal of record, it has been noticed that the petitioner has concealed the true facts of her service in zone-7. She has already completed more than 5 years of service in zone-7 of District- Charkhi Dadri, accordingly, as per provisions of Teachers Transfer Policy, 2016 as amended in 2017, she is bound to participate in the next transfer drive. As per Teachers Transfer Policy, she submitted her preferences for Government Girls Middle School Makrana [4350], Charkhi Dadri, Baund Kalan; Government Middle School Makrani [5670], Charkhi Dadri, Baund Kalan and Government Middle School Santokhpura [5674], Charkhi Dadri, Baund Kalan. She has been successfully allocated her 3rd choice.


Moreover Teacher Transfer Policy 2016 also provides for the transfer of a teacher on completion of five years in a particular school. For the sake of the convenience, the Clause 6 is reproduced hereby as under:

"6. Unless protected under a provision of this policy, every teacher completing 5 years stay/tenure in a particular school/zone of any district(s), whether independently in a district or cumulatively of more than one district, of the State shall be transferred."

It has also been considered that the Classical & Vernacular Cadre of teachers has already been declared a diminishing cadre by way of notifying new Service Rules, 2012. Further, under Rule-9(5) of these Service Rules 2012, all vacant posts of C&V Cadre teachers have already been got converted in TGT Cadre, accordingly, the teachers rendering service under this cadre have only limited choice of posting i.e. a school where identical teacher of C&V cadre has been rendering service. It has also been observed that under Rule-12(1) of the Haryana School Education (Group C) State Cadre Service Rules, 2012, the Govt. of Haryana has a prerogative to appoint an employee (teacher) elsewhere in Haryana. Moreover, being a District Cadre employee, the petitioner has been allocated a new school in the same district i.e. Charkhi Dadri on her choice in the transfer drive. The petitioner failed to rebut this fact. Accordingly, her submissions against the impugned transfer order have been found devoid of merits.

Accordingly, she has rightly been transferred and allocated a new school for her posting on her choice. There seems no injustice with her in this transfer order. The representation made by the petitioner has been found devoid of merits, accordingly, the relief sought therein cannot be granted.

Order accordingly.



Whereas Shri Bhagwan and another approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No.30862/2019- Shri Bhagwan and another V/s State of Haryana & another praying therein for issuance of a writ of mandamus directing the respondents to promote the petitioners (Physically Handicapped Employee) as Middle Head with all consequential benefits in accordance with the reservation policy for handicapped employee dated 17th April, 2017 (annexure P-7) as per which 3% posts in a cadre have been reserved for persons with disabilities and also in the light of judgment dated 18.03.2010 (Annexure P-6) passed by this Hon'ble Court.

The said petition came up for hearing before the Hon'ble High Court on 24.10.2019 and was disposed off with the following directions:-

"Prayer in the writ petition is for issuance of mandamus directing the respondents to promote petitioners, being physically handicapped employees, as Middle Head with all consequential benefits in accordance with reservation policy for Handicapped Employees (Annexure P-7) in the light of judgment dated 18.03.2010 (Annexure P-6).

Learned counsel for petitioners submits that petitioners will be satisfied if a direction is issued to respondent No.2-Director Elementary Education, Haryana, Shiksha Sadan, Sector 5, Panchkula to consider the legal notice dated 08.02.2019 (Annexure P-10) in terms of judgment (Annexure P-6) within a stipulated period.

Without going into the merits and demerits of the claim of the petitioners, I deem it appropriate to direct respondent No.2-Director Elementary Education, Haryana, Shiksha Sadan, Sector 5, Panchkula to consider the legal notice dated 08.02.2019 (Annexure P-10) in terms of judgment (Annexure P-6) within a period of two months from the date of receipt of certified copy of this order and pass a speaking order thereon failing which respondent No.2 shall be liable to pay costs of 25,000/- to the petitioners. This condition of imposing costs is only to prevent petitioners from running pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court.

The writ petition stands disposed of with the above direction."

In compliance of this order, the matter has been perused in detail. After due consideration, it has been found that some identical handicapped teachers have also filed a writ petition claiming the promotion to the post of Elementary School Head Master. In pursuance of judgment dated 24.10.2019, the case of the petitioner No. 1 has been examined and it has been found that the petitioner is 70% physically handicapped and was initially appointed on the basis of handicapped against the post reserved for handicapped. The petitioner has claimed promotion in reservation on seat reserved for handicapped employee to provide 3% reservation in case of promotion to post of Elementary School Headmaster under the Haryana School Education (Group C) State Cadre Service Rules-2012.

In the view of above, it is pertinent to mention here that a order was passed by competent authority with subject to condition that the case of petitioners would be

examined for promotion when the final seniority of handicapped (Master cadre) shall be finalized. Now, the seniority list of physically handicapped of Master category is finalized and the case of the petitioners are examined by the competent authority. It has been found that the petitioner No. 1 falls at seniority No. 136 of the physically handicapped seniority list in General Category with 70% disability and petitioner No. 2 is not found in the list of 252 employees of physically Handicapped seniority dated 16.01.2020

It is also pertinent to mentioned here that there are total 108 physically handicapped post/vacancy available for 3% quota in TGT/Master Cadre. The petitioner No. 1 has retained seniority over such available vacancy for physical handicapped. The cases of the petitioners for promotion to the post of Elementary School Head Master under physically handicapped category had been examined on the basis of their seniority number as stood in the seniority list dated 16.01.2020 but the petitioners do not fall in the said criteria.

Now considering the matter from all corners, it has been found that the grievances of the petitioners deserve to be satisfied but their cases can only be consider for promotion when their turn will come as per the seniority of handicapped (Master cadre).

In the context of position explained above, the case of petitioners has been examined by the competent authority and it has been found that the petitioners are not entitled for the above said claim. Therefore, in view of the above background and factual position of the case, the claim of the petitioners are declined/rejected.

I order accordingly.

Whereas, the present civil writ petition No. 35304 of 2019-Nirmala Yadav V/s State of Haryana & Another was filed by the petitioners prayer therein for quashing the action of the Respondents for not considering the case of the petitioner for promotion to the post of Elementary School Head Master w.e.f. 19.01.2013 or from 24.08.2019, when her junior were promoted, being illegal, arbitrary, unjust, discriminatory & contrary to the provision of Rule, 9 of the Haryana Education (Group-C) State Cadre Service Rules, 2012. Further issue a writ in the nature of Mandamus directing the respondents to consider the case of petitioner for promotion to the post of Elementary School Head Mistress w.e.f. 19.01.2013 or w.e.f. 24.08.2019 i.e. the date when her juniors were promoted and grant her all consequential benefits i.e. seniority, fixation of pay, difference of arrears of salary along with interest @12% per annum from due date till its realization.

The said petition came up for hearing before the Hon'ble High Court on 05.12.2019 and the Hon'ble High Court passed the following order in which the interim part is as under:

- [1] Prayer in the writ petition is for promotion of the petitioner to the post of Elementary School Head Mistress with effect from the date her juniors were promoted on account of the petitioner fulfilling all eligibility conditions for being promoted to the said post.**
- [2] Learned counsel contends that the petitioner has served legal notice, Annexure P-5 dated 31.12.2018 in respect of the grievance which is the subject matter of the writ petition but the same has not been decided till date and in the circumstances, the petitioner would be satisfied if the writ petition is disposed of by directing respondent No.2 to consider and decide the claim made in the legal notice, Annexure P-5 dated 31.12.2018 in accordance with law in a time bound manner.**
- [3] Notice of motion.**
- [4] Mr. Harish Rathee, Sr. DAG, Haryana, who is present in Court, accepts notice and states that he has no objection to the innocuous prayer made by learned counsel for the petitioner."**
- [5] Without commenting on the merits of the claim or the entitlement of the petitioner to the relief claimed, the writ petition is disposed of by directing respondent No. 2 to consider and decide the legal notice, Annexure P-5 dated 31.12.2018 in accordance with law within a period of 3 months from the date of receipt of the certified copy of this order.**

That after receiving the said court direction from the Hon'ble High Court, the matter of the petitioner has been examined carefully and it has been found that the petitioner was initially appointed as Hindi Teacher on adhoc basis on Government Girls High School, Ateli District Mahendergarh by the office of DEO, Narnaul vide order dated 08.01.1986. Thereafter the service of the petitioner was regularized on the post of Hindi Teacher w.e.f 30.09.1988 in accordance with regularization policy framed by the Government of Haryana. Thereafter, the petitioner was promoted as SS Mistress vide order 2/6/2002-E-II


(4) dated 04.07.2005 and the petitioner had joined as TGT/Master Social Studies in GGHS Ateli Mandi District Mahendergarh on 08.08.2005.

It is pertinent to mention here that the promotion case of TGTs has been considered upto seniority No. 2700 for general category and upto seniority 10,000 for reserve category by the Directorate. The promotion cases of TGT/Master cadre are considered upto seniority No. 2700 for general category on the basis of seniority-cum-merit basis of the respective employees whereas the seniority No. of the petitioner in this cadre has been mentioned as 6546.

Besides above, the legal notice dated 31.12.2018 (Annexure P-5) has been examined by the competent authority. It has been found that, the promotion case of the petitioner will be considered on her turn as per the respective seniority of the petitioner.

Keeping in view the matter explained above, the petitioner cannot be promoted as Elementary School Head Master and claim of petitioner is rejected in above term and in compliance of Hon'ble Court direction.
