

Whereas, Mr.Rupinder Singh (ID No.: 079439) has filed a CWPNo. 28037 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of certiorari for quashing the letter dated 08.08.2019 (Annexure P-3) vide which one out of two posts of PGT-Hindi at Government Senior Secondary School, Mahendergarhwhich is alleged to be against the criteria dated 29.06.2016, strength of students and letter dated 09.08.2019 issued by Principal, GSSS Mahendergarh. The petitioner has further prayed for quashing the list uploaded on official website of the department on 16.08.2019 (Annexure P-9) qua petitioner vide which the petitioner has been included in the list of employees eligible for transfer/compulsory participant for the online transfer drive. Petitioner has further prayed for issuance of a writ in the nature of certiorari for quashing the transfer order dated 22.08.2019 (Annexure P-10).

Whereas the above mentioned writ petition was disposed of on 27.09.2019 by Hon'ble Punjab and Haryana High Court and the operative part of the order dated 27.09.2019 is reproduced as under:

"Notice of motion.

Mr. Harish Nain, learned Assistant Advocate General, Haryana.

Learned counsel contends that the petitioner, at this stage, would be satisfied if a direction is issued to respondent No.2 to consider and decide the representation dated 09.08.2019 (Annexure P-6), within some specified time.

In view of the statement made by the counsel for the petitioner and without going into the merit of the case or commenting thereon, the present writ petition is disposed of with directions to respondent No.2 to decide the representation dated 09.08.2019 (Annexure P-6) within a period of one month from the date of receipt of certified copy of this order as the transfer of the petitioner is also involved.

In case the claim of the petitioner is not to be accepted, then awell-reasoned and speaking order be passed and conveyed to him forthwith. It is made clear that in case the representation is not decided within one month, there shall be costs of Rs. 25,000/- to be paid to the petitioner.

That whereas, the Government of Haryana has framed Teachers Transfer Policy, 2016 dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and a teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station voluntarily, on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

That in compliance of the directions of the Hon'ble High Court issued vide order dated 27.09.2019, the grievances of the petitioner in his writ petition were considered and it has been found that the petitioner has been rightly transferred vide order dated 22.08.2019 as per clause 'a' mentioned above as the petitioner had already served at zone 7 for more than 5 years. Petitioner had been working as PGT Hindi at RaiBahadur M.M.M. Government Senior Secondary School Mahendergarh, Mahendragarh (3882) [Zone 3] since 06.08.2014 i.e. more than 5 years.



Furthermore, the prayer of the petitioner for inclusion of Guest Teachers does not hold any ground as the Guest Teachers are not under the purview of Teachers Transfer Policy, 2016.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no substance in the claim of the petitioner and hence, the same is liable to be dismissed, being devoid of any merits in the interest of justice.

I order accordingly.

Whereas the petitioners Smt. Santra & others filed CWP No 18457 of 2019 titled as Santra & others versus State of Haryana & others, wherein the petitioners have prayed for issuance of a writ in the nature of certiorari by partly quashing the impugned order dated 02.08.2017, 08.02.2018, 18.10.2018, 03.01.2019, 25.01.2019, 15.03.2019, 24.04.2019 and 20.12.2014 in regard to non-payment of arrears of pay from due date of regularization i.e. 27.01.1999 of the petitioners. Further, for issuance of a writ in the nature of mandamus directing the respondents to release the arrears of pay from due date of regularization i.e. 27.01.1999 alongwith interest.

The Hon'ble High Court disposed of the present writ petition vide order dated 27.11.2019. The operative part of order dated 27.11.2019 is reproduced as under:-

"Without commenting upon the merits of the claim, the writ petition is disposed of by directing respondent No.2 i.e. Director, Secondary Education, Haryana to consider and decide the claim made in the legal notice, Annexure P-15 dated 15.05.2019 and pass appropriate orders in accordance with law as expeditiously as possible preferably within a period of three months from the date of receipt of certified copy of this order."

In compliance of the order of the Hon'ble High Court, department has re-examined the case of the petitioners with the help of the committee which was constituted as per the guidelines dated 10.09.2019 of the Director Secondary Education in compliance of the order/direction dated 19.07.2019 passed in the related matter i.e. CWP No 16086 of 2019 titled as Pushpa Devi & others V/s State of Haryana & others. After re-examination of the matter, the constituted committee it has found that the petitioners were regularized in the year 2011, 2012 & 2014 by DEO, Sonepat vide order dated



03.08.2011, 21.10.2011, 09.01.2012, 08.05.2012, 18.07.2012 and 25.08.2014 as per the common district wise seniority list made according to the regularization policy of 2003 against vacant sanctioned post available in Sonepat district. Thereafter, various writ petitions were filed by the similar situated petitioners praying for regularization w.e.f. 27.01.1999. In compliance of the Hon'ble High Court order in CWP No 19327 of 2014 titled as Vijaypal V/s State of Haryana & others, the petitioners were regularized w.e.f. 27.01.1999 vide order No E-5-2014/2351-54 dated 20.12.2014, E-5-2017/1488-96 dated 02.08.2017, E-5-2018/2073-87 dated 08.02.2018, E-5-2018/3064-66 dated 18.10.2018, E-5-2019/125-128 dated 03.01.2019, E-5-2019/287-306 dated 25.01.2019, E-5-2019/659-671 dated 15.03.2019 and E-5-2019/892-904 dated 24.04.2019. The benefits were granted notionally w.e.f. 27.01.1999 without any arrear. But in actual the petitioners were not entitled for regularization under the regularization policy of 30.12.1998/25.02.1999 because for regularization under policy of 1999 initial appointment as part time on sanctioned post was must. Since the petitioners were appointed as part time Class-IV employees against unsanctioned posts, so the petitioners cannot be covered under policy of 1999. Those Class-IV part time employees who were initially appointed against un-sanctioned posts, the cases of regularization those Class-IV part time employees can only be considered according to the terms and conditions of regularization policy dated 11.11.2003.

Therefore, keeping in view of the above mentioned facts and circumstances, District Education Officer, Sonepat served show cause notice dated 13.11.2019 to the petitioners. The petitioners had given representations through their counsel in the O/o District Education Officer, Sonepat and stated that the pertitioners are fulfilling the terms and conditions of policy dated 30.12.1998/25.02.1999 but as per Departmental Policy dated 30.12.1998/25.02.1999 the petitioners are not eligible for anti-dated regularization w.e.f. 27.01.1999 because they were initially appointed

as part time class-IV employee against un-sanctioned post. Hence, the District Education Officer, Sonipat had withdrawn the order Nos. E-5-2014/2351-54 dated 20.12.2014, E-5-2017/1488-96 dated 02.08.2017, E-5-2018/2073-87 dated 08.02.2018, E-5-2018/3064-66 dated 18.10.2018, E-5-2019/125-128 dated 03.01.2019, E-5-2019/287-306 dated 25.01.2019, E-5-2019/659-671 dated 15.03.2019 and E-5-2019/892-904 dated 24.04.2019, with all consequential benefits, since they were appointed against un-sanctioned posts. Also the pay of the petitoners has been re-fixed as per the previous regularization order dated 03.08.2011, 21.10.2011, 09.01.2012, 08.05.2012, 18.07.2012 and 25.08.2014. Hence, the benefits sought by the petitioners in their legal notice dated 15.05.2019 is not tenable.

Keeping in view of the above, the claim of the petitioners has been rightly rejected by the competent authority i.e. District Education Officer, Sonepat vide office order No E-5-2020/5151-69 dated 09.01.2020.

The claim of the petitioners stands rejected.

I order accordingly.
