Order No. 13/242-2019 HRME-I (6)

Dated, Panchkula,

Whereas, the petitioner has filed the CWP No. 21805 of 2019 titled as Boora Singh Vs State of Haryana, praying therein for the issuance of a writ in the nature of Mandamus commanding the respondents to regularize the service of the petitioner w.e.f. 01.01.1999 at parity with those who have been regularized against sanction post or w.e.f. 29.12.2001 with all consequential benefits. The above mentioned Civil Writ Petition came up for hearing on 20.08.2019 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 20.08.2019 is as under:-

“Without going into the merits and demerits of the claim of the petitioner, I deem it appropriate to direct 2nd respondent-Commissioner cum-Director General, School Education, Haryana, Shiksha Sadan, Sector 5, Panchkula to consider the legal notice dated 16.03.2019 (Annexure P-4) within a period of two months from the date of receipt of certified copy of this order and shall pass a speaking order thereon, failing which respondent No.2 shall be liable to pay costs of 25,000/- to the petitioner. This condition of imposing costs is only to prevent petitioner to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court.

The writ petition stands disposed of with the above direction”.

In compliance of order dated 20.8.2019, the case record of the petitioner was examined at the length in view of the information received from the O/o DEO Fatehabad. It is pertinent to mention here that District Education Officers are competent authorities for regularizing the services of part-time class-IV employees. In pursuance to the information received from the O/o DEO Fatehabad it has been found that the petitioner was engaged on 20.5.1992 as a Part-time Class-IV and thereafter, he was regularized on 23.01.2003 under the regularization policy of 1999 when regular sanctioned post was available in that school.

Further it is worthwhile to mention here that the example quoted by the petitioner of Sh. Mohan lal, who was appointed after the petitioner on 23.5.1992 and has been regularized w.e.f. 29.12.2001 prior to the petitioner because the school in which Sh. Mohan lal was regularized, there was vacant sanctioned post of class-IV on 29.12.2001 and the school in which the petitioner was regularized, there was vacant sanctioned post of class-IV on 23.1.2003. Therefore, the petitioner was regularized on 23.01.2003. Further it is stated that prior to the regularization policy dated 11.11.2003/27.2.2004, there was no Seniority/Rule regarding the seniority list of part-time class-IV employees at District level under the regularization policy of 1999. Thus the part-time class-IV employees were regularized on the basis of availability of sanctioned vacant post of Class-IV employees by the concerned Drawing & Disbursing Officer of the Institute.

It is also pertinent to mention here that when they were regularized before 30.6.2003 under the regularization policy of 1999, there was no seniority list of class-IV

employees. Thus the petitioner cannot claim his seniority equivalent/higher to Sh. Mohan lal because both employees were working in different-2 Institutes. Now it has been decided that the claim of the petitioner is not maintainable in the interest of justice.

The claim of the petitioner stands rejected.

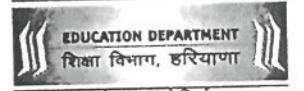

1	U/S 324/34 OF IPC	One Year Rigorous Imprisonment and Rs 500/- each as fine
2	U/S 326/34 OF IPC	Two Years Rigorous Imprisonment and Rs 500/- each as fine
3	U/S 452/34 of IPC	Two Years Rigorous Imprisonment and Rs 500/- each as fine
All the sentences shall run concurrently		


Thereafter, Sh. Krishan Lal filed Criminal Appeal No. 7-Cr.A.(IPC) of 2007 titled Krishan Lal V/s State of Haryana in the court of Additional District Session Judge Fatehabad. The appeal was dismissed vide order dated 15.7.2008.

He had filed further Criminal Appeal No. 1440 of 2008 along with Crl. Misc. No. 6876 of 2010 in the Hon'ble High Court of Punjab and Haryana at Chandigarh. The Hon'ble High Court vide its order dated 13.7.2011 held as under:-

The revision is not likely to be heard soon. In view of this conviction of the petitioner (Krishan Lal) is suspended during the pendency of revision. Crl. Misc. stands disposed of.

Sh. Krishan Lal has been superannuated at the age of 58 years on 31.03.2014. Keeping in view the conviction order dated 09.02.2007 passed by Ld. Sub Divisional Judicial Magistrate, Tohana, the suspension period i.e. 15.07.2008 to 31.03.2014 of delinquent could not be treated as duty period because conviction of delinquent is still sustained and as conviction of pendency as per Rule 90 of Haryana Civil Services (General) Rules, 2016, delinquent is only entitled for suspension allowances from the period of 15.7.2008 to 31.3.2014.

Ordered accordingly.

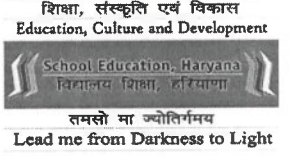

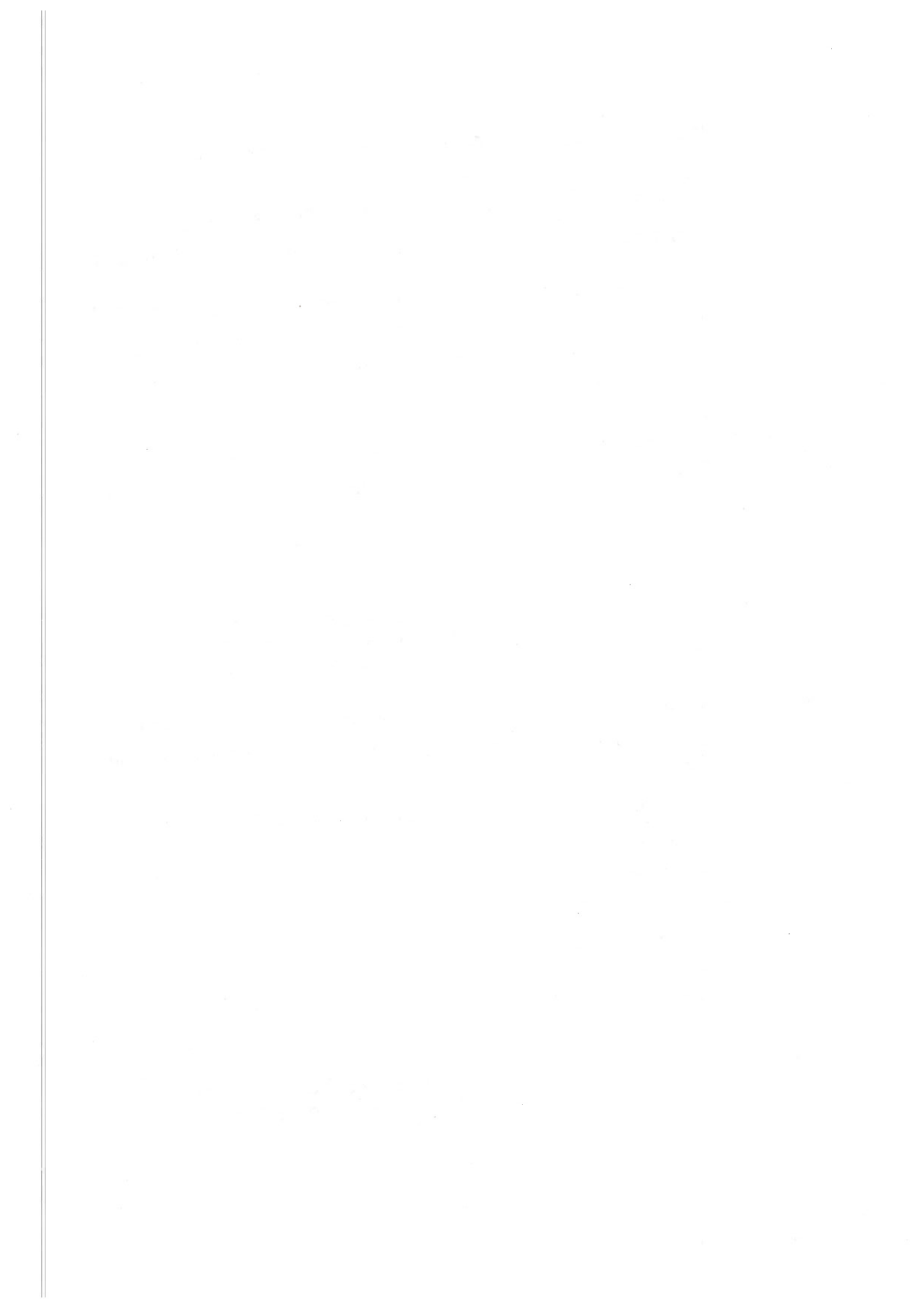
