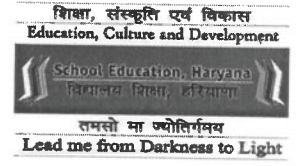

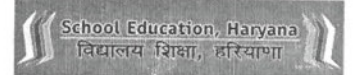

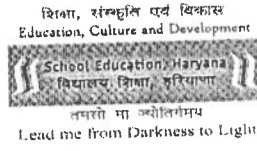

2 **Shri Joginder Hooda** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.

3 **Shri Joginder Hooda** is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If **Shri Joginder Hooda** wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Shri Joginder Hooda** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

Statement of allegations against Shri Joginder Hooda [035781] the then District Education Officer, Jind [now District Education Officer, Sonapat]

While being posted as District Education Officer, Jind from 15.02.2014 to 24.01.2017, Shri Joginder Hooda committed following acts of omission and commission:-

That the Superintendent of Police, State Vigilance Bureau (H), Hisar Range, Hisar, vide letter no. 329/SVB/HSR dated 03.02.2016, intimated that FIR NO. 11 dated 02.02.2016 under sections 7/13 Prevention of Corruption Act, Police Station State Vigilance Bureau, Hisar against Shri Mani Ram, Clerk and him i.e. Shri Joginder Hooda, was registered on the complaint of Shri Mandhir Kaushik S/o Shri Yograj Kaushik resident of 940/23, Kaushik Nagar, Jind and following irregularities were found to be committed on his part i.e. Shri Joginder Hooda:-

That he i.e. Joginder Hooda forced Shri Mandhir Kaushik S/o Shri Yograj Kaushik resident of 940/23, Kaushik Nagar, Jind, to pay the bribe of Rs 40,000/- through his subordinate i.e. Shri Mani Ram, Clerk for the sake of forwarding the case for permanent recognition upto 10th class to the school i.e. Hindu Vidya Mandir High School, Shamlo Khurd of the complainant. Further, he i.e. Shri Joginder Hooda failed to pay any heed to the requests of the complainant to forwarded his file to next level and kept pressurizing the complaint with malafide intention to meet Shri Mani Ram, Clerk. Apart from this, he i.e. Shri Joginder Hooda fled away from the office on 02.02.2016 knowingly when the Vigilance Team conducted the raid. Resultantly, FIR NO. 11 dated 02.02.2016 under sections 7/13 Prevention of Corruption Act, Police Station State Vigilance Bureau, Hisar, was registered against him leading to his arrest i.e. Shri Joginder Hooda on 10.06.2016 and prosecution sanctioned against Shri Joginder Hooda was also issued on 01.06.2017. Thus, he i.e. Shri Joginder Hooda dented the dignity of the department by his acts and conduct.

In this way, he i.e. Shri Joginder Hooda committed an act unbecoming of a Government officer by performing his duty with malafide intention in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Shri Joginder Hooda the then District Education Officer, Jind [now District Education Officer, Sonapat] rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statement of charges against Shri Joginder Hooda [035781] the then District Education Officer, Jind [now District Education Officer, Sonapat]


While being posted as District Education Officer, Jind from 15.02.2014 to 24.01.2017, Shri Joginder Hooda committed certain acts of omission and commission for which he is charged as under :-

That the Superintendent of Police, State Vigilance Bureau (H), Hisar Range, Hisar, vide letter no. 329/SVB/HSR dated 03.02.2016, intimated that FIR NO. 11 dated 02.02.2016 under sections 7/13 Prevention of Corruption Act, Police Station State Vigilance Bureau, Hisar against Shri Mani Ram, Clerk and him i.e. Shri Joginder Hooda, was registered on the complaint of Shri Mandhir Kaushik S/o Shri Yograj Kaushik resident of 940/23, Kaushik Nagar, Jind and following irregularities were found to be committed on his part i.e. Shri Joginder Hooda:-

That he i.e. Joginder Hooda forced Shri Mandhir Kaushik S/o Shri Yograj Kaushik resident of 940/23, Kaushik Nagar, Jind, to pay the bribe of Rs 40,000/- through his subordinate i.e. Shri Mani Ram, Clerk for the sake of forwarding the case for permanent recognition upto 10th class to the school i.e. Hindu Vidya Mandir High School, Shamlo Khurd of the complainant. Further, he i.e. Shri Joginder Hooda failed to pay any heed to the requests of the complainant to forwarded his file to next level and kept pressurizing the complaint with malafide intention to meet Shri Mani Ram, Clerk. Apart from this, he i.e. Shri Joginder Hooda fled away from the office on 02.02.2016 knowingly when the Vigilance Team conducted the raid. Resultantly, FIR NO. 11 dated 02.02.2016 under sections 7/13 Prevention of Corruption Act, Police Station State Vigilance Bureau, Hisar, was registered against him leading to his arrest i.e. Shri Joginder Hooda on 10.06.2016 and prosecution sanctioned against Shri Joginder Hooda was also issued on 01.06.2017. Order No. 13/203-2019 HRME-I (4)

Dated, Panchkula, 02/07/2020

Whereas, the petitioner has filed the CWP No. 23176 of 2019 titled as Surinder Singh Vs State of Haryana and others, praying therein for the issuance of a writ in the nature of Mandamus directing the respondents to decide the representation dated 12.12.2018 (P-3) and the reminder dated 09.03.2019 (P-4) of the petitioner claiming promotion under the provisions of persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 as per instruction dated 17/19.04.2017 (P-2). The above mentioned CWP came up for hearing on 29.08.2019 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 29.08.2019 is as under:-

“In view of statement made by learned counsel for the petitioner and without going into merit of case or commenting thereon, present writ petition is disposed of with a direction to respondent No.2 to decide the representation dated 12.12.2018 (Annexure P-3) by passing a well reasoned and speaking order within a period of two months from the date of receipt of certified copy of this order.”

In compliance of the above said direction of the Hon'ble High Court, the representation dated 12.12.2018 (Annexure P-3) of the petitioner has been examined by the departmental committee constituted under the Chairmanship of Dy. Director HRME branch. On the basis of report submitted by the above said committee, it has been found that since 1.1.1996, department has promoted 1001 clerks to the post of Assistant on various dates.

As 3% seats are reserved for the persons with disabilities under the person with Disabilities Act, 1995. Therefore out of 1001 posts department has reserved 30 posts for the person with disabilities. Further it is also pertinent to mention here that person with disabilities are divided into 3 categories i.e. Blindness, Hearing impairment and Locomotor disability. As per the instructions no. 22/10-2013- 1GS -III dated 15.7.2014 issued by the Chief Secretary Haryana office, 3% of vacancies in case of direct recruitment to group A, B, C and D posts shall be reserved horizontally for persons with disabilities. Out of which 1% each shall be reserved for persons suffering from (i) Blindness or low vision (ii) Hearing impairment and (iii) locomotor disabilities or Cerebral palsy in the posts identified for each disability. As per instructions no. 22/10/2013-1GS-III Dated- 17/19.04.2017 issued by the General Administration Department, general services branch, office of Chief Secretary to Govt. of Haryana, grant of reservation has been made applicable in the case of promotion also vide notification dated 27.01.2017 issued vide Endorsement No. 130-SW(4) 2017 dated 03.02.2017.

That out of 30 seats reserved for the persons with disabilities since 1.1.1996, 10 seats are available in the category of locomotor disability in accordance with the instructions dated 15.7.2014 read with 19.04.2017. Further as per the seniority list of the department, petitioner stands at seniority no. 12 in the category of locomotor disabilities. As the total seats under the locomotor disability category are 10. Thus the claim of the petitioner is not tenable and not acceptable at this stage. It is further clarified here that whenever the turn of the petitioner for promotion under person with disability category i.e.

locomotor disability will come, department will consider the case of the petitioner accordingly.

The claim of the petitioner stands rejected.

I, order accordingly.
