Whereas, the Haryana Staff Selection Commission, vide letter No. HSSC-Confd-Principal/2008/60 dated 30.01.2008 made recommendation of the name of Sh. Joginder Singh, Sh. Rupender Singh and Smt. Suman Ramne for the post of Principal as per advertisement No. 6/2007 (Category No. 7). Their names figured at Sr. no. 104 to 106 in the merit list of General Category. Although, above said recommendations were made subject to final outcome of the result of CWP No. 7659 of 2006, 7658 of 2006 and 623 of 2005 pending in the Hon'ble High Court of Punjab & Haryana, Chandigarh.

In lieu of the recommendations of the Haryana Staff Selection Commission, the appointment letters were offered to above said three persons for the post of Principals vide No. 7/1-2007 HRG-I(2) dated 18.07.2008 and 31.07.2008. However, the letter of appointments were issued to them with condition that their appointments were subject to the result of above said CWPs pending in the Hon'ble Punjab & Haryana High Court and Supreme Court. Accordingly, they joined the service on the post of Principals with the above stipulated conditions.

Thereafter, Secretary, Haryana Staff Selection Commission, vide letter No. HSSC/Confd/B/2008/1001 dated 08.10.2009 recommended the name of Shri Karambir Singh, Roll No. 00344 (BC Category) at Sr. no. 29-A against General Category, Sh. Suresh Pal, Roll No. 03201 against General Category at Sr. No. 51-A and Smt Manishan Nee Dipa, Roll No. 00524 against General category at Sr. No. 103-A. It was also informed in the said letter that consequent upon the inclusion of the aforesaid candidates in the main selection list, Shri Joginder Singh Lather Roll No. 02896 (Merit No. 104, General category), Shri Rupender Singh, Roll No. 00957 (Merit No. 105, General category) and Smt Suman Ramne, Roll No. 01916 (Merit No. 106, General category) are hereby ousted from the main selection list.

Keeping in view the above recommendation of Haryana Staff Selection Commission, a Show Cause Notice was issued to Sh. Joginder Singh Lather vide order No. 7/1-2007 HRG-I(2) dated 04.11.2009/17.11.2009 to the effect that why his appointment order as Principal may not be withdrawn. Any representation which he may like to make in that connection will be considered. Such representation if any, should be made in writing and submitted within 15 days from the date of receipt of communication by him otherwise it will be presumed that he has nothing to submit in this regard and the final order will be passed accordingly.

However, the reply to Show Cause Notice was received in the office on 16.01.2010 which was considered at length. He stated in the reply to show cause notice that there was no allegation regarding concealment or misrepresentation on his part and he was also deprived for applying the 43 posts of Principal which was advertised by the

Haryana Staff Selection Commission vide advertise no. 2 dated 14.03.2008. He further stated that more than 100 posts of Principals were lying vacant in the department at that time. So in these circumstances when 100 of posts of Principals were lying vacant, there is no justification to terminate his services. Education Department as well as Staff Selection Commission are estopped by their own action. He further stated in the reply that his case is squarely covered by various decisions of the Hon'ble Punjab and Haryana High Court.

It is worth mentioning here that the appointment letter was to be withdrawn well in time. But the file was consigned by the then dealing assistant in the records conniving with the appointed officers. The matter came into the knowledge of the branch at the time of preparing the seniority of Principals. In this regard, Sh. Satinder Siwath, HCS, Joint Director has been appointed as Inquiry Officer vide order no. 7/1-2007 HRG-I(2) dated 16.01.2020/20.01.2020 to enquire the matter. After concluding the enquiry, action will be taken against the defaulting officials/officers as per rules.

After consideration of the reply to Show Cause Notice, it has been found that there is no force in the reply of the officer. Since the appointment was subject to the final outcome of the Civil Writ Petitions pending in the Hon'ble High court and the same was in the knowledge of the appointee. Therefore, Haryana Staff Selection Commission in compliance of Hon'ble Punjab & Haryana High Court, Chandigarh orders dated 17.07.2009 and 17.09.2009 passed in CWP No. 8665 of 2008, CWP No. 338 of 2009 and CWP No. 4998 of 2008, rightly recommended the alternate names of above mentioned candidates & withdrew the recommendation already made in his favor. Hence, the claim of Sh. Joginder Singh Lather is not legally tenable to continue on the post of Principal despite specific orders of Hon'ble High Court and subsequent recommendation of Haryana Staff Selection Commission to withdraw his name from the list of selected candidates. However, the connivance/negligence of officials/officers of the department equally needs investigation for which enquiry has already been entrusted to Joint Director mentioned above. Further, it is also pertinent to mention here that there was no waiting list when the recommendation/selection was made for the post of Principal by the Haryana Staff Selection Commission. Therefore, keeping in view the above said reasons, the initial appointment letter which was issue vide letter No. 7/1-2007 HRG-I (2) dated 18.07.2008 is hereby withdrawn.
