Sh. Rama Nand, Headmaster now retired is hereby informed that it is proposed by the Governor of Haryana to take action against him under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12(2) (b) of the Haryana Civil Services (Pension) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2. Sh. Rama Nand is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
3. Sh. Rama Nand is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director General, Secondary Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director General, Secondary Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If Sh. Rama Nand wishes to consult any other relevant record, which is not in the custody of the Director General, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to Sh. Rama Nand that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.
4. The written statement should be submitted direct to the undersigned.
5. The receipt of this memorandum with enclosure may be acknowledged.

**Statement of allegations against Sh. Rama Nand the then Headmaster, Government Senior Secondary School Kulan District Fatehabad (now retired from Government Senior Secondary School Damkora District Fatehabad).**

While being posted as Headmaster in Government Senior Secondary School Kulan Distt. Fatehabad from 19.02.2014 to 30.06.2017, Sh. Rama Nand committed following acts of omission and commission:-

That he i.e. Rama Nand had submitted tempered permanent physical disability certificate of 71% handicapped to obtain the extension in service after attaining the age of superannuation i.e. 58 years to 60 years and on the basis of said permanent physical disability certificate, he i.e. Sh. Rama Nand was allowed to continue in service with immediate effect till 30.11.2018 vide memo No. 2/57-16 Human Resource Gazetted-II(2) dated 05.04.2017. Further in continuation of the said orders dated 05.04.2017, the period of delay in granting sanction for extension in service was also condoned from 01.12.2016 to 05.04.2017 vide order No. 2/57-16 Human Resource Gazetted-II(2) dated 12.12.2017. Thereafter, he i.e. Sh. Rama Nand appeared in the Directorate and made a representation for updating the Human Resource Management System data where he uploaded certificate of 55% on 08.05.2018. His i.e. Sh. Rama Nand representation was sent to Information Technology Cell for necessary action and on examining the matter by Information Technology Cell his permanent physical disability certificate was found to the extent of 48%. Whereas, he i.e. Sh. Rama Nand had submitted the permanent disability certificate to the extent of 71 % issued by the Post Graduate Institute of Medical Sciences, Rohtak vide No. Neuro/16/617 dated 17.11.2016. Further, keeping in view the reasons, Sh. Rohtash Sankhla, Assistant of Human Resource Gazetted-II Branch was deputed to get the verification of said certificate from the Post Graduate Institute of Medical Sciences, Rohtak and as per record of Post Graduate Institute of Medical Sciences, Rohtak, his permanent physical disability certificate i.e. Sh. Rama Nand was found to the extent of 48 % (Forty Eight). Thus, he i.e. Sh. Rama Nand had tempered the permanent physical disability certificate issued by the Post Graduate Institute of Medical Sciences, Rohtak. Therefore, his order of extension in service from 58 to 60 years, was withdrawn vide order No. 2/57-2016 Human Resource Gazetted-II(2) dated 06.08.2018.

In this way, he i.e. Sh. Rama Nand failed to perform his duty with all sincerity and absolute integrity and acted with malafide intention by getting extension in service on the basis of fake disability certificate and committed an act unbecoming of a Government Officer and violated the provisions of rule 4 of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Rama Nand the then Headmaster, Government Senior Secondary School Kulan District Fatehabad (now retired from Government Senior Secondary School Damkora District Fatehabad)), rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 read with rule 12(2) (b) of the Haryana Civil Services (Pension) Rules, 2016.

**Statement of charges against Sh. Rama Nand the then Headmaster, Government Senior Secondary School Kulan, District Fatehabad (now retired from Government Senior Secondary School Damkora District Fatehabad)).**

While posted as Headmaster in Government Senior Secondary School Kulan Distt. Fatehabad from 19.02.2014 to 30.06.2017, Sh. Rama Nand committed certain acts of omission and commission for which he is charged as under:-

That he i.e. Sh. Rama Nand had submitted tempered permanent physically disability certificate to obtain the extension in service after attaining the age of superannuation i.e. 58 years to 60 years on the basis of said certificate he i.e. Sh. Rama Nand was allowed to continue in service till 30.11.2018 vide Memo No. 2/57-2016 Human Resource Gazetted-II (2) dated 05.04.2017. Further in continuation of the said order dated 05.04.2017, the period of delay in granting sanction for extension in service was also condoned from 01.12.2016 to 05.04.2017 vide Order No. 2/57-2016 Human Resource Gazetted-II (2) dated 12.12.2017. On examining the matter by Information Technology Cell permanent physical disability certificate submitted by him are updating Human Resource Management System data on 08.05.2018 was found to the extent of 55 %. Whereas, he i.e. Sh. Rama Nand had submitted the permanent physical disability certificate to the extent of 71 % for extension in service issued by Post Graduate Institute of Medical Sciences, Rohtak vide No. Neuro/ 16/ 617 dated 17.11.2016. Further, as per record of Post Graduate Institute of Medical Sciences, Rohtak, his permanent disability certificate was found to the extent of 48 % (Forty Eight). Thus, he i.e. Sh. Rama Nand had tempered the permanent disability certificate issued by the Post Graduate Institute of Medical Sciences, Rohtak. So, his order of extension in service were withdrawn vide order No. 2/57-2016 Human Resource Gazetted-II (2) dated 06.08.2018.

In this way, he i.e. Sh. Rama Nand failed to perform his duty with all sincerity and absolute integrity and act malafide intension by getting extension in service on fake disability certificate and committed an act unbecoming of a Government Officer and violated the provisions of rule 4 of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Rama Nand the then Headmaster, Government Senior Secondary School, Kulan, District Fatehabad (now retired from Government Senior Secondary School Damkora District Fatehabad) rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016 read with rule 12(2) (b) of the Haryana Civil Services (Pension) Rules, 2016.
