**ORDER**

NO. 13/3-2020 HRME-II (2)

DATED, PANCHKULA, THE 13.03.2020

Whereas the petitioner Sh. Gopal Singh filed CWP No 32932 of 2019 titled as Gopal Singh versus State of Haryana & others, wherein the petitioner has prayed for issuance of a writ order or direction especially in the nature of mandamus commanding the respondents to consider his case and decide the legal notice dated 15.09.2019 (Annexure P-IV) by passing a speaking order.

The case was came up for hearing on 15.11.2019 and the Hon'ble High Court disposed of the same with following order/direction:-

***"At the very outset, learned counsel for the petitioner states that the petitioner has served legal notice Annexure P-4 dated 15.09.2019 in respect of the grievances which are the subject matter of the writ petition but the claim as made in the legal notice has not been decided till date and the petitioner would be satisfied if at this stage, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim as made in the legal notice Annexure P-4 dated 15.09.2019 in accordance with law as expeditiously as possible.***

***In view of the innocuous nature of the prayer made by learned counsel for the petitioner, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim as made in the legal notice Annexure P-4 dated 15.09.2019 in accordance with the rules/regulations/instructions applicable as expeditiously as possible, preferably within a period of three months from the date of receipt of certified copy of this order alongwith a copy of the legal notice Annexure P-4 dated 15.09.2019."***

In compliance of the order dated 15.11.2019 passed by the Hon'ble High Court in CWP No 32932 of 2019, department has re-examined the case of the petitioner with the help of the committee constituted according to the guidelines dated 10.09.2019 of the Director Secondary Education in compliance to the order/direction dated 19.07.2019 passed in the related matter i.e. CWP No 16086 of 2019 titled as Pushpa Devi & others V/s State of Haryana & others. After re-examination of the matter, the constituted committee has found that petitioner was appointed on non-sanctioned and listed at Seniority No 197, in seniority list for the year of 2003 prepared by District Education Officer, Rewari and was regularized w.e.f. 03.09.2014, according to the District wise common seniority list made as per to regularization policy of 2003. But as per policy of 1998/1999 only those employees were regularized who were appointed and working against regular sanctioned posts and also fulfilled requisite conditions mentioned therein.



However, no junior to the petitioner has been regularized. It is also clarified here that example given by the petitioner in the present writ petition in which he has alleged that some of his juniors were regularized prior to him does not relate to District Rewari but relates to another District i.e. Fatehabad. Moreover, as per regularization policy dated 11.11.2003, **the District Level common seniority list of part time Class-IV employees shall act only as a reference point for sponsoring the names of the senior most persons for regularization against the regular sanctioned Class-IV posts in the field offices/schools of the Education Department. The cadre of the Class-IV employees will not become a district cadre simply because such a district level common seniority list has been prepared.**

Therefore, as per the above facts the benefits sought by the petitioner through legal notice dated 15.09.2019 are not tenable. The claim of the petitioner has been rightly rejected by the competent authority i.e. District Education Officer, Rewari vide its office order No E-3/2020/154 dated 21.01.2020.

Keeping in view of the aforementioned facts, the claim of the petitioner stands rejected.

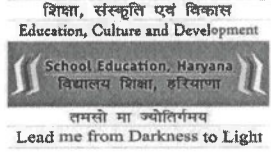

**Note :-**
