

Whereas Sh. Dharmender Indora joined services on post of PRT on 06.12.1995 and thereafter got promotion on post of TGT (S.S.), thereafter he applied through proper channel for post of Headmaster High School under School Education Department Haryana through direct appointment but while submitting application he showed himself appointed as TGT (S.S.) w.e.f. 06.12.1995 and remained successful to have appointment on post of Headmaster vide order No.4/69-2007 HRG (4) dated 17.01.2008. He joined on post of Headmaster at Govt. High School Chulkana (Panipat).

Later on, the actual facts of service earthed out and his appointment on post of Headmaster was cancelled vide order No.4/69-2007 HRG-II (1) dated 03.06.2009 and he joined services back on post of TGT (S.S.) vide this Directorate order No.15/81-2009 HRM-II (3) dated 31.10.2009. Having the knowledge of played fraud, he was put under suspension vide order dated 15.03.2013 and served a charge sheet. Thereafter, Sh. Balwan Singh, IAS (Retd.) was appointed Inquiry Officer to conduct a regular enquiry. He submitted its report stating therein that the charges leveled upon delinquent are stood proved. The enquiry report has duly been served upon delinquent. On finding the charges proved, the delinquent was served a show cause notice dated 22.10.2018 stating therein why your service be not be terminated/dismissed. He submitted its comment on 11.11.2018 rebutting all the allegations and pleaded for mercy.

Since the charges leveled upon him are duly proved and he played a fraud on the Department but on reconsidering his comments dated 11.11.2018 on show cause notice dated 22.10.2018, it has been found that a mutual mistake has got committed as while signing the experience certificate, the concerned Drawing & Disbursing Officer (DDO) concerned failed to consider the true fact of his service career and signed the experience certificate negligently, therefore, the delinquent deserves some leniency but before awarding punishment with leniency, he deserves to be served another show cause notice under principles of natural justice.

Hence, this show cause notice is hereby issued upon him why a punishment of stoppage of four increments with cumulative effects be not awarded upon you. He is hereby granted an opportunity of a period of 15 days to reply this show cause notice otherwise it would be presumed that he has nothing to say and further action would be decided accordingly.

Subject:-

Recognition Certificate for the School under sub-rule (4) of rule 12 of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of right of Children to Free and Compulsory Education Act, 2009.

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to Little Angel Public School, Ambala, Distt. Ambala class 1st to 5th with effect from 01.04.2019 run by Managing Committee Sai Dwarika Welfare Trust, Distt. Ambala.

The above sanction is subject to fulfilment of following conditions:-

- 1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
- 3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion:

Provided, that in case of pre primary classes also, this norm shall be followed.

- 4. For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of .. section 12. To receive such reimbursements school shall provide a separate bank account.
- 5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- 6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
- (ii) no child shall be subjected to physical punishment or mental harassment;
- (iii) no child is required to pass any board examination till the completion of elementary education.
- (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
- (v) inclusion of students with disabilities /special needs as per provision of the Act;
- (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5 years;
- (vii) the teacher performs its duties specified under section 24(1) of the Act; and
- (viii) the teachers shall not engage himself or herself for private teaching activities.
- 7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
- 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
- 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
 - (i) Area of school campus total built up area.
 - (ii) Area of play ground
 - (iii) Number of class rooms
 - (iv) Room for Head master-cum-Office-cum-Store room
 - (v) Separate toilet for boys and girls
 - (vi) Drinking Water Facility
 - (vii) Kitchen for cooking Mid Day Meal
 - (viii) Barrier free Access
 - (ix) Availability of Teaching Learning Material /Play Sports Equipments/Library.

- 10. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 11. The school buildings or other structures or the grounds are used only for the purposes education and skill development
- 12. The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
- 13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.
- 14. The recognition code Number allotted to your school is <u>4389/AMB/5th/BOSE/2019</u>. This may please be noted and quoted for any correspondence with this office
- 15. The school furnishes such reports and information as may be required by the Director of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfilment of the condition or recognition or the deficiencies in working of the school.
