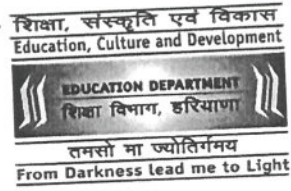

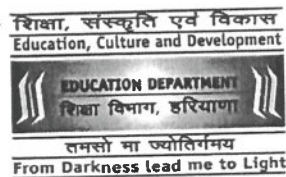

Ramesh Kumar (ID No.019065), TGT (Maths), GSSS Bhaini Amirpur (1273) now posted at GSSS Balsamand, District- Hisar was put under deemed suspension w.e.f. the date of arrest i.e. 16.11.2010 vide this Directorate order dated 21.03.2011 in a criminal case registered under FIR No.140 dated 14.11.2010 under Sections 420, 120B IPC at Police Station, Civil Line, Bathinda (Punjab). He was granted bail and thereafter he was reinstated in service vide this Directorate order dated 05.07.2018 without any prejudice to disciplinary action to be initiated against him. A charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987/2016 was served upon him vide this Directorate order dated 12.06.2018.

The Hon'ble Court of Kanwaljit Singh PCS, Judicial Magistrate 1st Class, Bathinda vide its judgment dated 10.04.2017 acquitted the delinquent stating therein that the prosecution has miserably failed to prove its case against the accused persons beyond shadow reasonable of doubt rather the case of the prosecution is no case in so far as the accused is concerned. So the accused persons are acquitted of the charges framed against them in this case due to lack of evidence. A CRM No.637 of 2017 was preferred against this judgment but the same was declared dismissed as withdrawn vide order dated 16.12.2019 by Hon'ble Court of Sh. Rakesh Gupta ASJ, Bathinda.

Now the TGT concerned has made a request submitting therein that the criminal case against him has got finality and he has been acquitted from charges leveled upon him, therefore, the charge sheet as well as suspension period may please be decided.

Considering his request and documents on file, I am being competent disciplinary authority is of considered view that after having acquittal from Hon'ble Judicial Courts, the disciplinary action would be a futile exercise, accordingly the charges under Rule-7 are hereby dropped and the suspension period is treated duty period for all intents and purposes under statutory provisions of Rule-7.3 (2) of Punjab CSR Volume-I Part-I read with Rule-89 of Haryana Civil Services (General) Rules, 2016.

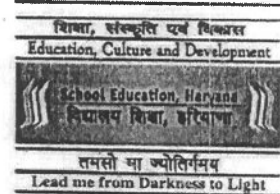



 - (v) Publication of list of eligible applicants by BEO/BEEO's by **27.03.2020**.
 - (vi) Date of conducting assessment test to be held on **12.04.2020**.
 - (vii) First draw of lots at State Level on **18.04.2020**.
 - (viii) Admission on the basis of 1st draw of lots from **20.04.2020 to 28.04.2020**.
 - (ix) 2nd draw of lots for remaining seats, if applicable will be announce later.
