

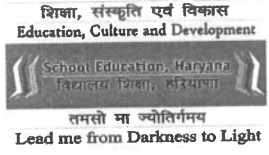

Whereas Sh. Anil Kumar has approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 18705/2019 titled as Anil Kumar V/s State of Haryana & Others praying therein inter-alia for issuance of a writ, order or direction especially in the nature of mandamus directing the respondents to grant the benefits of 3rd ACP or grant the promotion for the post of ESHM w.e.f.01.04.2014, even after sending so many representations dated 30.09.2017(Annexure P-3), dated 20.06.2016(Annexure P-4) dated 19.07.2018(Annexure P-5) and through proper channel application by department dated 27.03.2018(Annexure P-9).

The said petition came up for hearing before the Hon'ble High Court on 12.07.2019 and was disposed of with the following directions:-

"In the present writ petition, the claim of the petitioner is for the grant of 3rd ACP w.e.f. 01.04.2014.

Counsel for the petitioner argues that though, initially the petitioner had refused to accept promotion due to family circumstances, thereafter, he requested for the grant of promotion, which request was not accepted and therefore, he became entitled for the grant of ACP. Counsel argues that despite being entitled for the grant of ACP, said benefit was not given to him only due to the fact that he had refused the promotion on an earlier occasion. Counsel further argues that keeping in view the instructions issued by the Government of Haryana, even where an employee has refused the promotion at one given point of time, he does not lose his entitlement for the grant of said ACP in case subsequently he is not granted the promotion.

Counsel for the petitioner submits that for the relief which has been sought in the present writ petition, petitioner has served the respondents with a legal notice dated 19.07.2018 (Annexure P-5), which is still pending consideration with the respondents and the petitioner will be satisfied, at this stage, in case a time bound direction is issued to the respondents to decide the said legal notice.

In view of the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioner, the respondents are directed to decide the legal notice dated 19.07.2018 (Annexure P-5) by passing a speaking order within a period of three months from the date of receipt of a certified copy of this order.

Present writ petition stands disposed of."

- (b) **2nd ACP Level, the pay shall be re-fixed in the 1st ACP Level ;**
- (c) **1st ACP Level, the pay shall be re-fixed in the Functional pay structure, equal to the presumptive pay which shall have been admissible had he not been granted 3rd/2nd/1st ACP Level , as the case may be.**
- (2) **If such Government employee becomes ready to accept promotion, in such case the period of service between the date of foregoing promotion/reversion and date of application indicating readiness to accept the promotion, subject to minimum one year, shall be excluded from the regular satisfactory service for the purpose of grant of ACP Level. On assuming the charge of promotional post the pay shall be re-fixed equal to the pay drawn in ACP Pay structure immediately before foregoing promotion or fixation of pay of the promotional post under normal rules, whichever is higher;**

Provided that the request for seeking reversion or foregoing promotion once accepted by the competent authority shall not be withdrawn. Once a Government employee has foregone his promotion or sought reversion to a feeder post, such foregoing/ reversion shall remain in force for a minimum period of one year or up to the period he gives in writing to re-consider his name for promotion, whichever is later.

In the light of above mentioned rules, it is pertinent to mention here that the petitioner has himself forgo the promotion so he is not entitled to claim the 3rd ACP. According to the above mentioned rule, the pay scale of petitioner was supposed to be refixed on account of forgo of promotion .Hence, if refixation has not been yet then it would be done forthwith. The undersigned Department has done the promotion in 2014 and now the promotion are done on 24.08.2019. Hence, the representation of petitioner dated 08.12.2014 and subsequent reminder dated 01.06.2015, 26.06.2018 (Annexure p-4) and dated 19.07.2018 (Annexure P-5) can not be entertained. The case of the petitioner was not included in the promotion dated 24.08.2019 as the petitioner has been retired on 30.09.2018

Hence, the case of petitioner has been examined by undersigned being the competent authority and it has been found that the petitioner is not entitled for the above said claim because he has voluntarily forgo the promotion for the post of ESHM in the year 2013 and when promotion was again due then petitioner was already retired from the

In compliance of this order dated 12.07.2019, the case of petitioner has been examined and it has been found that the petitioner was initially appointed as Science Master in the year 1984 on temp/ad-hoc basis and his services were regularized w.e.f. 01.11.1986 vide letter dated 04.05.1987 in the Education Department of Haryana Government. That the petitioner has been granted 1st ACP w.e.f 01.11.1996 after completion 10 year of regular satisfactory service. Then on 01.11.2006 the petitioner has been granted 2nd ACP after completion 20 year of regular satisfactory service. Then on 19.01.2013 Education Department publish the promotion list in which the name of petitioner was mentioned. Later on the petitioner forgo the promotion by writing a letter that he doesn't want promotion for the post of ESHM.

That on date of promotion, the statutory financial provisions of the Haryana Civil Services (Assured Career Progression) Rules, 2008 were in operation. As per Rule- 14, it has been specifically defined that in case the government servant chooses to forego any functional promotion on any ground whatsoever, while drawing his pay in any ACP pay structure with reference to him, he shall cease to be entitled to draw his pay in the ACP pay structure last granted to him and shall draw his pay in the pay band and grade pay he was drawing before the grant of the last ACP grade pay. The Rule -14 is reproduced herein for kind consideration:

“14. Ceasing of entitlement of ACP pay structure:—

In case the government servant chooses to forego any functional promotion on any ground whatsoever, while drawing his pay in any ACP pay structure with reference to him, he shall cease to be entitled to draw his pay in the ACP pay structure last granted to him and shall draw his pay in the pay band and grade pay he was drawing before the grant of the last ACP grade pay from the date of such forgoing of promotion.”

That it is also worthwhile to submit that the Finance Department Haryana vides its Notification No. 1/20/2016(ACP)-5PR(FD) dated 28-10-2016 notified the **Haryana Civil Services (Assured Career Progression) Rules, 2016**. The Rule-14 of these ACP Rules is very crucial for proper adjudication of this writ petition. The Rule-14 provides as under:


“14. Ceasing of entitlement of ACP Level:—

- (1) A Government employee who foregoes his promotion in the line of hierarchy or seeks reversion on his own accord to feeder post on any ground whatsoever, while drawing pay in—***
- (a) 3rd ACP Level, the pay shall be re-fixed in 2nd ACP Level ;***
