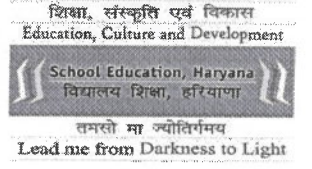

19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments it any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

Whereas, Smt. Suman Nain, Joint Director (Retd.), SCERT Gurugram was placed under suspension vide order no. 10/3-2008 Admn. (2) dated 03.01.2008. Thereafter, she was charge-sheeted under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 read with Rule 2.2(b) of CSR Vol. II vide Govt. Order No. 17/22-2008 HRG-I(2)/1808 dated 26.03.2009. The following charges were leveled against her:

That Smt. Suman Nain the then DEEO, Jhajjar was given a fund of Rs. 17,50,000/- for purchase of cooking devices including gas stove, cylinders and other accessories for Mid Day Meal programme vide order no. 1/96-06 MDM(1) dated 08.10.2007 by the Director Elementary Education, Haryana, Chandigarh. She purchased a set of one gas stove, lighter pipe, regulator, burner at exorbitant rates which was of poor quality and even not ISI marked. She also purchased each set @ Rs. 3170/- +4% vat charges from Ambala Co-operative Consumer Store, Chandigarh, which was not an approved source. Further, in most of other districts the price of the said set was between Rs. 425/- to Rs. 850/-. Moreover as per quotation dated 05.01.2008 procured by a committee of the offices of the O/o District Elementary Education Officer Gurgaon, the price of the said equipment set was Rs. 676/-. In this way she violated the instructions of the Government dated 08.10.2007 by purchasing above said items more than market prices which caused loss a of Rs. 8,72,900/- to the State exchequer and also purchased these items from unapproved source.

Whereas, Sh. V.P. Batra, IAS (Retd) was appointed as Inquiry Officer vide order no. 17/22-2008 HRG-I(2) dated 17.06.2010 who submitted his report on 28.06.2011. In the said inquiry report the charges were partly proved. A show cause notice was issued on 30.09.2011/03.11.2011 alongwith Dissenting Note. Ultimately, Smt. Suman Nain was ordered to compulsorily retired vide order no. 17/22-2008 HRG-I(2) dated 16.03.2012, and a recovery of Rs. 4,28,190/- was also imposed upon her from retiral benefits.

The said order was challenged by the petitioner by way of filing CWP No. 6315 of 2012 in the Hon'ble High Court of Punjab & Haryana, Chandigarh. The Hon'ble Court set aside the punishment order on 02.08.2013. The department challenged the said in LPA and the same was dismissed on 26.04.2014.


Whereas, Sh. Zile Singh, Smt. Sumedha Taneja and Smt. Sarita Chaudhary were also charge sheeted in similar allegations and were also punished by the competent authority. The punishment orders were challenged by them before the Hon'ble High Court in separate writs. The said punishment orders were set aside in terms of Suman Nain's case i.e. CWP No. 6315 of 2012. Thereafter, Sh. Zile Singh, Smt. Sumedha Taneja and Smt. Sarita Chaudhary were exonerated. However, subsequently Smt. Suman Nain was again awarded the punishment of stoppage of one annual increment with cumulative effect vide order no. 6/26-2012 HRG-I(2) dated 08.01.2016/20.01.2016. The said order was also set aside by the Hon'ble Court order vide order dated 29.01.2019, in CWP No. 5482 of 2016. Operative part of said order is reproduced as under:-

"In view of the above, impugned order dated 08/20.01.2016 is held to be contrary to the directions given by this Court in CWP No. 6315 of 2012 as well as on the law laid down by this Court mentioned above and, therefore, the same is set-aside. Though the impugned order has been set aside, the respondents will be at liberty to pass appropriate order afresh after complying with the directions given by this Court in CWP No. 6315 of 2012, decided on 02.08.2013.

Keeping in view the above said facts and circumstances, it is observed that since the orders of Sh. Zile Singh, Smt. Sumedha Taneja and Smt. Sarita Chaudhary have already been set aside in terms of the orders passed by Hon'ble High Court in petitioner's case and they were exonerated from all the charges. Hence, Smt. Suman Nain is also entitled to be exonerated on similar grounds in the interest of justice.

Therefore, the Governor of Haryana is pleased to withdraw the above said punishment inflicted upon the petitioner vide order no. 6/26-2012 HRG-I(2) dated 08.01.2016/20.01.2016.

It is ordered accordingly.



Whereas, Shri Ram Kumar Phalswal (Retd.) the then District Education Officer, Rewari was charge-sheeted under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/184-2019 HRG-I(2)/11 dated 25.10.2019 with the allegations that while posted as District Education Officer, Rewari, he had submitted false affidavit before Hon'ble High Court in COCP No. 2122 of 2017 (Jagat Singh Yadav and others Vs P.K. Das and others) to the effect that the order dated 20.02.2017 passed in CWP No. 9347 of 2016- (Jagat Singh Yadav and others Vs State of Haryana) has been fully complied with and all benefits had been granted to all the petitioners. Further, it was alleged that he also caused the delay of two years to comply with the order dated 20.02.2017.

The delinquent submitted his reply on 07.11.2019 to the chargesheet with prayer that the chargesheet may be dropped against him in the interest of justice as he was neither posted as DEO Rewari during the period 04.05.2015 to 31.08.2018 nor filed any false affidavit before the Hon'ble High Court in the above said contempt case. He further, contend that there were no delay in releasing the benefit to the petitioners on his part as he disposed off the case file within stipulated time whenever the matter came to his knowledge.

Thereafter, the delinquent was given personal hearing and heard in person on 13.02.2020 in the presence of officials from department wherein, he reiterated the same contentions submitted by him in his reply with the documents supporting his version. During the course of hearing it is observed that the delinquent has performed his duty with due diligence and no delay was found on his part in the above said matter. Further, on examination of the documents submitted by the delinquent, and office record, it is found that Sh. Ram Kumar Phalswal (Retd.) never hold the post of DEO, Rewari during the above said period.

Keeping in view the above said facts and circumstances, submissions made by delinquent and documents relied upon, the Governor of Haryana is pleased to drop the above said chargesheet against Sh. Ram Kumar Phalswal who is already retired on 31.10.2019.

Whereas, the petitioner namely Suresh Pandey approached the Hon'ble High Court of Punjab and Haryana Chandigarh by way of filing CWP No. 32106 of 2019 titled as Suresh Pandey v. State of Haryana and others praying therein for issuance of writ of mandamus directing the respondents to consider the service of the petitioner as qualifying service in Mewat cadre w.e.f 13.01.2009 to till date. The writ petition was disposed of by the Hon'ble High Court vide its order dated 05.11.2019 with the following directions to the respondents. The operative part of the order is as under:-

"Petitioner is seeking seeking indulgence of this Court for issuance of a writ in the nature of mandamus directing the respondents to consider the service of petitioner as qualifying service in Mewat Cadre w.e.f. 13.01.2009 to till date as he is belonging to Mewat Cadre. In this regard, had submitted representation dated 09.09.2019 (Annexure P-5), but there is no adherence thereto.

Learned counsel for petitioner submits that he will be satisfied if a direction is issued to respondent No.2- Director Secondary Education Haryana, Sector 5, Panchkula, to consider the representation dated 09.09.2019 (Annexure P-5), within a stipulated period.

Without going into the merits and demerits of the claim of the petitioner, I deem it appropriate to direct respondent No.2 to consider the representation dated 09.09.2019 (Annexure P-5), within a period of two months from the date of receipt of certified copy of this order and shall pass a speaking order thereon after affording opportunity of hearing to petitioner, failing which, respondent No.2 shall be liable to pay costs of `25,000/- to petitioner.

This condition of imposing costs is only to prevent petitioner to run from pillar to post and avail remedy of



contempt in case of noncompliance of directions issued by this Court.

The writ petition stands disposed of with the above direction."

Whereas, the representation dated 09.09.2019 (Annexure P-5) by the petitioner was considered and the petitioner was accorded an opportunity of personal hearing on 25.02.2020. The claim of the petitioner pertaining to change of cadre to Mewat Cadre from Rest of Haryana Cadre was examined. Separate Service rules namely Mewat District School Education Group B Service Rules, 2012 were introduced vide notification dated 11.04.2012. PGTs appointed in Mewat after notification of 2012 rules, were allocated Mewat Cadre relevant portion of the same is reproduced as under:

"Members of the existing state cadre under the Haryana State Education(School & inspection) Cadre (Group-B) Service and the Haryana State Education Lecturer School Cadre (Group C) Service would automatically become member of this District Cadre Service after the notification of these rules:

Provided that the existing members of the Haryana State Education (School & Inspection) Cadre (Group B) Service and the Haryana State Education Lecturer School Cadre (Group C) Service who are the members of the State Service shall have a right to exercise the option of district within three months from the notification of these rules for joining the Mewat District School Education(Group B) Service:

Provided further that while exercising the option, principle of seniority will be deciding factor keeping in view the number of posts in the district in the relevant cadre.

Provided further that the option once exercised shall be final."

Whereas, no option was given by the petitioner at the time of the notification of the Mewat Rules of 2012. The Directorate of Secondary Education Haryana vide Memo No. KW 13/111-2017 PGT-II(3) dated 07.11.2017 again allowed one time opportunity to all the PGTs who were selected before the year 2012, to exercise their option for adopting Mewat Cadre under the provision of Rule 3 (ii) of Mewat District School Education

Group B Service Rules, 2012. This letter dated 07.11.2017 was circulated across the offices of all District Education Officers in the State of Haryana. But no option was received from the petitioner at that time.

Whereas the petitioner has contended vide representation dated 09.09.2019 that he has been allocated Government Senior Secondary School Nimoth, District Rewari in General Transfer Drive, 2016 in 'Anywhere in the State' category, whereas, the petitioner was allocated Government Senior Secondary School Nimoth, District Rewari on his own choice during the General Transfer Drive, 2016. (Online option at Sr. No. 20). Copy of the allocation detail (MIS) is attached herewith.

It is pertinent to mention here that when the petitioner was working as PGT History at Government Senior Secondary School Nimoth, District Rewari from 09.08.2016 to 23.08.2019, no case for exercising the option for adopting Mewat Cadre was received from district Rewari or from the petitioner himself. The District Education Officer, Rewari also issued a certificate vide Memo No. E-2/2017/3071 dated 28.11.2017 stating therein that the number of candidates willing to exercise the option for adopting Mewat Cadre in furtherance of Memo No. KW 13/111-2017 PGT-II(3) dated 07.11.2017 is nil implying that no PGT from the district Rewari is willing to exercise the option for adopting Mewat Cadre.

Petitioner was afforded an opportunity of being heard on 25.02.2020. At the time of personal hearing petitioner submitted another application dated 25.02.2020 for considering his case for adopting Mewat Cadre. He claimed in his application that he was never been communicated to submit his option for adopting Mewat Cadre and in the lack of official communication his juniors got promoted from PGT to Principal in Mewat.


On the perusal of the record, it is found that petitioner joined as PGT History at GSSS Hasanpur (Mewat) on 13.01.2009. He remain there till 08.08.2016 and still continuing in Mewat district w.e.f.



25.08.2019. He remain out of Mewat from a short period i.e. 09.08.2016 to 24.08.2019 on his own request.

Keeping in view the above, I find the claim of the petitioner as genuine and thus, the representation dated 09.09.2019 & 25.02.2020 is liable to be accepted. The case of petitioner for promotion and seniority be put up to the competent authority accordingly.
