Sir/ Madam,

I am directed to refer to the subject noted above and to say that Armed Forces Flag Day will be observed on 7th December, 2020 being Monday. Accordingly, the ceremonial pinning of flags will be done on 7th December, 2020 throughout the State of Haryana to commemorate the bravery and supreme sacrifice of our soldiers in protecting the Honour of our motherland. The Flag Day is an occasion to express our gratitude to Armed Forces Personnel who are engaged in the onerous task of national defence.

Token and Car Flags will be distributed to various Government Departments and General Public in return for voluntary donations to the Flag Day Fund on the occasion. No monetary amount for the individual Token Flag and Car Sticker is proposed. However, in view of the increasing financial requirement to run welfare schemes for defence personnel, efforts should be made to mobilize maximum contributions to the fund.

Accordingly, you are requested to extend your full co-operation to the collection of contributions to the fund and ensure that a proper account of the Token Flag and Car Stickers is maintained. Details of the collection may be sent by 31st Jan, 2021 through the Welfare Officer, Sainik & Ardh Sainik Welfare offices concerned.

As you are aware that contributions to Armed Forces Flag Day are exempted from payment of income tax under section 80(G)(5)(vi) and u/s10(23C)(iv) of Income Tax Act 1961 and as per Government of India letter No. 69(12)-1/54, dated 6-3-1954. A Trophy is awarded to the Welfare Officer/ Deputy Commissioner raising maximum contribution to the Flag Day Fund. The Trophy is presented by His Excellency, the Governor of Haryana during the annual meeting of the Haryana Sainik and Ardh Sainik Welfare Department.
