In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.

With aforesaid direction, the writ petition stands disposed of.”

In compliance of this order dated 22-10-2019, the case of petitioner has been examined and it has been found that the petitioner had opted more than 125 schools for his transfer in transfer drive on dated 06-09-2019. 

The petitioner participated in the online system of transfer and got his posting at opted school, accordingly he is not entitled to impugn the adjustment order on rationalization of post.

Thereafter, the petitioner had filed the said petition claiming the issuance of direction to the answering respondent to adjust the petitioner in the previous school in District Sonipat. It is pertinent to mention that if the petitioner is adjusted in school of District Sonipat than purpose and spirit of the transfer policy will vitiate and that of RTE Act, 2009. Rather, it is the competent authority who has to decide after having regard to other circumstances and provisions of transfer policy.


