Whereas, the petitioner, Sh. Deepak Kumar, Science Master in GGSSS Khanda, tehsil Kharkhoda Distt. Sonapat by way of filing a Civil Writ Petition (No. 10142 of 2019) before Hon'ble Punjab & Haryana High Court at Chandigarh has sought directions to the respondents to grant continuity in service without monetary benefits on his reappointment in service by counting the intervening period for the purpose of length of service with notional consequential benefits. The writ petition came for hearing before Hon'ble Bench on 12.04.2019 and Hon'ble court dispose of the said writ without expressing any opinion on the merits of the case, with a direction to the respondents to look into the legal notice dated 09.03.2019 (Annexure P-19) and decide the same in accordance with law within a period of six months from the date of receipt of certified copy of this order.

After having the certified copy of order dated 12.04.2019, the contents mentioned in legal notice dated 09.03.2019 have been examined minutely. After due consideration of the facts, it has been observed that the petitioner was initially engaged on contractual basis for a fixed period of 89 days. He joined this contractual service on 11.01.1997 and his services were dispensed with on 14.04.1997 on completion of 89 days. In this appointment, it has specifically been defined that the appointment is purely contractual and the services can be dispensed with either on joining of a regular incumbent or completion of contractual period of 89 days, which may be earlier. In the present case the engagement was done by the District Education Officer concerned whereas the appointing authority of a "master" is Joint Director at Directorate Level at Chandigarh, therefore, this engagement cannot be said to be a substantive and legal one. Moreover, the services came to an end on expiry of contractual period. Moreover, the petitioner himself has admitted this fact, that he has never been reinstated in service on contractual basis.

It has also been observed that in November, 2005 the Govt. of Haryana School Education Department notified a new teacher engagement policy, popularly, known as Guest Faculty Teachers policy on contractual basis @ per period or per day so that the study of the students in Govt. Schools may not suffer due to paucity of teachers. Under the present policy, the Drawing and Disbursing Officer (DDO) was the appointing authority. At this time, no regular procedure of appointment was pursued. Hence, this appointment can also not be considered as a substantive and legal one. The petitioner approach the court filing CWP no 12928 of 2004 petitioner approached this Court by filing CWP No.12928 of 2004 seeking reinstatement with continuity of service. The said petition was disposed of vide order dated 20.10.2015 (Annexure P-5) by giving direction to the respondents to take a final decision within a period of three months. In the

meantime petitioner was recruited as Guest Teacher on 05.07.2007. Since then, he is serving as Science Master.

Since, both the engagement/appointment (Supra) are temporary and contractual in nature, therefore, substantive service rules cannot be made applicable in case of petitioner. After due consideration, it has been noticed that the claim of the petitioner is not covered under Rule 4.23 of Punjab Civil Services Vol. II which says as under:-

"Rule- 4.23-Condonation of Interruptions and Deficiencies:

Interruption in service (either between two spells of permanent, or temporary service or between a spell of temporary service and permanent service or vice versa in the case of an officer retiring on or after the 5th January, 1961, may be condoned, subject to the following conditions, namely:-


- (1) The interruption should have been caused by reasons beyond the control of Government employee concerned.***
- (2) Service preceding the interruption should not be less than five years' duration. In cases where there are two or more interruptions, the total service, pensionary benefits in respect of which shall be lost if the interruptions are not condoned should not be less than five years.***
- (3) The interruption should not be of more than one year's duration. In cases where there are two or more interruptions, the total period of all interruptions to be condoned should not exceed one year."***

A consideration of this Rule 4.23 would reveal itself that the claim of the petitioner is not covered under this statutory provision. It is also relevant to state that the terms & conditions of contractual services of the teachers were quashed by Hon'ble Division Bench of Punjab & Haryana High Court in ***Polu Ram & others Vs. State of Haryana & others, cited as 1998 (4) RSJ 152***, accordingly, the contractual teachers were continued in service and paid full salary of the post. Against Polu Ram case (Supra), State of Haryana filed SLP. The said SLP was disposed off in terms of State of Karnataka Vs. Uma Devi & others. In others words, the Appeal of State of Haryana was allowed and decision of Punjab & Haryana High Court was set aside. The petitioner has neither been paid full salary at the time of contractual service of 89 days nor did pay during guest faculty teacher. Hence, the present case of the petitioner cannot be said identical to teachers defined in order dated 11.07.2005 (P-9) and 11.07.2017 (P-16).

Considering the above-said facts and circumstances, it has been observed that the petitioner was purely engaged on fixed salary as a contractual teacher on 89 days as well as guest faculty teacher. His case has not been found identical to teachers defined in Annexure P-9 and P-16 as petitioner was freshly recruited as guest teacher instead of reinstated. Moreover, the claim of the petitioner is not found covered under

Rule 4.23 Pb. CSR Vol. II. Perusing the factual position, it is concluded that the contents of legal notice dated 09.03.2019 are conjectures and surmises of the petitioner therefore, the legal notice has been found devoid of merits. Consequently, the relief claim therein deserves to be declined/rejected.

Order accordingly.



Whereas Saroj Rani approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 29127/2019 – Saroj Rani V/s State of Haryana & Another praying therein for issuance of a writ in the nature of certiorari/mandamus for quashing the impugned transfer order dated on 06-09-2019 (P-6) which is issued in the violation of Teacher Transfer Policy, 2016 as amended on 05-06-2017 (Annexure P-1) and without granting 10 points to the petitioner as provided under Sr. No. 5 of clause 7 (iii) (b) of Teacher Transfer Policy, 2016 despite the fact that the petitioner is suffering from Chronic Heart Disease and Chronic Artery Disease (Annexure P-2) dated 21-07-2017 and (Annexure P-3) dated 20-09-2019 and the same is recorded in the profile of the petitioner on MIS portal of the department. Further prayed that operation of impugned transfer order dated on 06-09-2019 (P-6) may kindly be stated during the pendency of the present writ petition, in the interest of justice.

The said petition came up for hearing before the Hon'ble High Court on 04.10.2019 and was disposed off with the following directions:-

“Learned counsel for the petitioner seeks leave of Court for withdrawal of present writ petition with liberty to make representation for awarding marks of merit on the basis of transfer as per transfer policy.

Ordered accordingly. In case such representation is made, the same shall be decided in accordance with law”.

In the compliance of this order dated 04-10-2019 and representation received dated 18.11.2019 the matter has been examined in view of the Court directions and Transfer Policy, 2016. It is found that the petitioner is suffering from the Chronic Disease (Diabetes Mellitus and Chronic Artery Disease). In this regard, petitioner submitted the certificate issued by the Civil Surgeon, Bhiwani. On the basis of this, Petitioner is claiming Ten Points in Teacher Transfer Drive. It is also clear here that the petitioner herself filled her data on the MIS Portal and got it approved by the concerned DDO. However, petitioner did not fill the data about her chronic disease.

The transfer policy amended in year of 2017 according to which, the decision of allotment to a vacancy shall be based on the total composite score of points earned by a teacher, out of 80 points. Age shall be the prime factor for deciding the claim of the teachers against a vacancy since it shall have weightage of 60 points, out of total 80 points. According to Rule 9 of the amended teacher transfer policy 2016 as amended on 01.06.2017. The teachers suffering from

- a) 100% vision loss; or
- b) 100% loco motor disability for any reason; or
- c) currently suffering from cancer; or
- d) having undergone bye-pass heart surgery; or
- e) kidney transplant; or
- f) currently undergoing dialysis;

shall be assigned 80 points (60 for age factor and 20 for special points factor) if they are willing to participate in a transfer drive. Otherwise, they shall not be transferred, if they are not willing to participate in a transfer drive.

It is relevant to state that the instructions issued by Health Department Haryana through letters dated 11.08.1992 and 08.06.2005 are related to declaration of a disease whether the same is chronic or not. All chronic diseases have not been included in the list left out diseases do not affect the daily movement of a teacher.

However, as per Clause-9 (1) of Haryana School Teachers Transfer Policy-2016, every teacher will be responsible for the accuracy and regular updation of data in the MIS in respect of his/ her credentials. In case he/she notices any discrepancy, he/she will get it rectified by adopting due procedure after producing the relevant evidences before the competent authority. He/she shall be responsible for updation of profile as and when any status is changed.


It is also relevant to state that the petitioner voluntarily participated in the transfer drive and opted more than 9 schools for her transfer. She remained successful to have a school of her choice i.e. GSSS Sankhol (3126) Bahadugarh, Jhajjar at preference No. 9 in zone 1. therefore, she may not be permitted to back out from her options now.

Thereafter, the petitioner had filed the said petition claiming the issuance of direction to the answering respondent to adjust/transfer in any of the school nearest Bhiwani city in District Bhiwani against the clear vacancy.

Considering the directions as well as relevant provisions of teachers transfer policy-2016/2017, the department is of the considered view that no injustice, illegality and biasness has been committed against the petitioner, therefore, she is not entitled to any relief only a single ground that the petitioner is suffering with chronic diseases. No merit has been made out which entitles the petitioner to be reconsidered for transfer/adjustment after having a school from the opted list of schools.

Hence, the case of petitioner has been examined by the competent authority and it has been found that the petitioner is not entitled for the above said claim as her Chronic Disease is not covered within the ambit of chronic disease list. Moreover, petitioner did not update her MIS Portal qua this. Therefore, in view of the above background and factual position of the case, the claim of the petitioner is declined/rejected.

Order accordingly.

Whereas Harish Chand approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 29324/2019 – Harish Chand V/s State of Haryana & Others praying therein inter-alia for issuance of a writ in the nature of certiorari for quashing of transfer order dated 06.09.2019 (Annexure P-3) issued by the respondent no. 2 being illegal and not sustainable in the eyes of law.

The said petition came up for hearing on dated 06.09.2019 before the Hon'ble High Court on 29.10.2019 and was disposed off with the following directions:-

“Prayer in present writ petition is for issuance of a writ in the nature of certiorari for quashing of transfer order dated 06.09.2019 (Annexure P-3) passed by respondent no.2.

Notice of motion.

On asking of Court, Mr. Kiran Pal Singh, Assistant Advocate General, Haryana, who is present in Court, accepts notice on behalf of respondents/State.

Mr.Hakam Singh, learned counsel appearing on behalf of petitioner submits that petitioner, at this stage, would be satisfied if a direction is issued to respondent No.4 to consider and decide representation dated 09.09.2019, (Annexure P-4), within some specified time.

In view of statement made by learned counsel for the petitioner and without going into merit of case or commenting thereon, present writ petition is disposed of with a direction to respondent No.4 to decide the representation dated 09.09.2019, (Annexure P-4) by passing a well reasoned and speaking order within a period of two months from the date of receipt of certified copy of this order.

In case, representation is not decided within aforementioned specified time, there shall be costs of Rs.25,000/- to be paid by the concerned officer to the petitioner”.

In compliance of direction of court it is pertinent to mention here that Respondent No.4 i.e. Block Education Officer is not competent to pass the speaking order, hence, on behalf of it speaking order is passed by Respondent No.2 i.e. Director Elementary Education being competent authority to pass speaking order in transfer matters.

In compliance of this order dated 29-10-2019, the case of petitioner has been examined and it has been found that the petitioner had opted schools for his transfer in transfer drive on dated 06-09-2019 and the petitioner had opted for schools in District Sirsa, and for no other District. The petitioner had participated in transfer drive on 06-09-2019. The petitioner had opted schools in zone 5 at his preferences. The petitioner had transferred from Government Senior Secondary School Darba Kalan, Sirsa (2904) [Zone3] to Government Girls Middle School Raghuana, (4701) Baragudha Block, District Sirsa [Zone 5] which was opted by petitioner at his preferences. However, after the transfer in the said school, the petitioner came to know that from the last 2 years, no student has been enrolled in the said school and school strength is zero. Thereafter, the petitioner had approached to the respondent No. 4 i.e. Block Education Officer Baragudha Block, District Sirsa vide letter dated 09.09.2019 regarding the grievance of the petitioner and with request to sought out the problem and adjust the petitioner in any other school as soon as possible. It is also pertinent to mention here that the petitioner had uploaded his complaint on Sugam Sampark Portal vide ticket No. 060839-C2D17 dated 07.09.2019. After due consideration the request/complaint of the petitioner, the petitioner had adjusted at Government Middle Senior Secondary School District Sirsa vide letter dated 16.09.2019.

At this juncture, it is pertinent to mention that the paramount object of transfer policy was to provide adequate teachers at every school for the welfare of children. For this purpose, the whole transfer system was made.


Besides this fact, it has also been relevant to state that the vacancy of a teacher depends on workload of periods of classes. In single section school there is not sufficient workload. Having such information, the Department rationalized the posts with an objective that the maximum number of students getting education in Govt. Schools may have teacher to teach. The petitioner has also not negated this fact.

However, it is also relevant to consider that the petitioner has been rendering service on a State Cadre Post and the appointing authority has a prerogative to appoint him elsewhere in Haryana. Considering all the facts submitted above, it has

been found that the grievance of the petitioner is not a justified one. Moreover, the appointing authority has a prerogative to appoint a State Cadre Employee elsewhere in Haryana under Rule 12 (1) of statutory provisions of Haryana School Education (Group-C) State Cadre Service Rules, 2012.

The petitioner in his complaint himself sought to adjust him in any other school as early as possible. Accordingly, the competent authority after having regard to facts and circumstances of the case adjusted him in Government Middle Senior Secondary School, Sirsa. Therefore, in view of the above background and factual position of the case, the claim of the petitioner is declined/rejected.

Order accordingly.
