



Whereas Smt. Sarita and another have filed the CWP No. 30689 of 2019 titled as Sarita and another versus State of Haryana and Others before the Hon'ble High Court with the prayer for issuance of a writ of mandamus or any other appropriate writ directing respondents to show cause as to why their complaints on the Sugam Sampark Portal have not been addressed till date for the last three years despite representations Annexure P-3 and Annexure P-7 and for further issuance of direction directing the respondents to adjust the petitioners in their home Block Sonapat and Block Rai in the process of internal adjustment/deputation as per workload since the petitioners were not given an opportunity in the open transfer drive as in both the Blocks, more than 30 to 40 posts are laying vacant The above said CWP was fixed for hearing on 23.10.2019 before the Hon'ble high Court wherein following order was passed:-

“Prayer in the application is for directing the respondents to show cause as to why the complaints of the petitioners on the Sugam Sampark Portal have not been addressed till date for the last three years despite representation (Annexure P-7). Learned counsel contends that the petitioners, at this stage, would be satisfied if a direction is issued to respondent No.2 to consider and decide the representations (Annexures P-3 and P-7), within some specified time.

In view of the statement made by the counsel for the petitioners and without going into the merit of the case or commenting thereon, the present writ petition is disposed of with directions to respondent No. 2 to decide the representations (Annexure P-3 and P-7) within a period of two months from the date of receipt of certified copy of this order. In case the claim of the petitioners is not to be accepted, then a well reasoned and speaking order be passed and conveyed to the petitioners forthwith. It is made clear that in case the representations are not decided within two months, there shall be costs of 25,000/- to be paid to the petitioners.”

In view of the order of the Hon'ble High Court dated 23.10.2019 and representation received from petitioners, the grievance of the petitioners has been considered meticulously by the department. Further, an opportunity of personal hearing has also been granted to the petitioners on 16.12.2019 wherein they were heard at length.

The brief history of the instant matter is that both the petitioners are JBT Teachers and belong to District Sonapat. It is a matter of record that JBT is a District

Whereas, Sh. Jagdish Parsad and others have filed Civil Writ Petition No. 10868 of 2019 titled as Jagdish Parsad and others vs. State of Haryana in the Hon'ble High Court of Punjab and Haryana at Chandigarh with the following prayer:-

“For issuance of a writ in the nature of certiorari quashing Rule 10 of “The Haryana Civil Services (Revised Pay) Rules, 30-12-2008 (Annexure P-2) to the extent of denial of benefit of annual increment to a Government employee who is not in service on 1st of July which is beyond his control due to retirement on superannuation, despite the fact that he has served more than six months and more, after his last annual increment which is required by an employee to earn annual increment as per the said “The Haryana Civil Services (Revised Pay) Rules, 2008”, in their retiring year.”

The Hon'ble High Court disposed of the present Writ Petition vide order dated 30.04.2019. The operative part of said order is reproduced as under:-

“Learned counsel for the petitioners as well as Mr. Sharad Aggarwal, learned Assistant Advocate General, Haryana are not at issue to the matter for adjudication in this writ petition stands squarely covered by a judgment of this Court dated 22.04.2019 rendered in Civil Writ Petition No. 29465 of 2018 and other connected writ petitions (Rajinder Singh Kuhar and others versus State of Haryana and others).

Accordingly, this petition also stands disposed of in terms of the judgment and order dated 22.04.2019 rendered in Civil Writ Petition No. 29465 of 2018 and other connected writ petitions.”

The case of the petitioners was examined as per the order dated 22.04.2019 rendered in CWP No. 29465 of 2018 titled as Rajinder Singh Kuhar and others versus State of Haryana and others by the department and also as per the Haryana Civil Services (Assured Career Progression) Rules, 2016 and it has been described under Rule 19 that “There shall be two dates for grant of increment namely, 1st January and 1st July of every year, instead of existing date of 1st July. Proviso of Rule 19 of said

ACP Rule of 2016 further says that an employee shall be entitled to only one increment either on 1st January or 1st July depending on the date of grant of ACP up-gradation. It has also been further stated that a Government employee who does not complete six months qualifying service before the date of normal increment due on 1st July or 1st January, as the case may be, his date of next increment shall be changed to 1st January or 1st July and shall be granted subject to admissibility.

After bare perusal of said rule it is clear that increment shall be due on completion one year full service rendered by a Government employee. But even after framing of said rule, there is a controversy that an employee who has been retired in the month of June after completing full one year service but the next increment due on next date in the month of July on which date he was not in service.

As the anomaly arose in above mentioned service rule there were number of writ petitions filed before different High Courts through different Government employees in which the Hon'ble Madras High Court has rendered its decision on issue of said anomaly in CWP No. 15732 of 2017 titled as P.Ayyamperumal versus Union of India which was decided on 15.09.2017. The operative part of the judgment is reproduced herein below :-

“The petitioner herein had completed one full year service as on 30.06.2013, but the increment fell due on 01.07.2013, on which date he was not in service. In view of the above judgment of this Court, naturally he has to be treated as having completed one full year of service though the date of increment falls on the next day of his retirement. Applying the said judgment of the present case, the writ petition is allowed and the impugned order passé by the first respondent-Tribunal dated 21.03.2017 is quashed. The petitioner shall be given one notional increment for the period from 01.07.2012 to 30.06.2013, as he has completed one full year of service, though his increment fell on 01.07.2013, for the purpose of pensionary benefits and for any other purpose. No Costs.”

Thereafter, Hon'ble Supreme Court of India has upheld the above mentioned judgment of Hon'ble Madras High Court in SLP No. 22283 of 2018 titled as Union of India versus P.Ayyamperumal vide judgment dated 23.07.2018. In this case Central

Government was also party. Therefore, the Finance Department, Haryana has requested to Central Government vide letter dated 28.03.2019 to apprise the latest position in respect to the judgment passed by the Hon'ble Supreme Court so that appropriate policy decision may be taken accordingly. The Finance Department, Haryana has further issued instruction dated 03.04.2019 providing guidelines for bringing this factual position to the aggrieved petitioners while disposing of their claims. Moreover, the Central Government has appropriate remedy to file review application and curative petition before Hon'ble Apex Court.

In compliance of the order of the Hon'ble High Court, department has examined the legal notice dated 16.01.2019 (Annexure P-5) and it has been found that in related matter the Finance Department, Government of Haryana sought the information vide letter 6/183/2018-4PR(FD), dated 13.05.2019 from the Secretary to the Government of India, Ministry of Personnel, Public Grievance and pensioners Department of Pension, New Delhi and in response to the letter no. 6/183/2018-4PR(FD), Ministry of Finance, Department of Expenditure, Government of India has informed the State Government vide letter No. 08-09/2019-E-III A, dated 25.06.2019 that issue regarding grant of one notional increment is under examination in Department of Personnel and training(DOPT). It has already been communicated vide letter 6/183/2019-4PR (FD) dated 03.04.2019 and 6/109/2019-3PR(FD)30790 dated 31.10.2019, that in the context of above mentioned facts, a decision will be taken by the Government of Haryana only after ascertainment of final decision from the Government of India.

Therefore, the claim of the petitioners cannot be decided at this stage i.e. till finalization of granting not of notional increment by Finance Department, Haryana which is possible only after having final decision of Government of India in this regard.

Ordered accordingly.

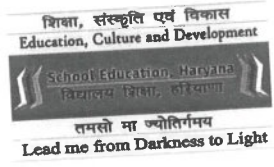
