Whereas Kuldeep Yadav approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 28654/2019 – Kuldeep Yadav V/s State of Haryana & Another praying therein inter alia for issuance of a writ in the nature of certiorari for quashing the impugned transfer order dated on 06-09-2019 in light of submission made herein below in the present petition and in the interest of justice and fair play.

The said petition came up for hearing before the Hon'ble High Court on 03.10.2019 and was disposed off with the following directions:-

*“Petitioner is seeking indulgence of this Court for issuance of a writ in the nature of certiorari quashing the transfer order dated 06.09.2019 and further writ for quashing Clause No.7 (i)(c) of Policy dated 29.06.2016(Annexure P-1) and Clause 8 (i)(a) of amended policy dated 05.06.2017 (Annexure P-2). In this regard, had submitted representation dated 25.09.2019 (Annexure P-11), but there is no adherence thereto.*

*Learned counsel for the petitioner submits that petitioner will be satisfied if a direction is issued to respondent No.2 to consider the representation dated 25.09.2019 (Annexure P-11) within a stipulated period.*

*Without going into the merits and demerits of the claim of the petitioner, I deem it appropriate to direct respondent No.2, to consider the representation dated 25.09.2019 (Annexure P-11) and decide the same within a period of two months from the date of receipt of certified copy of this order, by passing a speaking order after affording opportunity of hearing to petitioner, failing which, respondent No.2, shall be liable to pay costs of `25,000/- to petitioner.*

***This condition of imposing costs is only to prevent petitioner to run from pillar to post and avail remedy of contempt in case of non compliance of directions issued by this Court.***

***The writ petition stands disposed of with the above direction."***

In compliance of this order dated 03-10-2019, the case of petitioner has been examined and opportunity of personal hearing was granted to the petitioner. During hearing, grievance of the petitioner heard in length. It has been found that the petitioner had opted 49 schools for his transfer in transfer drive on dated 06-09-2019. The petitioner has opted for schools in District Sirsa and for no other District. The petitioner has obtained 39.76 points on MIS portal. The petitioner was allotted the school GSSS, Nagal(189) Yamunanagar in anywhere. On 06.09.2019 Smt. Shobha Sharma was transferred to GHS Sahuwala vide order no. 7/37-2019 HRM II (3) dated 06.09.2019. Later on vide letter 7/38-2019 HRM II (3) dated 13.09.2019 the order of Smt. Shobha Sharma was cancelled after giving relaxation in transfer policy with immediate effect by the Government of Haryana vide Order No.7/38-2019-HRM-II(3). Hence on 13.09.2019 the post became vacant and thus the grievance of the petitioner had been arisen on 13.09.2019. The transfer Redressal drive was open on 14.09.2019 but the option was not shown on the MIS Portal due to technical reasons.

At this juncture, it is pertinent to mention that the paramount object of transfer policy was to provide adequate teachers at every school for the welfare of children. For this purpose, the whole transfer system was made.


Besides this fact, it has also been relevant to state that the vacancy of a teacher depends on workload of periods of classes. In single section school there is not sufficient workload. Having such information, the Department rationalized the posts with an objective that the maximum number of students getting education in Govt. Schools may have teacher to teach. The petitioner has also not negated this fact.

*B* From these facts it is evident that the petitioner be adjusted at GHS Sahuwala District Sirsa. Considering the above said facts and circumstances the petitioner has been found aggrieved from this transfer, accordingly he is hereby adjusted at GHS



Sahuwala (2936) District Sirsa subject to participation in next transfer drive when ever norms for transfer drive fulfill.


