The charges are based on the statement of allegations appended thereto.

- 2 **Shri Jitender Gaur** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
- Shri Jitender Gaur is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, **Shri Jitender Gaur**, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Shri Jitender Gaur** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

Deputy Director HRG-I for Director Secondary Education, Haryana, Panchkula Statement of allegations against Shri Jitender Gaur [042098] the then Principal, Government Senior Secondary School, Nindana [2669], Rohtak now suspended.

While being posted as Principal, Government Senior Secondary School, Nindana (Rohtak) from 07.09.2017 to 03.12.2019, Shri Jitender Gaur committed following acts of omission and commission:-

That Shri Jasvinder Singh Gill, Deputy District Attorney office of Director Elementary Education, Haryana, Panchkula verbally informed Director Elementary Education, Haryana, Panchkula on 03.10.2019 that Shri Sunil Kumar [094096] Clerk O/o Principal, Government Senior Secondary School, Nindana, Rohtak who came to him i.e. Shri Jasvinder Singh Gill, Deputy District Attorney on 26.09.2019, for vetting of the affidavit, was directed that affidavit is required to be filed in the Hon'ble Punjab and Haryana Court on the date of hearing i.e. 27.09.2019 in CM NO. 10632 of 2019 in CWP No. 3490 of 2016 titled as Phoolwati versus State of Haryana. The said case was listed for hearing at Serial number 101 in the court room number 28 in urgent list. In this context, Shri Charanjit Singh Bakshi, Additional Advocate General, Haryana further directed him i.e. Shri Jasvinder Singh Gill, Deputy District Attorney Office of Director Elementary Education, Haryana, Panchkula on 27.09.2019 at 08.00 am that affidavit be handed over to him i.e. Shri Charanjit Singh Bakshi, Additional Advocate General, Haryana at 9.30 AM sharply and the said order was conveyed to Shri Sher Singh, Dealing Assistant Office of Director Secondary Education, Haryana, Panchkula who replied that he i.e. Shri Jitender Gaur was coming to attend the hearing in the Hon'ble Court and would reach in time at 9.30 AM. It was further confirmed by Shri Sher Singh, Assistant at 9.30 AM, that he i.e. Shri Jitender Gaur was in the Hon'ble Court. Resultantly, Shri Jasvinder Singh Gill, Deputy District Attorney Office of the Director Elementary Education, Haryana contacted him i.e. Shri Jitender Gaur but he i.e. Shri Jitender Gaur failed to attend the phone and also failed to present in the Court till 12.30 PM, Consequently, Hon'ble Punjab and Haryana High Court was about to summon Principal Secretary, Government of Haryana, School Education Department Chandigarh as well as the Director Elementary Education, Haryana, Panchkula but in the meantime he i.e. Shri Jitender Gaur reached the Hon'ble Punjab and Haryana Court at 12.30 PM. Resultantly, it was prayed by the Additional Advocate General, Haryana to take up the matter and the Hon'ble Punjab and Haryana High Court was pleased to disposed off the case thereafter. On examination of the said facts, following irregularity was found to be committed on his part i.e. Shri Jitender Gaur:-

That he i.e. Shri Jitender Gaur was very much aware of the gravity of the matter as the Director Elementary Education, Haryana, Panchkula had appeared in CM NO. 10632 of 2019 in CWP No. 3490 of 2016 titled as Phoolwati versus State of Haryana on the last date of hearing i.e. 19.09.2019 before Hon'ble Punjab and Haryana High Court

and case was listed for hearing on 27.09.2019 at Serial Number 101 in the Hon'ble Court room number 28. Further, he i.e. Shri Jitender Gaur had to handover the affidavit to the Additional Advocate General, Haryana at 9.30 AM but he i.e. Shri Jitender gaur reached at 12.30 PM and the Hon'ble Court took serious view of the matter which could result into personal appearance of the Principal Secretary, Government of Haryana, School Education Department Chandigarh as well as the Director Elementary Education, Haryana, Panchkula along with any adverse orders. As such, he i.e. Shri Jitender Gaur, took very casual approach in the matter by reaching the Hon'ble Punjab and Haryana High Court late by more than 3 hours and failed to attend the phone calls of Shri Jasvinder Singh Gill, Deputy District Attorney Office of Director Elementary Education, Haryana, Panchkula.

In this way, he i.e. Shri Jitender Gaur committed an act unbecoming of a Government officer by performing his duty in a casual manner in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Shri Jitender Gaur [042098] the then Principal, Government Senior Secondary School, Nindana [2669], Rohtak now suspended rendering him liable for strict disciplinary action under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Statement of charges against Shri Jitender Gaur [042098] the then Principal, Government Senior Secondary School, Nindana [2669], Rohtak now suspended.

While being posted from 07.09.2017 to 03.12.2019 as Principal, Government Senior Secondary School, Nindana (Rohtak), Shri Jitender Gaur committed certain acts of omission and commission for which he is charged as under:-

That he i.e. Shri Jitender Gaur was very much aware of the gravity of the matter as the Director Elementary Education, Haryana, Panchkula had appeared in CM NO. 10632 of 2019 in CWP No. 3490 of 2016 titled as Phoolwati versus State of Haryana on the last date of hearing i.e. 19.09.2019 and the case was listed for hearing on 27.09.2019 at Serial Number 101 in the Hon'ble Court room number 28. Further, he i.e. Jitender Gaur had to be handed over the affidavit to the Additional Advocate General, Haryana at 9.30 AM but he reached at 12.30 PM and the Hon'ble Court took serious view of the matter which could resulted into personal appearance of the Principal Secretary, Government of Haryana, School Education Department Chandigarh as well as the Director Elementary Education, Haryana, Panchkula along with any adverse orders. As such, he i.e. Shri Jitender Gaur took very casual approach in the matter by reaching the Hon'ble Punjab and Haryana Court late by more than 3 hours and failed to attend the phone calls of Shri Jasvinder Singh Gill, Deputy District Attorney Office of Director Elementary Education, Haryana, Panchkula.

In this way, he i.e. Shri Jitender Gaur committed an act unbecoming of a Government officer by performing his duty in a casual manner in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Shri Jitender Gaur [042098] the then Principal, Government Senior Secondary School, Nindana [2669], Rohtak now suspended rendering him liable for strict disciplinary action under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.
