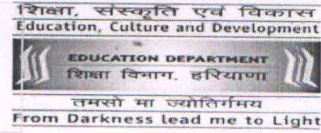

In continuation of office letter No. 1/2-2012-13 IED-SS (1) dated 30-08-13 regarding Provision of Stationary, Escort Allowance for CWSN studying in classes 9th to 12th, Stipend for all Girl Child (CWSN) under IED-SS. There are some directions which are compulsory to follow up:

1. Stationary will be provided to all CWSN studying in 9th to 12th Classes.
2. Escort Allowance will be provided to (Totally Blind, Low Vision (if required), Mentally Retarded and Multiple Disability CWSN) only on the basis of Medical Certificate issued by concerned Authority.
3. Stipend will be provided only for Girl CWSN Child (The SC and BPL Girl child alongwith with their disability will get double benefits).
4. Each and every child must be enrolled in UDISE on urgent basis.
5. The CWSN child who is not enrolled in UDISE will also be provided above mentioned facility in the during financial year but the concerned Special Teacher/BRC-Cum-Principal of IED will ensure that the particular CWSN child will be enrolled in UDISE year of 2013-14

The above mentioned points may be duly followed by the special teachers for filling the Annexures which were sent through mail vide letter no. **1/2-2012-13 IED-SS (1)** on dated **30.08.2013** related to the CWSN studying in 9th to 12th classes and will produce to the Head Quarter within 10 Days. The information provided should be duly signed by the BRC-cum-Principal of IED Model School of your block.
