

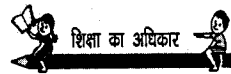


**Subject:- Minutes of the 10<sup>th</sup> meeting of the Executive Committee of RMSA held on 9.11.2016 at 3.00 P.M. at conference hall, Shiksha Sadan, Sector 5, Panchkula.**

10<sup>th</sup> meeting of the Executive Committee of RMSA was held on 9.11.2016 at 3.00 P.M. at Conference Hall, Shiksha Sadan, Sector 5, Panchkula, under the chairmanship of worthy ACSSE to discuss various matters pertaining to Education Department. Matters pertaining to Children With Special Needs were also discussed. All officers concerned have attended the meeting. On behalf of IED Cell, I, Rajnish Sharma, Coordinator, IED, have attended the meeting. Following issues were discussed and after discussion, worthy ACSSE have ordered as under :-

- (i) Every Saturday will be observed as "Bag Free Day" for all general children by the department. In this regard, guidelines are being prepared by the department. Therefore, while preparing guidelines for this day, department should prescribe various activities for disabled children and organize such activities in the schools and ensure their involvement according to their disabilities, need and requirements.
- (ii) The Children With Special Needs (CWSN) will play the role of guide, referee or monitor on that day during the various activities to be conducted for such children, so that proper interaction, involvement and cooperation among the general & disabled children may be maintained and they may not feel segregation environment and they may also be able to show their hidden talents in them and feel confident.
- (iii) Such disabled children of classes 9<sup>th</sup> to 12<sup>th</sup> should be involved in the District Chess Association. They should be provided with chess and impart training of chess to them by trained persons/students with whom CWSN feel comfortable. Also motivate & involve them in other indoor games according to their disabilities, need and requirements.
- (iv) Concerned Principals may also be directed to prepare and plan the activities/games according to the ability, I.Q. of the special children studying in their schools.
- (v) Monthly Assessment Tests are conducted for all general students every month by the department in schools. Since disabled children are not being covered in the present format of Monthly Assessment Tests, and their performance remains down as compare to general students, therefore, there is a need to modify/re-construct the Monthly Assessment Tests according to their disabilities, need & requirements in such a way that all disabled children may be covered and participated in these tests. Guidelines be prepared for such children accordingly.





- (vi) Worthy ACSSE has desired that the Medical Assessment Camps for Children with Special Needs (CWSN) should be organized in the month of July from the year 2017 and Aids & Appliances may also be provided within two months after completion of these camps. Generally as per Memorandum of Undertaking between Government of India, the Aids & Appliances are provided through ALIMCO under ADIP scheme but in case after getting the advance payment, the ALIMCO is failed to provide the Aids & Appliances to the CWSNs within time, Worthy ACSSE has desired that a letter may be sent to Sh. A. K. Awasthi, Director (JS DEPwD, MOSJE), Govt. of India, New Delhi. In this regard, if need be, the same matter may also be brought to the notice of Shri Krishan Pal, Minister of State, Social Justice & Empowerment, Haryana.
- (vii) Activities related to Cultural Activities of CWSN be organized after 15<sup>th</sup> January, 2017 due to heavy winter in this region,
- (viii) Parents of total blind students should be motivated for admitting their wards in the special schools which are being run under the department of Social Justice & Empowerment, Government of Haryana. Representative of Social Justice & Empowerment, Haryana was requested to conduct a counselling camps for the parents of Children having total blindness.
- (ix) Worthy ACSSE has desired that a detailed note with regard to any activity which is to be conducted may be sent to him in advance for his information.
- (x) Worthy ACSSE has desired that **I.T.Cell of the department** shall provide a separate link for activities of CWSNs (such as case study and success stories of CWSNs with articles pertaining to them, etc. etc.).
