

Whereas Smt. Urmila Devi [055547], Elementary School Headmistress, GMS Chhatehra B.pur Sonipat has filed a Civil Writ Petition No. 15672 of 2020 in the Hon'ble Punjab & Haryana High Court at Chandigarh. In the said writ petition she has made the following prayer:-

"for issuance a writ in the natrue of certiorari for quashing the impugned posting/transfer order dated 18.09.2020 (Annexure P-6) for posting/transfering the petitioner from Govt. Middle School, Chhatehra B. Pur, Sonipat to Govt. High School Chaudhary wali Distt. Hisar on account of promotion to the post of High School Headmaster (Which petitioner already have requested to forgo), being illegal arbitrary against the transfer policy dated 05.06.2017 (Annexure P/1), discriminatory and violative of Articles 14 and 16 of the Constitution of India;

(ii) Issue an appropriate order of direction for staying the opeartion of the impugned transfer order dated 18.09.2020 (Annexure P/6) because the petitioner already have requested to forgo her promotion to the post of High School Headmaster but still Transferred on account of promotion to 200 KMs away or in alternate, if respondent still don't want to accept request of Forgo promotion then the petitioner may be adusted against vacancies still available in Distt. Sonipat, during the pendency of the writ petition;

The said writ petition was disposed of by the Hon'ble High Court on 29.09.2020 and passed the following order:-

"Learned counsel for the State submits that he has no objection if the writ petition is disposed off with a direction to decide the representation (Annexure P-7) in a time-bound manner by passing a speaking order. He further states, on instructions, that the posting/transfer order dated 18.09.2020 (Annexure P-6) qua the petitioner would be kept in

abeyance till a decision is taken on the representation (Annexure P-7) made by the petitioner.

In view of the above, and without commenting on the merits of the case, the present writ petition is disposed off with a direction to respondent No.2 to decide the representation dated 21.09.2020 (Annexure P-7) made by the petitioner by passing a speaking order in accordance with law within a period of one month from the date of receipt of a certified copy of this order. Till then, as stated by learned State counsel, the impugned posting/transfer order dated 18.09.2020 (Annexure P-6) shall be kept in abeyance qua the petitioner only."

Keeping in view of the above said order, the representation of the petitioner has been considered and promotion order dated 18.09.2020 (Annexure P-6) has been withdrawn as the petitioner requested to forgo the promotion from the post of ESHM to Headmaster High School. The case will be considered for further promotion again after atleast one year on her written request only and she will not be entitled for any benefits specially pay fixation and seniority etc. It is further ordered that increment on promotions as well as ACPs granted to her would be withdrawn as per rule. Accordingly, claim of the petitioner is hereby decided.

I order accordingly.


