As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019, issued vide notification no. - Note:- 1. Their appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
 - 2. They are also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

- 1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
- 2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education,

- Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.
- 3. They will be required to take the prescribed oath of allegiance to the constitution of India.
- 4. In case they are married, they will produce the following certificate to his/her

"That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.

- 5. In case they are unmarried, they will have to furnish a declaration to the Head of the Department that they have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
- 6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
- 7. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
- 8. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
- 9. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
- 10. No TA/DA and joining time will be paid to them for joining this post.
- 11. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
- 12. Their appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
- 13. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" and amended in the year 2013.

- 14. Their services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
- 15. That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.

ORDER No. 13/34-2021 HRME- I(4) Dated, Panchkula, the 28,04-21

Whereas, Petitioners have filed the CWP No. 16974 of 2020 titled as Krishan Kumar and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein to for issuance of a writ in the nature of certiorari/mandamus quashing the List dated 07.08.2020 (P-4) and impugned order dated 14.08.2020 (P-5) qua the petitioners.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 28.01.2021 and the same was disposed of with following orders:-

> "In view of the agreed stand taken by both sides, this writ petition is disposed off with liberty to the petitioners to make a representation to the competent authority within a period of two weeks from today and the same shall be considered and decided expeditiously in accordance with law preferably within two weeks thereafter in case there is no legal impediment.

> It is clarified that in case the desired representation is not decided within the stipulated time, the same shall be considered as disobedience of the order of this Court.

> Since main writ petition stands disposed off, therefore, the pending applications, if any, shall also dispose off."

In compliance of the abovementioned orders of the Hon'ble High Court, the department examined the claim of the petitioners & it was found that all the petitioners were compulsorily participants of Online Transfer

Policy of Ministerial Staff dated 06.03.2020. All the petitioners opted stations according to their suitability and choices and petitioner no 1 to 7 got the stations out of their preferred stations but petitioner no. 8 could not get station opted by him due to low merit scores obtained by him. Such stations were given/allocated to the employee who has scored higher marks than the petitioner no. 8. Therefore, petitioner no. 8 was transferred 'Anywhere in the State' category.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020. Thereupon, transfers were made under this policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State, in a fair & transparent manner and to maximize job satisfaction amongst employees. Under this policy all government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/ institutes across the zones available to him/her. He/She is free to give preferences in order of his/her suitability. So that chances of being posted in 'Anywhere in the State' category may be decreased.

Further it is stated that according to the Para No. 4 sub clause V (b), the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-

iv) Rationalization and Blocking of posts: To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.

The posts with less workload were blocked by the department, because stations with overwork load require more employee for smooth working in the department. So, for maximum utilization of the potential of an employee at over work loaded station and to avoid misappropriate concentration of employee at particular station, the blocking of posts was done by the process of rationalization in the public interest.

Moreover, the stations were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department, due to the process of rationalization for the purpose of even distribution of clerks in the State, which is done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas as per the provisions of the policy, allotment of a vacant seat/stations to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80

points. However, it is worthwhile to mention here that the categories like woman, widows, widowers, differently abled persons, employees with serious ailments, a privilege of maximum 20 points can be availed by the employees. Therefore, the employees were asked to opt maximum stations as per their choice suitable to them so that their chances of getting posted on an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by him/her, he/she shall be transferred under 'Anywhere in the State' category. In case an employee is to be transferred on an un-opted station in "Anywhere in state" category then Computer Programme/Software, instead of sending them at a distant place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Whereas, according to general principles of the policy, every employee is responsible for the accuracy and regular updation of data in MIS in respect of his/her credentials, otherwise the department is at liberty to transfer him anywhere category in the state. Employees are liable to be transferred under this policy in any zone or anywhere in the State, in public interest, on completion of prescribed tenure.



- 1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
