

The Governor of Haryana is please to promote Smt Saroj Bala [041287] (Retired on 31.03.2020 from Government High School, Patwapur, Rohtak) Headmistress (seniority no. 1104 as stood on 01.06.2015) to the post of Principal (Rest of Haryana Cadre) (School Cadre) in the pay scale of Rs.15,600-39,100 + 6600 (G.P.) plus usual allowances as sanctioned by the Haryana Government from time to time w.e.f. 27.11.2019/28.11.2019 i.e. the date her junior was promoted. She will be entitled for notional pay fixation along with benefit of seniority w.e.f. the date her juniors were promoted, however, she will not be entitled to any arrear of pay for such promotion for the period in which she had not actually worked as Principal.

**Terms & Conditions:**

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. **This promotion orders are subject to final outcome of Civil Writ Petitioner No. 19403 of 2019 titled as Baljeet Singh V/s State of Haryana.**
3. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
4. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
5. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centres located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
6. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
7. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their

inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.

8. There is no adverse remarks in the ACR for the year 2018-19.
9. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
10. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.
11. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
12. The District Education Officer concerned shall ensure compliance of above conditions before letting the promoted Principal to join.
