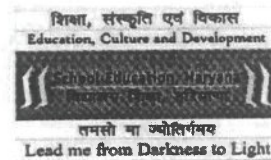

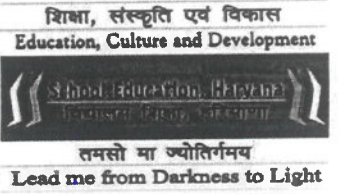

As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019, issued vide notification no. G.S.R. 32/Const./Art.309/2019 dated 02.08.2019, sanction is hereby accorded to appoint the following dependent due to death (while in service) of their father on the post of Clerk (Group-'C') on compassionate ground in the Government School of Education Department without going through the procedure of Haryana Staff Selection Commission/Director Employment Exchange Department in the pay band FPL-2 (19900-63200) of Schedule-I pay Matrix of Haryana Civil Services (Revised pay) Rules, 2016 plus usual allowances as sanctioned by the Haryana Government from time to time. He is hereby posted in the offices/institutions mentioned as under against vacancy and is posted at place mentioned against his name with immediate effect on the terms and condition mentioned below:-

- Note:-**
1. His appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
  2. He is also directed to participate in next online transfer drive for taking permanent Station.

### TERMS & CONDITIONS:-

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
2. If at any stage he desires to resign his posts he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his services for the reason other than that mentioned in clause (I) above.
3. He will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case he is married, he will produce the following certificate to his/her Head of office:-

- are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case he is unmarried, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
  6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
  7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
  8. He will be required to produce the original Educational documents and date of birth certificate before joining his duties of the said post.
  9. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining his duties.
  10. No TA/DA and joining time will be paid to him for joining this post.
  11. He will remain on probation for a period of two years, from the date of his joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing his performance during the period of probation, his work conduct will be taken into consideration. If his work and conduct during this period is not found satisfactory his services will be terminated without any notice.
  12. His appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
  13. That in the matters, not specifically mentioned in this Communication, he shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. He shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" and amended in the year 2013.
  14. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
  15. That if he got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, he would be liable for termination of his

services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.


