REGULATION GOVERNING THE AWARD OF SCHOLARSHIP (APPLICABLE FROM IST APRIL 2003)

The objective of the scheme is to provide financial assistance to the Scheduled Caste students studying at post matriculation or post-secondary stage to enable them to complete their education.

These scholarships are available for studies in India only and are awarded by the 11. government of the State/Union Territory to which the applicant actually belongs i.e. permanently settled

CONDITIONS OF ELIGIBILITY 111.

The scholarships are open to nationals of India.

These scholarships will be given for the study of all recognised post-matriculation for post-secondary courses pursued in recognised institutions with the following exceptions:

"Scholarships are not awarded for training courses like Aircraft Maintenance lingineer's Courses and Private Pilot licence Courses. Courses at Training - Ship Dufferin (Now Rajendra), courses of training at the Military College, Dehradun, courses at Pre-examination Training Centres of all India and State levels."

Only those candidates who belong to Scheduled Castes so specified in relation to the State/Union Territory to which the applicant actually belongs i.e. permanently settled and on Higher Secondary or any higher examination of a who have passed the Matriculrecognised University or Board of secondary Education, will be eilgible.

Candidates who after passing one stage of education are studying in the same stage of education in different subject eg. LSe after IA or B.Com after B.A. or M.A. in other iv) subject will not be eligible.

Students who, after having completed their educational career in one professional line, e.g. 1 (.1) after B.T./B.Ed. will not be eligible. From the academic year 1980-81, studies in two professional courses are allowed.

Students studying in Class XI of the Higher Secondary School courses of the XII Class of the Multipurpose High School will not be eligible for it being a continuous school course. However, in cases where tenth class examination of such courses is treated as equivalent to Matriculation and students who after passing tenth class join other courses, such students will be treated as post-matric students and will be eligible for the award of scholarships

- vii) Students pursuing Post-graduate courses in medicine will be eligible if they are not allowed to practice during the period of their course
- Students who after failing or passing the under graduate/post-graduate examinations in Arts/Science/Commerce join any recognised professional or Technical certificate/diploma/degree courses will be awarded scholarships if otherwise eligible. No subsequent failure will be condoned except courses in Group 'l'.
- (ix) Students who pursue their studies through correspondence courses are also eligible. The term correspondence includes distant and continuing education.

Employed students whose income combined with the income of their parents/guardians does not exceed the maximum prescribed income ceiling are made eligible to post-matric scholarships to the extent of reimbursement of all compulsorily payable non-refundable fees.

All children of the same parents/guardians will be entitled to receive benefits of the scheme

A scholarship holder under the scheme will not hold any other scholarship/stipend. If awarded any other scholarship/supend, the student can exercise his/her option for either of the two scholarships/stipends, whichever is more beneficial to him/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship will be paid to the students under this scheme from the dates he/she accepts another scholarship/stipend. The student can however, accept free lodging or a grant or adhoc monetary help from the State Government or any other source for the purchase of books, equipment or for meeting the expenses on board and lodging in addition to the scholarship amount paid under this scheme

Scholarship holders who are receiving coaching in any of the pre-examination training centres with financial assistance from the Central Government State Government will not be eligible for stipend under the coaching schemes for the duration of the coaching programme.

Note 1: It is mentioned under the item III (condition of eligibility) of these regulations that the scholarship will be given for the study of all recognised post-matriculation or post-secondary courses pursued in recognised institutions the list of courses grouped (I to IV) is only illustrative The State Governments/Union Territory Administrations are, thus, themselves competent to decide the appropriate grouping of courses at their level as advised vide this Ministry's letter No.11017/13/88-Sch.Cell; dated 3-8-1989.

MEANS TEST IV.

Scholarships will be paid to the students whose parents/guardians' income from all sources does not exceed Rs. 1,00,000/- per annum.

So long as either of the parents (or husband in the case of married unemployed NOTE 1: girl student) is alive, only income of the parents/husband, as the case may be, from all sources has to be taken into account and of no other member even though they may be earning. In the form of income declaration, income is to be declared on this basis. Only in the case where both the parents (or husband in the case of married but unemployed girl student); have died, the income of the guardian who is supporting the student in his/her studies has to be taken. Such students whose parent's income is affected due to unfortunate death of one of carning parents and resultantly comes within the income ceiling prescribed under the scheme, shall become eligible for scholarship, subject to their fulfilling other conditions of eligibility, from the month in which such sad incidence takes place. Applications for scholarships from such students can be considered even after lapse of last date of receipt of applications, on compassionate grounds.

NOTE 2: House rent allowance received by the parents of a student shall be exempted from the computation of 'income' if the same has been permitted to be exempted for purpose of Income tax.

NOTE 3: Income certificate is required to be taken once only i.e. at the time of admission to courses which are continuing for more than one year.,

NOTE 4: The revised income ecilings account for Consumer Price Index for Industrial workers upto October 2002. Income Ceiling would be revised once in every two years linking it with Consumer Price Index for Industrial Workers for the month of October of the year, preceding the year of revision and will be made effective from April.

VALUE OF SQUOLARSHIP

The value of scholarship includes maintenance allowance, additional allowance students with disabilities, reimbursement of compulsory non-refundable fees, study tour charges thesis typing/printing charges, book allowance for students pursuing correspondence courses and book bank facility for specified courses, for complete duration of the course. The details are as follows:

Note 1 Commercial Pilot License Course (CPL)

CPL course would include Commercial Helicopter Pilot License (CHPL) and multienjune ratingerraining on N-120 and similar aircrafts even after the candidate has got scholarship The number of awards for CPL will be 20 per annum. Consequent upon receiving applications from concerned students, concerned State Governments/UT Admins, should scrutinise them for determining their eligibility under the scheme and thereafter recommend the number of eligible applicants for CPL training (with their names) each financial year to Ministry of Social Justice & Empowerment (their applications need not be sent to the Ministry). Upon receipt of such information, Ministry of Social Justice & Empowerment will give clearance to the concerned States/UTs on the first-come-first served basis upto 20 awards for the country as a whole. Selected candidates are provided a maintenance allowance at the rates applicable to Group '2' courses i.e. Rs 740 per month for hostlers and Rs.330 per month for day scholars. In addition all compulsory fees, including flight charges are to be provided as fee.

Note 2:M. Phil and Ph.D courses are post-graduation courses. Scholarship to such students may be paid at the rates of maintenance allowance for Group 'I' or 'II' depending on the course under these groups.

Note 3: Normally the term 'Hostel' is applicable to a common residential building and a common mess for the students run under the supervision of the educational institution authorities. In case the college authorities are unable to provide accommodation in the college Hostel, an approved place of residence can also be treated as Hostel for the purpose of this scheme. The place will be approved by the Head of the Institution after due inspection and keeping in view the rules and regulations laid down by the University, if any. In such case, a certificate to the effect that the student is residing in an approved place of residence, as he is unable to get accommodation in the college hostel should be furnished by the Head of Institution

It is further clarified that such deemed hostels should consist of such accommodation as is hired at least by a group of 5(live) students living together, usually with common mess arrangements.

Note 4. Scholars who are entitled to free board and/or lodging will be paid maintenance charge at 1/3^{el} at Hostllers' rate.

- (13) Provision of transport allowance upto Rs (10) per month for disabled such students do not reside in the hostel, which is within the prem educational institution. The disability as per the Persons with Disabilities (b Opportunities, Protection of Rights and Full Participation) Act, 1995 is defined blindness, low-vision, leprosy-cured, hearing impairment, locomotor disability, mental retardation and mental illness.
- Escort Allowance of Rs 100/- per month for severally handicapped day scholar (C) students with low extremity disability.
- Special Pay of Rs 100%- per month is admissible to any employee of the hostel (D) willing to extend help to a severely orthopaedically handicapped student residing in hostel of an educational institution, who may need the assistance of a helper.
- Allowance of Rs 150/- per month towards come coaching to mentally retarded and (E) mentally ill students

The provisions in (B) to (D) will also apply to such reprosy-cured students Note 1:The disabled students belonging to Scheduled Castes covered under the Scheme can also get such additional lienefits from other Schemes, which are not covered under the scheme Note 2: The disability as defined under the said Act has to be certified by competent medical authority of the State Govt/UL Administration. iii) Fees

Scholnes will be paid enrolment/registration, tuition, games, Union, Library, Magazine, Medical Examination and such other fees compulsorily payable by the scholar to the institution or University/Board Refundable deposit like caution money, security deposit will, however, be excluded

Note: Compulsory non-retundable fee charged by recognised institutions against free and paid sents of recognised courses can be fully reimbursed as per the fee structure approved by the competent State/Control Government authority. However, while sanctioning scholarship against paid seats, State Governments should make the income verification compulsory.

Correspondence courses including distance and continuing education

The students pursuing such courses are also cligible for an annual allowance of Rs.750/for essential/prescribed books, besides reimbursement of course fees

vii) Book Banks

- Book Banks are to be set up in all the Medical, linguineering, Agriculture, Law and Veterinary Degree Colleges and Institutes imparting Chartered Accountancy, MBA and alike Management courses and Polytechnics where Scheduled Caste students are in receipt of Post Matric Scholarship. The set of text books will be purchased for 2 such SC students at various stages except in respect of Post-graduate courses and Chartered Accountancy where it will be one set for each student. However, the ratio of sets and students will have to be adjusted to the total number of sets that could be procured within the total resources allocated to the State concerned.
 - The details of courses covered for setting up of Book Banks, ceiling of admissible expenditure per set of books and sharing criteria are given below:

Courses

1 Bio-Sylences

For storage of books and contingencies etc., the cost of steel almirah for storing books of each Book Bank including contingencies like transportation etc. the following expenses are admissible.

Rs 2000 or actual cost whichever is less.

5% of the grant may be earmarked for expenses on binding, sticking etc.

Note: The said sets of books also include Braille Books, Talking Books. Cassettes for the visually Handicapped students.

- 3. The Book Banks are to be set up in all the recognised colleges/institutions where these courses are being offered as recognised courses.
- 4 Purchase of books for these Book Banks will be restricted to the prescribed text books for the entire courses
- The State Governments may constitute Expert Groups consisting of members from selected colleges/educational insulutions of different regions to decide the adequate number of text books in a set(not reference books) required for each course.
- the life period of one set of books has been fixed at 3 years. Thereafter the books may be disposed of by the institutions in the same manner as the books in the library subject to the guidelines, if any, of the State Government/UT Administration in this regard.
- These books are to be supplied to SC students in installments, depending on the course, semester structure etc
- 8. The following rules shall govern the distribution of books to the students:
- (i) Each SC student will be provided with an identity card for this purpose.
- (ii) Each SC student will be required to submit requisition for borrowing books from the Book Bank in a form to be provided for this purpose.
- (iii) The books would be returned to the Book Bank at the end of each term. The Principal of the college/institution will make every effort to ensure that those underts who complete their choice or those who drop out in the middle, return the books belonging to the Book Bank.

- It is the responsibility of the student concern to maintain the books supplied to (iv) them from the Hook Bank, in good combinion
- Any case of loss or damage to the books would attract penalty. In case of (V) serious damage or loss of books, the student concerned will have to bear the cost of the book.

SELECTION OF CANDIDATES VI)

- All the eligible Scheduled Caste candidates will be given scholarships subject to the i) application of Means Test prescribed in these Regulations.
- Candidates belonging to one State but studying in other State will be awarded scholarships by the State to which they belong and will submit their applications to the ii) competent authorities in that State. In the matter of exemption from fees or other concessions also they will be treated as if they were studying in their own State.

DURATION AND RENEWAL OF AWARDS VII)

- The award once made will be tenable from the stage at which it is given to the completion of course subject to good conduct and regularity in attendance. It will be i) renewed from year to year provided that within a course which is continuous for a number of years, the scholar secures promotion to the next higher class irrespective of the fact whether such examinations are conducted by a University or the Institution.
- If a Scheduled Caste scholar pursuing Group I courses fails in the examination for the first time, the award may be renewed. For second and subsequent failure in any class, the ii) student shall bear his/her own expenses until he/she secures promotion to the next higher
- If a scholar is unable to appear in the annual examination owing to illness and or on account of any other unforesecable event, the award may be renewed for the next iii) academic year on submission of medical certificate and/or other required sufficient proof to the satisfaction of the Head of the Institution and his/her certifying that the scholar would have passed had he appeared in the examination
- If according to the Regulations of a University/Institution, a student is promoted to the next higher class even though he/she may not have actually passed in lower class and is iv) required to take examination of the junior class again after sometime, he/she will be entitled to scholarship for the class to which he/she is promoted if the student is otherwise eligible for scholarship

VIII. PAYAILNT:

iii)

- Maintenance allowance is payable from 1° April or from the month of adhibition whichever is later, to the month in which the examinations are completed, at the entitle academic year (including maintenance allowance during holidays), provided that the scholar secures admission after the 20th day of a month, the amount will be made from the month following the month of admission
- ii) In case of renewal of scholarships awarded in the previous years, maintenance allowance will be paid from the month following the month upto which scholarship was paid in the previous year, if the course of study is continuous
 - The Government of the State/Union Territory Administration, to which they belong, in accordance with the procedure laid down by them in this regard, will pay the scholarship money to the selected students.
- Scholarship will not be paid for the period of internship/housemanship in the M.B.B.S. course or for a practical training in other course if the student is in receipt of some renumeration during the internship period or some allowance/supend during the practical and training in other course.

IX OTHER CONDITIONS FOR THE AWARD

- The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc. the authority sanctioning the scholarship may either cancel the scholarships or stop or withhold further payment for such period as it may think fit
- ii) If a student is found to have obtained a scholarship by false statements, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in any scheme forever.
- of study for which the scholarship was originally awarded or changes the institution of study, without prior approval of the State Government. The Head of the Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.



- Overment, if during the root of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.
- v) The regulations can be changed at anytime at the discretion of the Government of India.

X. ANNOUNCEMENT OF THE SCHEME

All the State Governments will announce in May-June, the details of the scheme and invite applications by issuing an advertisement in the leading newspapers of the State and through other media outlits. All requests for application forms and other particulars should be addressed to the Government of State/Union Territory Administration to which the scholars actually belong. The applicant should submit the completed application to the prescribed authority before the last date prescribed for receipt of applications.

XI. PROCEDURE FOR APPLYING

- i) An application for scholarship should comprise:
 - a) one copy of the application for scholarship in the prescribed form (separate application forms as have been prescribed for 'fresh' and renewal scholarship by concerned States/(I/s)
 - One copy of the passport size photograph with signatures of the student thereon (for bresh scholarship)
 - One attested copy of certificates, diploma, degree etc. in respect of all examinations
 passed
 - d) A certificate (in original) of Caste duly signed by an authorised Revenue Officer not see below the rank of Tehsildar.
 - An income declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper.
 - 1) A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application only duly counter-signed by the Head of the Institution concerned, if the application was in receipt of a scholarship under this scheme in the preceding year.
- n) Application complete in all respects shall be submitted to the Head of the Institution, being attended or last attended by the candidates and shall be addressed to an officer

specified for this purpose by the Government of State/Union Territory to which the student belongs, in accordance with the instructions issued by them from time to time.

XII. FUNDING PATTERN OF THE SCHEME

The Scheme is implemented by the State Government and Union Territory Administrations, which receive 100% central assistance from Government of India for the total expanditure under the scheme, over and above their respective Committed Liability. The level of Committed Liability of respective State Violernments/Union Territory Administrations for a year is equivalent to the level of actual expanditure incurred by them under the Scheme during the reminal year of the last Five Year Plan Period and is required to be borne by them for which they are required to make required provision in their own budget. The North Eastern States have, however, been exempted from making their own budgetary provisions towards Committee Liability from Ninth Plan Period (1997-2002) onwards and the entire expanditure under the Scheme in respect of them will be borne by Government of India

All the State Governments and Union Territory Administrations implementing the scheme will harnish data of beneficiaries and expendence under the scheme, to Government of India, as and when required. I marked assistance proceeder the scheme shall not be utilized for any other purpose.

Centrally Sponsbred theme of Post-Matric Scholarship for students belonging to Schedu | Castes - Calling of proposals for seeking due Central assistance dur 3 the year 2008-09.

The Scheme of Post Matric holarships to the students belonging to Scheduled Caste for studies in India is perhap, the most important Scheme of the Government of India aimed at educational development of Scheduled Caste students at postmatriculation stages. In order to ensure that this scheme is implemented efficiently, so as to reach the target group, it is requested that you may kindly take early action to formulate the State Government's proposals for the year 2008-09 and send it to the Ministry to enable an early release of funds, and ensure early disbursement of sche arships. You are, therefore, requested kindly to take advance action on the folle ving: -

- 1.1 Proposals may be formulated in the prescribed proforma for release of Central Assistance under the Scheme. A copy of prescribed proforma for furnishing proposal for the year 2008-0's enclosed, which may be duly filled and returned at the earliest.
- 1.2 The anticipated expenditure projections for 2008-09 may be worked out keeping in view the trend of growth a wards. If however, any State Govt. proposes any abnormal growth, and ii. all cases where more than 20% growth in expenditure/coverage is envisaged, the same may be supported with valid reasons, therwise they are likely to be rejected.
- 1.3 Since the expenditure projection for 2008-09 is based on actual expenditure 2007-08, it may be categorically stated whether the actual expenditure reported for 2007-08 are based on departmental figures duly audited. In case the accounts have not been audited the probable date by which the audit shall be completed may please be indicated. The arrears for the year 2007-08, which could not be paid should be separately indicated, so as to have an idea about total expenditure on the Scheme in a year.

bank Component will be shared on 50.50 basis between Centre/S: tes and case of UTs.

- 1.5 The unspent balances with States/UTs needs to be reconciled immediately avoid delay in release of funds.
- 1.6 Urgent necessary steps may be taken to update the audit of expensiture under the scheme. Where audit under the scheme is pending for many years, special drive needs to be undertaken in co-ordination with the concerned Accountant General to bring the position of audit up-to-date. In the proposal for 2008-09, audited expenditure figures for 2007-08 may be provided, wherever available. The utilisation certificate(s) for central assistance released in past may be furnished in prescribed proforma (GFR-19A) duly signed by the competent authority.
- 1.7 Free availability of forms and timely payment of scholarship are instrumental in the scheme. In this regard this Ministry had also issued comprehensive guidelines for streamlining sanction and disbursement procedures under this scheme vide this Ministry's circular No.14017/8/93-Sch. Cell, dated 4.4.1995. Timely parment of scholarship must be ensured to all eligible students covered under the Scheme. The system of sanction and disbursement of scholarship should be simplified so that there is no undue delay and all the eligible students get scholarship without any difficulty.
- 1.8 It is requested that all the parts of the proforma are filled in properly with consequent figures of beneficiaries and expenditure and signed by competent officers at the appropriate place and may please be furnished as early as possible so that due central assistance could be released to your State/UT well in time for disbursement of scholarship to poor SC students.

Upward revision in family income ceiling in Post-Matric Scholarship Scheme for S.C. students.

Dear Vijuyends.

The Ministry of Social Justice & Empowerment, Government of India has revised the annual family income ceiling from the existing $\stackrel{>}{_{\sim}}$ 1.00 lac to $\stackrel{>}{_{\sim}}$ 2.00 lac per annum under Post-Matric Scholarship Scheme for S.C. students. The Ministry has also revised grouping of courses and also suitably increased monthly maintenance for Day Scholars and Hostellers. A copy of communication received from the Government of India on the subject is enclosed for ready reference. Since the income ceiling and monthly maintenance allowance and other allowances have been revised w.e.f. 1.7.2010, those students whose parents'/guardians' annual income was between ₹ 1.00 lac to ₹ 2.00 lac have also become eligible for grant of scholarship under Post-Matric Scholarship Scheme. A fresh advertisement is being issued asking such students to apply, the last date for which has been kept as 15th February 2011.

In view of the above, I would request you to give wide publicity to the revised income ceiling and other norms. A copy of the above referred letter received from the Ministry of Social Justice & Empowerment, Government of India may kindly be sent to the Principals/Directors of the Government, Government aided as well as private institutions (including Self-Financed Institutions) under your supervision and administrative control with the directions to give wide publicity to it and invite applications from S.C. students whose parental annual income is between ₹ 1.00 lac to ₹ 2.00 and who have thus become eligible for grant of scholarship under Post-Matric Scholarship Scheme. Subject: Revision in the Centrally sponsored scheme of Post-Matric Scholarship for students belonging to Scheduled Castes.

The Government of India has been implementing the Scheme of Post-Matric Sir, Scholarship to students belonging to Scheduled Castes since 1944. It aims to provide financial assistance to students belonging to Scheduled Castes for pursuing postmatriculation courses through recognized institutions. Under the Scheme, Central assistance is provided on 100% basis to all States/UTs over and above their respective "committed liability" except in the case of the 8 North Eastern States (Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Tripura and Sikkim), which are exempted from committed liability, and were therefore provided 100% assistance without deducting any committed liability.

- Components of the Scheme include:

 - reimbursement of non-refundable compulsory fee charged by educational. (i) (ii)institutions;
 - Book Bank facility, and
 - certain other allowances. (iii)

The Scheme was last revised w.e.f. 01.04.2003, and the revised Scheme was communicated to State Governments vide this Ministry's letter No.11017/7/2002-SCD-V dated 28lli January 2004.

- The Scheme has now been revised w.e.f. 01.07.2010. The revision includes changes in (i) income ceiling; (ii) grouping of courses; and (iii) rates of maintenance and other allowances.
- The changes effective from 01.07.2010 are summarized in the table below.

- 5. Under Centrally-sponsored Schemes, recurring expenditure of the last year of a Five Year Plan gets transferred to States as their committed liability, from the first year of the next Five Year Plan. In the instant case, however, as the revision is taking place late during the XI Five Year Plan, Government of India have decided, as a special case, that additional committed liability arising on account of the revision of the Scheme w.e.f. 01.07.2010 shall be passed on to the States / UTs at the end of the XII Five Year Plan (w.e.f. 01.04.2017) and not at the end of the XI Plan. However, committed liability as per old scholarship rates, at the end of the XI Plan, will get transferred to States / UTs from 1.4.2012 as per past practice.
- 6 Other provisions of the Scheme remain unchanged.
- 7. State Governments are requested to please send a revised proposal for Central assistance in 2010-11 in the light of the above revision of the Scheme, so as to reach the undersigned (by name), preferably by 31st January, 2011, but, in any case, not later than 15th February, 2011. In case the proposal for Central assistance under the Scheme for the current year has not yet been sent, it may now please be sent, in the light of the above revision, by the above dates, to enable the Ministry release Central assistance at the earliest.
