In compliance with the Hon'ble Punjab and Haryana High Court's order dated 29.11.2019 passed in CWP No. 34810 of 2019 titled as Roshan Lal Vs. State of Haryana and others, **Sh. Roshan Lal [026018], Hindi Teacher (C&V) now ESHM, Govt. Middle School, Gorgarh (Karnal) [4438]** is hereby promoted as **PGT Hindi w.e.f. 06.05.2016 (Notionally)** i.e. the date from his junior namely Sh. Virender Singh [026024], PGT Hindi, Govt. Sr. Sec. School, Nigdhu (Karnal) [1800] was promoted to the post of PGT Hindi in the Scheduled-I of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time. Further, he is posted against vacancy in the School mentioned against his name in the below table temporarily. He shall have to compulsorily participate in the next phase of Online General Transfer Drive for permanent posting. The details are as under :-

TERMS AND CONDITIONS:-

- 1) If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Service (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent shall be reverted without issuing any prior notice.
- 2) The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent shall be reverted without issuing any notice.
- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed

Universities, from study centers located outside the territorial jurisdiction of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of judgment passed by Hon'ble Division bench of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

- 4) If the penalty of stoppage of grade increments with or without cumulative effect is still in operation, the incumbent shall be reverted in view of Govt. instructions dated 31.05.2006.
- 5) If any discrepancy regarding not fulfilling the essential qualifications/eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012 is found, the said incumbent shall be reverted without issuing any prior notice.
- 6) The promotion being based on provisional list and without prejudice to the right of the seniors to be considered for promotion if they opt for promotion as **PGT Hindi** provided they are found eligible for the post.
- 7) Promotions are subject to undergo change if warranted on the regularization of the provisional gradation list.
- 8) In case the degree of a teacher is found not to be from a recognized University having no statutory authority/jurisdiction in regard to award of such degree, the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action as per rules.
- 9) The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and posts have been reserved for them pending determination of their eligibility at a later date.
- 10) Inter-se seniority based on the feeder cadre shall be the determining factor in the PGT Cadre. In other words if a senior employee in the TGT cadre is found eligible at a later date and vacancy in respect of them is occupied by a junior employee, then the junior employee shall have to be reverted back so that such senior employee may get their due promotion.

- 11) He will remain on probation for a period of one year, which can be extended in terms of Service Rules, in case his work and conduct is not found satisfactory.
- 12) It is also made clear that the incumbent can't be considered senior to other TGTs those will be promoted thereafter in other subjects and seniority will be considered only from their feeder cadre i.e. as per seniority list of TGTs.
- 13) It is made clear that he shall compulsorily participate in the next General Transfer Drive as per Teacher's Transfer Policy, 2016.
- 14) The promotion is subject to final outcome of decision(s) of CWP No. 9675 of 2016 titled as Sumer Singh V/s State of Haryana.
- 15) He is directed to join his place of posting within 15 days, failing which this offer of promotion will be deemed to have been withdrawn.

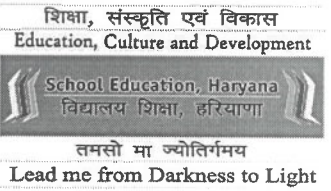
