- 2. If any, disciplinary proceeding under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
- 3. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
- 4. If any discrepancy regarding not fulfilling the essential requirements as prescribed in the Haryana State Education (Group-A) Rules, 1998, the said incumbent(s) shall be reverted without issuing any notice.
- 5. The inter-se-seniority of the promote(s) shall be subject to the claim of their seniors, who have not been promoted in these orders due to various reasons and for whom the posts have been kept reserved.
