







Subject:- Preventive measures to contain the spread of Coronavirus (COVID-19)- Guidelines for protection and safety of Persons with Disabilities (Divyangjan), vulnerable persons and Pregnant Women.

Sir/Madam,

I am directed to invite your attention towards Government letter of even number dated 16.04.2021 on the subject noted above vide which it was directed that Officers of the level of Under Secretary or equivalent and below be allowed to work from home and their physical attendance in office be restricted to 50% of the actual overall strength. Thereafter, vide letter dated 30.04.2021 it was conveyed that no person with severe disabilities (Divyangjan), vulnerable persons viz. employees suffering from hypertension, blood pressure, Heart or Lung disease, cancer and other chronic disease and Pregnant women employee whether regular, contractual, outsources, daily wages or adhoc shall be called for duty, even if they are engaged in essential services, till further orders.

2. Government has duly considered the matter, It has been observed that the Covid positivity rate and the number of new positive cases have declined drastically and therefore, the exemptions provided by the Government letters referred to above are hereby withdrawn with immediate effect.
