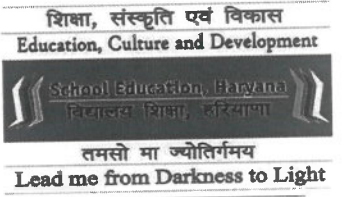

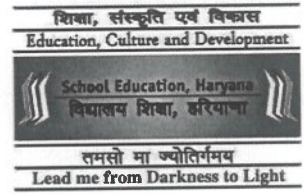

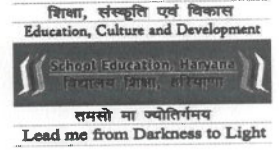

No. 6/25-2017 HRG-II (1)

Dated: Chandigarh, the 14.7.2017

Whereas, Sh. Dinesh Kumar had filed a CWP No. 18030 of 2017 for directing the department to grant him promotion as Headmaster High School from the date of his junior, who was earlier promoted as High School Headmaster.

The said writ petition was disposed of by the Hon'ble High Court on 16.08.2017 and the following order was passed:-

“Without commenting on the merits of the case or the entitlement of the petitioner for the above said relief and keeping in view the fact that the matter is still pending consideration, the present writ petition is disposed of with direction to respondent no. 2 to take a decision on the said legal notice dated 06.04.2017 (Annexure P-4) within a period of 3 months from the date of receipt of certified copy of the order. Needless to say if the benefit is to be declined, a reasoned order be passed and the same be conveyed to the petitioner.”

Whereas, in compliance of above said order legal notice dated 06.04.2017 of Sh. Dinesh Kumar was duly examined and it was found that earlier he was wrongly promoted as High School Headmaster due to negligence of branch officials vide order 6/25-2017 HRG-II (2) dated 3.12.2017 w.e.f. 10.02.2014. Now, after re-examination of the case of Sh. Dinesh Kumar, it has been found that initially he was appointed as C&V teacher on 07.08.1985 and his services were regularized on 30.09.1988 as C&V teacher. He was promoted to the post of Social Science Master on 15.01.1996. He was further promoted in the year 2017 from back date (10.02.2014) but there was no provision in Haryana State Education School Cadre Group B service (amendment) Rules, 2012 regarding promotion as a High School Headmaster from C&V Cadre. The relevant rule regarding promotion as a Headmaster High School in Haryana State Education School Cadre Group B service (amendment) Rules, 2012 is mentioned as below:-

Rule 9(i)(b)

9 . Recruitment in the service shall be made

(b) In case of Headmaster of High School

(i) 100% by promotion from amongst elementary school headmaster /TGT or

(ii) By transfer or deputation of an official already in service of any state government or Government of India.

Further, Director Secondary Education Department has already considered the promotion case as a regular appointee till the year 1993 as per ESHM seniority list dated 01.04.2016. Moreover, reversion process of juniors from the post of Headmaster High School to ESHM in compliance of orders of Hon'ble High Court dated 22.12.2015 passed in CWP No. 4301 of 2013 titled as Sartaj Singh Dhanda and others vs. State of Haryana and others.


On further examination, it is found that while dealing with the case of Sh. Dinesh Kumar for promotion as High School Headmaster, the then dealing assistant Sh. Rohtash Kumar Sankhla negligently mentioned the date of his promotion to TGT as 30.09.1988 & thus made him eligible for promotion to the post of High School Headmaster. It is matter of fact that only those persons were considered for promotion to the post of High School Headmaster, who were appointed or promoted as TGT on or before 30.09.1988. Sh. Dinesh Kumar was promoted as TGT on 15.01.1996 although no junior person to him was promoted as Sh. Dinesh Kumar has claimed in his legal notice. In this way, Sh. Rohtash Kumar Sankhla, the then dealing assistant committed a grave misconduct by mentioning the date of promotion of Sh. Dinesh Kumar as TGT on 30.09.1988 & thus he who was not entitled for promotion. In this regard, chargesheet has already been served under Rule-7 of Haryana Civil Service (Punishment and Appeal) Rule 2016 upon Sh. Rohtash Kumar Sankhla. Further, Sh. Ranbir Singh branch superintendent and the then Dy. Director, Sh. Joginder Hooda were also charge sheeted under Rule-8 of Haryana Civil Service (Punishment and Appeal) Rules, 2016.

As per the condition mentioned in promotion order para No. 6 stated *"That if information of the candidate has found to be factually incorrect, erroneous or mis-represented, the promotion so granted shall be withdrawn without according any further opportunity"*.

Accordingly, the matter was duly examined and a Show Cause Notice dated 04.11.2020 was issued to Sh. Dinesh Kumar with opportunity to submit any relevant record, if any in the Office. He submitted his reply on 23.11.2020 and the same has been duly considered. On consideration of reply of Sh. Dinesh Kumar, it is observed that Sh. Dinesh Kumar is not entitled to hold the post of High School Headmaster as he was wrongly promoted as High School Headmaster. Secondly, the 129 High School Headmasters regarding whom the applicant mentioned as precedents, have already been issued Show Cause Notice for their reversion to initial post. Therefore, at this stage Sh. Dinesh Kumar is not entitled to remain on the post of High School Headmaster.

Keeping in view, the fact and circumstances, reply of incumbent, documents relied upon and official record, the claim of petitioner in the reply to the legal notice dated 04.11.2020 is hereby rejected being devoid of any merits and Shri Dinesh Kumar [003349] is reverted to his initial post of ESHM with immediate effect.

It is ordered accordingly.

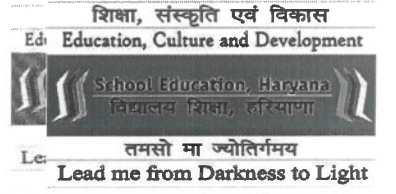

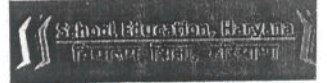
