Whereas Chander Bhan & 69 others had approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition No. 25868 of 2018- Chander Bhan & others versus State of Haryana & others, praying therein for granting of benefit of modified pay scale of Rs. 6500-10500 w.e.f. 01-01-2006. Hearing Ld. Counsel for petitioners, the Hon'ble High Court pleased to issue directions dated 08-10-2018 to the concerned respondents as under:

"At this stage, the present petition is disposed of by giving direction to the respondents to look into the legal notice dated 21.08.2017 (Annexure P-5) and pass appropriate orders as per Haryana Civil Services (Revised Pay) Rules, 2008, which have been amended thereafter. This exercise be completed within a period of six months from the date of receipt of certified copy of this order."

That in compliance of above-said directions of Hon'ble Punjab and Haryana High Court, the legal notice dated 21.08.2017 has been considered. After due consideration of contents, it has been found that all the petitioners are rendering or have rendered service on different cadre of posts (i.e. their cadre are not identical) under School Education Department including two departments, namely, Elementary & Secondary Education Haryana. Hence, the grievances of all the petitioners are not identical.

That it has also been observed that all the petitioners are pre-2006 appointed employees. Their pay has been rightly revised under Rule-7 of Haryana Civil Services (Revised Pay) Rules, 2008 implementing general formula of multiplying the existing pay of the concerned employee on 31-12-2005 or 01-01-2006 with a factor of 1.86. The Rule-8 of H.C.S. (Revised Pay) Rules, 2008 was made applicable on post-2006 appointed employees. Resultantly, on implementation of two different set of rules, junior(s) who are post-2006 appointee got fixed on higher pay than senior in their cadre. An anomaly got revised in pay. The Finance Department Haryana duly considered this anomaly and omitted Section-II of Part-A of H.C.S. (Revised Pay) Rules, 2008 vide order dated 18-08-2009 and further clarified the fixation of pay properly vide order dated 16-12-2010.

That it has also been observed that some seniors who got less pay than their juniors approached the Hon'ble High Court by way of filing writ petitions for getting their pay fixed at par with their juniors, mainly,

in CWP No. 11254 of 2010- Neelam Rani vs State of Haryana & others, decided on 15-05-2013. The Finance Department Haryana considered this judgment dated 15-05-2013 and controversy thereon in detail and issued order dated 21-11-2017 allowing benefit of stepping-up of pay at par with identical junior under Statutory Service as well as Financial Rules. The Hon'ble Punjab & Haryana High Court has already considered this order dated 21.11.2017 in a bunch of writ petitions, mainly in CWP No. 14830 of 2017- Ram Parsad & others versus State of Haryana & others, decided on 20.12.2017.

It has also been observed that in the present legal notice, the petitioners have also not discussed the order dated 04-03-2014 issued by Finance Department Haryana vide which the requisite period for granting of Assured Career Progression (ACP) Pay scale has been reduced from 10/20/30 years to 08/16/24 years on regular satisfactory service. This FD order dated 04-03-2014 has further been impugned by some petitioners praying its application w.e.f. 01-01-2006 but this prayer has already been denied/rejected by the Hon'ble Punjab & Haryana High Court vide its judgment dated 18.03.2017 in bunch cases of 75 writ petitions, mainly in CWP No. 17496 of 2014 - Om Parkash & others versus State of Haryana & others.

That it has also been observed in case of Art & Craft (Drawing) Teachers and PTIs, that this cadre was allowed grade pay of Rs. 3600/-instead of Rs. 4200/- under H.C.S. (Revised Pay) Rules, 2008. Such aggrieved teachers approached the Hon'ble High Court by way of filing civil writ petitions, mainly, CWP No. 9597/2010 and 511/2011, which were allowed on 22-05-2012. The said anomaly in pay was got settled by the Finance Department Haryana vide its order dated 20-08-2009 and letters were issued thereafter. The petitioners have never denied these letters. From these facts, it can be concluded that the grievance of petitioners have already been settled/adjudicated by the Hon'ble High Court, therefore, another claim raised out of H.C.S. (Revised Pay) Rules 2008 or H.C.S. (Assured Career Progression) Rules 2008 is barred under principles of Order -2 Rule-2 of Code of Civil Procedure 1908 and principle of "Constructive Res-judicata".

That it has also been observed that the matter of granting benefit of stepping-up of pay as well as equal work-equal pay has already been considered in detail by the Hon'ble Division Bench of this Court in CWP No. 4563 of 2007- Prem Chand Manchanda & others versus State of Haryana & others, decided on 09-01-2009. After this judgment, the Finance Department Haryana has also issued an Office Memorandum dated 23-06-2009 wherein different situations of equal pay- equal work

and benefit of stepping-up of pay have been defined. It has been observed that while serving these legal notices upon respondents, the petitioners have ignored this judgment as well as office memorandum.

Moreover, the judgment passed by the Hon'ble Apex Court in Chandigarh Administration vs. Naurang Singh – cited as (1997) 4 SCC Page 177 has also been observed wherein the Hon'ble Apex Court has held that principle of 'equal pay for equal work' and stepping up of pay would not apply where higher scale was granted to some persons by an evident mistake. This Hon'ble Court held:

"We are, however, of the opinion that a mistake committed by the Administration cannot furnish a valid or legitimate ground for the Court or the Tribunal to direct the Administration to go on repeating that mistake. proceedings placed before us clearly show that the pay revision of September 19, 1975 was an unscheduled one, effected merely on the basis of a letter written by the Principal of the College. The Administration no doubt could have rectified that mistake. That would have been the most appropriate course but their failure to do so cannot entitle the respondents to say that mistake should form a basis for giving the higher pay scale to them also. The proceedings of the Administration dated 19.8.1982 clearly shows that the said higher pay scale was treated as personal to the then existing incumbents. As stated above that was really the pay scale admissible to the post of Assistants which was a promotion post to storekeepers. Both these posts cannot be given the same pay scale....An evident mistake cannot constitute a valid basis for compelling the administration to keep on repeating that mistake."

That it may also be relevant factor that the Finance Department Haryana has notified the Haryana Civil Services (Revised Pay) Amendment Rules, 2019 vide Notification dated 07.02.2019 vide which anomaly arose under H.C.S. (Revised Pay) Rules, 2008 has been settled down by making these rules applicable w.e.f. 01.01.2006. After due perusal of this notification, it has been found that so far as the pay of the Primary and Elementary Department's Teachers/Masters and Secondary Department's Lecturers, whose scales were modified vide order dated 20.08.2009 by the Finance Department, is concerned, has been fixed in accordance with the rules and instructions and no anomaly has ever occurred therein.

That considering the factual position and circumstances as detailed above, it has been observed that the petitioners have not come to this Hon'ble High Court with clean hands and clean mind. They have concealed the above-said finance department orders and judgments passed by the Hon'ble Courts and tried to get un-due and un-advantageous benefits. The petitioners are not entitled to take any advantage of mistake of others under provisions of Article-14 of the Constitution of India as principles therein are positive in nature and cannot be implied negatively. Consequently, the legal notice dated 21.08.2017 so far as Lecturer is concerned has been found devoid of any merits; hence, the relief sought herein deserves to be denied and hereby rejected in the interest of justice.
