



Whereas, the petitioner has filed the CWP No. 8783 of 2021 titled as Surinder Singh Vs State of Haryana and another, praying therein for the issuance of a writ in the nature of Mandamus directing the respondent no. 2 to decide the claim of the petitioner contained in representation dated 04-10-2020 (P-5) and dated 12-10-2020 (P-6) for fixation of the seniority of the petitioner in physically handicapped (Ortho category) at proper place with all consequential benefits like promotion to next higher post, pay scale etc.

The above mentioned CWP came up for hearing on 23-04-2021 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 23-04-2021 is as under:-

"In view of the above and without commenting upon the merits of the case, the writ petition is disposed of with a direction to respondent No.2 - competent authority to look into the grievance of the petitioner as made in the representations (P5 & P6) qua fixation of seniority of the petitioner and decide his claim as expeditiously as possible maximum within two months from the date of receipt of certified copy of this order."

In compliance of the above said direction of the Hon'ble High Court, the representations dated 04.10.2020 & 12.10.2020 (Annexure P-5 & P-6) of the petitioner were minutely examined by the department and found that since 1.1.1996, department has promoted 1001 clerks to the post of Assistant on various dates.

disabilities. Further, it is germane to mention here that persons with disabilities are further divided into 3 sub categories i.e. Blindness, Hearing impairment and Loco-motor disability. As per the instructions no. 22/10-2013- 1GS -III dated 15.7.2014 issued by the Chief Secretary Haryana office, 3% of vacancies in case of direct recruitment to group A, B, C and D posts are reserved horizontally for persons with disabilities. Out of which 1% each is reserved for persons suffering from (i) Blindness or low vision (ii) Hearing impairment and (iii) Loco-motor disabilities or Cerebral palsy in the posts identified for each disability. As per instructions no. 22/10/2013-1GS-III Dated- 17/19.04.2017 issued by the General Administration Department, general services branch, office of Chief Secretary to Govt. of Haryana, grant of reservation has been made applicable in the case of promotion also vide notification dated 27.01.2017 issued vide Endorsement No. 130-SW(4) 2017 dated 03.02.2017.

Out of above cited 30 seats reserved for the persons with disabilities, since 1.1.1996, 10 seats are available in the category of Loco-motor disability, in accordance with the instructions dated 15.7.2014 read with 19.04.2017. Further, as per the seniority list of the Department, petitioner stands at seniority no. 13 in the combined list of handicapped employees and at seniority no. 12 of the ortho category of Loco-motor disabilities. As far as his contention with regard to mentioning of his name at Sr. No. 15 is concerned, it is clarified here that the same is as per the old tentative list. Whereas the petitioner in his representation dated 12.10.2020 has mentioned the name of Sh. Nihal Singh and Sh. Pritam Singh etc. in this regard it is clarified that they are junior to the petitioner, therefore, prima facie the petitioner has no cause of action to challenge the same.

Further, their seniority is fixed after determining the various factors like the date of regular appointment and if a person is appointed as class-IV then the availability of promotional post in the district etc.

Whereas, the contention with regard to addition of names of retired persons is concerned, it is further clarified that the list notionally maintained the situation as on 01.01.1996, therefore, the persons who were in seniority on that date were added in the list in toto.

Whereas, the total seats under the Loco-motor disability category are 10. Thus the claim of the petitioner is not tenable and not acceptable at this stage. It is further clarified here that whenever the turn of the petitioner for promotion under person with disability category i.e. Loco-motor disability will come, department will consider the case of the petitioner accordingly.

Hence, the claim of the petitioner stands rejected.

She is hereby posted in the offices/institutions mentioned as under against vacancy and is posted at place mentioned against her name with immediate effect on the terms and condition mentioned below:-

Note:-1. His appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.

2. He is also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

- 1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
- 2. If at any stage he desires to resign his posts he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his services for the reason other than that mentioned in clause (I) above.
- 3. He will be required to take the prescribed oath of allegiance to the constitution of India.

4. In case he is married, he will produce the following certificate to his/her Head of office:-

"That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.

- 5. In case he is unmarried, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
- 6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
- 7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
- 8. He will be required to produce the original Educational documents and date of birth certificate before joining his duties of the said post.
- 9. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining his duties.
- 10. No TA/DA and joining time will be paid to him for joining this post.
- 11. He will remain on probation for a period of two years, from the date of his joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing his performance during the period of probation, his work conduct will be taken into consideration. If his work and conduct during this period is not found satisfactory his services will be terminated without any notice.
- 12. His appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
- 13. That in the matters, not specifically mentioned in this Communication, he shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. He shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" and amended in the year 2013.
- 14. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
- 15. That if he got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be

false or forged or fraudulent, he would be liable for termination of his services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.

Whereas the petitioners have filed CWP No. 15680 of 2020 titled as Shankar Dayal Sharma and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari/mandamus quashing list dated 07.03.2020 and transfer list/order dated 14.08.2020 qua the petitioners. Further petitioners prayed that the respondents be directed to carry out the transfer process afresh.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 28.01.2021 and the same was disposed of with the following orders:-

"Ld. State counse! has raised no objection in case the innocuous prayer of the petitioners is accepted.

In view of the agreed stand taken by both the sides, this writ petition is disposed of with liberty to the petitioners to make a representation to the competent authority within the period of two weeks from today and the same shall be considered and decided expeditiously in accordance with law preferably within two weeks thereafter in case there is no legal impediment

It is clarified that in case the desired representation is not decided within the stipulated time the same shall be considered as disobedience of the order of this court.

det

It is also clarified that interim order aated 07.09.2020 will continue till the representation is decided in accordance with law.

Since main writ petition stands disposed off, thereof, the pending applications if any shall also disposed off."

In compliance of the abovementioned orders of the Hon'ble High Court, the claim of the petitioners was examined & it was found that the petitioners were transferred in accordance with the Transfer Policy as petitioner no. 1 was voluntary participant & petitioner nos 2, 3, 4 & 5 who completed the required tenure of five years in their particular zone, were compulsory participants of the Online Transfer Policy of Ministerial Staff 2020. All the petitioners opted stations according to their suitability and choices. But due to low merit scores obtained by the petitioner nos 1,2,4 &5 respectively could not get station opted by them and therefore transferred in 'Anywhere in the State' category. Such preferred stations were give/allocated to the employees who have scored higher marks than the petitioners. Whereas petitioner no. 3 was transferred at the station preferred by him.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020. Thereupon, transfers were made under this policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State, in a fair & transparent manner and to maximize job satisfaction amongst employees. Under this policy all government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/ institutes across the zones available to him/her. He/She is free to give preferences in order of his/her suitability. So that chances of being



posted in 'Anywhere in the State' category may be decreased. Further according to the Para No. 4 sub clause V (b) of the Transfer Policy of Ministrial Staff 2020, the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-

iv) Rationalization and Blocking of posts: To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.

The posts with less workload were blocked by the department, because stations with over workload require more employees for smooth working in the department. So, for maximum utilization of the potential of an employee at over workloaded station and to avoid misappropriate concentration of employee at particular station, the blocking of posts was done by the process of rationalization in the public interest.

Moreover, the stations were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department. Thus for the process of even distribution of clerks in the State the process of rationalization was done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas as per the provisions of the policy, allotment of a vacant seat/stations to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80 points. However, it is worthwhile to mention here that the categories like woman, widows, widowers, differently-abled persons, employees with serious ailments, a privilege of maximum 20 points can be availed by the employees. Therefore, the employees were asked to opt maximum stations as per their choice suitable to them so that their chances of getting posted on an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by him/her, he/she shall be transferred under 'Anywhere in the State' category. In case, an employee is to be transferred on an un-opted station in "Anywhere" in state" category then Computer Programme/Software, instead of sending them at a distant place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Whereas, according to general principles of the policy, every employee is responsible for the accuracy and regular updation of data in MIS

in respect of his/her credentials, otherwise the department is at liberty to transfer him anywhere category in the state. Employees are liable to be transferred under this policy in any zone or anywhere in the State, in public interest, on completion of prescribed tenure.

Whereas, the contention with regard to the Right of Education is concerned, the Government of Haryana enacted the Haryana Right of Children to Free and Compulsory Education Rules, 2011 dated 03.06.2011 for the teachers and the same is not applicable to clerks. Thus, the clerks do not fall under the ambit of Haryana Right of Children to Free and Compulsory Education Rules, 2011. Moreover, most of the clerical work with regard to the elementary schools is done from the office of Block Elementary Education office. As such, there is no clerical workload in elementary schools and most of the posts in the elementary schools were blocked by the department due to less workload and the same was done in a fair manner and no teacher was allocated the clerical work till date.
