Case No. CD-163/2021, Sh. Bansi Lal Jhorar, State President, Viklang Sangh Umang V/s Director Secondary Education and Ors – Guidelines regarding updation of MIS Portal of Persons with Disabilities Haryana, Social Justice & Empowerment Department, Panchkula.

Reference the recommendations of Hon'ble State Commissioner for the Persons with Disabilities Haryana, Social Justice & Empowerment Department, Panchkula dated 16.06.2021 on the subject noted above.

Sh. Bansi Lal Jhorar, State President, Viklang Sangh Umang has filed Case No. CD-163/2021 in the court of Hon'ble State Commissioner for the Persons with Disabilities Haryana, Social Justice and Empowerment Department, Panchkula regarding updation of data on MIS Portal.

This case was listed for hearing before the Hon'ble State Commissioner for Persons with Disabilities Haryana on 16.06.2021 and State Commission has made the following recommendation:-

- i) Order all the DDOs to check the disability certificates of differently abled employees working under their supervision as already uploaded and approved.
- ii) Order to all the DDOs/Head of the Institution that as the date of validity is not mentioned on permanent disability certificates hence the same be allowed to be uploaded and approved, however such employee should mention date of validity as of date of superannuation.
- iii) Order to all the DDOs/Head of the institution to ensure that latest disability certificate in case of temporary disability is uploaded and verified specifically mentioning the date of validity of such certificates.
- iv) The respondents shall time and again ensure the compliance of these recommendations through District Education Officers/District Elementary Education Officers.

You are, therefore, directed to instruct all the Head of Institutions under your control to abide by the recommendations of the Hon'ble State Commissioner for the Persons with Disabilities Haryana in letter and spirit.
