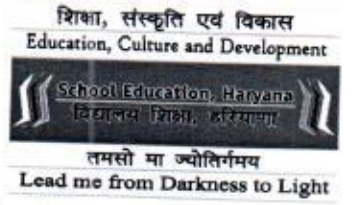

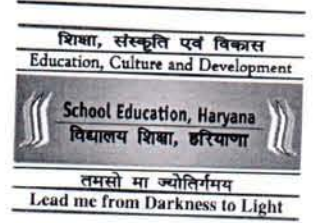

1. The ACR record of 69 officials were found complete. But in 29 cases one, two or three year's ACR of ESHM/TGTs are not available and the rest of service record is good or very good. The promotion orders of such ESHMs/TGTs will be issued on the basis of available records but in the eventuality, if the integrity of promoted candidate is found to be doubtful, the incumbent(s) shall be reverted without issuing any notice.

As per the seniority list dated 01.04.2016 of ESHM, the Officials at seniority No. 74, 454, 456 and 457 will be entitled for the benefit of promotion notionally w.e.f. 21.07.2020 and actually from date of joining and the employees at seniority No. 823 to 924 will be entitled for the benefit of promotion notionally w.e.f. 15.03.2021 and actually from date of joining and the officials at seniority No. 1931 to 2000 will be entitled for promotion with immediate effect.

2. The record of 22 ESHMs/TGTs are still incomplete and not received so far. Hence, the juniors to them have been considered for promotion. In this context, concerned District Education Officers/ District Elementary Education Officers were directed vide letter dated 13.03.2020, 11.06.2020, 22.10.2020, 22.12.2020, 18.02.2021, 20.02.2021, 26.02.2021 and 30.07.2021. But the record of 22 ESHMs/TGTs are still awaited.
3. That in case of 4 official at seniority No. 1101, 1961, 1984 and 1995 are working as PGT. Therefore, they do not fulfill the condition as per Service Rule 2012. Hence, they cannot be considered for promotion because there is no provision of promotion in service Rule, 2012.
4. That in case of 3 officials at seniority No. 1274, 1641 and 1829 are not being promoted due to the reason as the disciplinary proceeding/ Court case (FIR against Sn. No. 1829) is pending.
5. That in cases of 11 officials, at seniority No. 453, 1052, 1054, 1066, 1069, 1071, 1123, 1134, 1498, 1744 and 1994, who has forgone their promotion due to domestic reason or in case of any other contingency, making him/her ineligible, then the next seniority number will automatically be considered for promotion to the post of High

R

School Headmaster. The officer who will opt to forgo his/her promotion, shall not be considered for promotion until next one year.

6. Three weeks training for Account and Administration Work is necessary for promotion as per Haryana State Education School Cadre (Group B) Service Rule, 2012. But almost ESHMs/TGTs, who have been considered for promotion have not availed this training. Thus, condition shall be mentioned in promotion orders that such officers on promotion as High School Headmaster shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana and if any officer fails to complete the training within a period of one year, then promotion order of the candidate shall be withdrawn.
7. That these 98 officials shall join their duty within 15 days, otherwise their promotion order would be treated as withdrawn.
8. That in case 98 officials shall not join their duty in prescribed time the next person in the seniority list will be considered for promotion.
9. That, the place of posting will be allotted on the basis of online teacher transfer policy 2016/17 and as amended time to time.
10. That, there is no provision of reservation in the promotion of class-II from Class-III.
11. If any official is found senior to the above official(s) at any stage due to re-fixation of his/her seniority in his/her feeder cadre, respective junior promotee(s) shall be reverted without giving any notice.
12. If at any stage it is found that any official has been promoted in these orders inadvertently who was otherwise actually not eligible for promotion he/ she will be reverted to his/her feeder cadre (original post) without any notice and disciplinary action will be initiated against him/her.
13. If the seniority of any official is fixed later on in accordance with the instructions contained in Haryana Govt. letter No. 22/73/92-3GS-III, dated 14.10.1999, he/she will be reverted without any notice.
14. That promote(s) will remain on probation for a period of one year as per rule 27 of Haryana Civil Service (General) Rule, 2016.
15. The promote (s) will report to the DEO concerned for scrutiny of the documents and they will work in their present school till further orders.
16. This promotion order is subject to final outcome of the order dated 22.06.2020 passed in decision of CWP No. 8466 of 2020 titled as Haryana School Lecturer Association Vs. State of Haryana, CWP No. 27565 of 2019 and other connected court cases.
17. The District Education Officer concerned shall personally ensure the following:-
 - (a) That these promotions are subject to the condition that there is no adverse remark pertaining to integrity in the ACRs of the newly promoted Headmasters during the last ten years.



- (b) Their 70% or more service record during the last ten years must be satisfactory. The grading in the ACR of the promotee for the year last three years is good or better than that.
- (c) No complaint/ enquiry is pending against them.
- (d) That the concerned District Education Officers directed to intimate the Directorate, if any complaint/enquiry under Rule-7 and 8 of the Haryana Civil Services, Rules-2016 is pending against promotes Headmasters.
