Dated, Chandigarh, the 18/08/2021

Whereas, Sh. Anup Singh filed writ petition no. 14046 of 2021 before the Hon'ble Punjab & Haryana High Court, Chandigarh challenging the Department order dated 22.07.2021 qua his transfer/posting from District Nuh (Mewat) to District Ambala. The Hon'ble High Court on dated 29.07.2021 passed the following interim orders:-

"Inter alia submits that the petitioner is due to retire on 31.05.2022 and has been transferred within 7 months of his earlier posting at Nuh as District Elementary Education Officer, vide the impugned order dated 22.07.2021 (Annexure P-5). It is, thus, submitted that there is a violation as such of the guidelines issued by the State dated 19.11.1998 (Annexure P-7).

Notice of motion.

Mr. Gaurav Jindal, Addl. AG, Haryana accepts notice on behalf of the respondents and has placed on record communication dated 29.07.2021 addressed to the Advocate General on behalf of respondent No.2. It is pointed out that the petitioner has already relinquished his charge on 27.07.2021 and the fact that the petitioner has also filed an application for reconsideration dated 26.07.2021 which is also appended with the present petition as Annexure P-9. It has also been brought to the notice of the Court that the petitioner has been posted for the last 6 years and 7 months in Mewat and there are various complaints against him as such.

Keeping in view the above, this Court is of the opinion that respondent No.2 firstly should take a decision on the representation of the petitioner dated 26.07.2021 (Annexure P-9) as such by passing a reasoned order.

Needful be done on or before the next date of hearing i.e. 26.08.2021."


Meanwhile, Sh. Anup Singh without waiting for competent authority's decision, filed Letter Patent Appeal No. 650 of 2021 before the Hon'ble Division Bench against the above said order wherein, the Hon'ble Division Bench on dated 05.08.2021, dismissed his appeal with following orders:-

"Appellant has posed a challenge to his transfer from District Nuh Mewat to District Ambala. His only ground for challenge of transfer is that appellant has about 9 months to retire. According to him, as per the Government Policy, he ought not to have been transferred at this stage. We find no merit in this plea. The Transfer Policies are directory in nature and cannot always give a right to seek a mandamus on that basis. In our considered view the order dated 29.07.2021 passed by learned Single Judge calls for no interference. Present appeal is hereby dismissed."

of right. He can be transferred anywhere in public interest. Moreover, in the present matter, the incumbent is facing enquiries in which serious allegations.

Keeping in view of the above said complaints, allegations leveled against him and documents on record, there is no merit in the representation made by him. Therefore, the representation of the incumbent is not tenable in the interest of subordinate staff as well as in the interest of department. Hence, the claim of Sh. Anup Singh as prayed in his representation dated 26.07.2021 is hereby, rejected being devoid of merits.

It is ordered accordingly.

ORDER No. 13/33-2020 PGT-I (3)

Dated, Chandigarh, the -16/08/2021

Whereas, Sh. Anil Kumar Gupta and others have filed CWP No. 3292 of 2020 before the Hon'ble Punjab and Haryana High Court to consider their claim for promotion as Lecturer/ PGT Mathematics from the date of their junior promoted.

This case came up for hearing on 06.02.2020 and the Hon'ble High Court was pleased to dispose of the above-mentioned CWP on 06.02.2020 with the direction:-

"Petitioners are seeking issuance of directions to the respondents to consider their claim for promotion to the post of Lecturer/PGT (Math) from the date junior to the petitioner i.e. respondent No. 3 has been promoted.

Learned counsel for the petitioners has given detail at page No. 8 of the petition to show that petitioners are senior to respondent No. 3 but despite this fact petitioners were not considered for promotion w.e.f 18.01.1996.

Issue notice of motion.

On asking of the Court, Mr. Kiran Pal Singh, AAG, Haryana accepts notice on behalf of the respondent-State.

Without commenting upon merits of the case, this petition at this stage is being disposed of by giving direction to the respondent No. 1 to treat this petition as representation of the petitioners and consider their case for promotion as per seniority list and pass appropriate orders, within a period of six months from the date of receipt of certified copy of this order."

In non-compliance of the order dated 06.02.2020, the he filed contempt case No. 2300 of 2020 titled as Anil Kumar Gupta and others Vs. Mahavir Singh. The said COCP came up for hearing on 08.01.2021 and on that day, the Hon'ble High Court was pleased to dispose of the above-mentioned COCP with the following direction:-

"the contempt petition is disposed of as not pressed, at this stage, while directing the Director, Secondary Education Department, Haryana, to decide the claim of the petitioners for promotion as per seniority list in terms of order dated 06.02.2020 in CWP No. 3239 of 2020 within 04 weeks from today and to convey the decision on the same to the petitioners within 10 days, thereafter."

Subsequently, for alleged non-compliance of the order dated 08.01.2021, the petitioners have again filed another COCP No. 723 of 2021.

It is germane to mention here that in compliance of the order/directions of the Hon'ble Punjab and Haryana High Court dated 06.02.2020 and 08.01.2021, the petition filed by the petitioners has been examined wherein the petitioners have claimed that they should be promoted w.e.f. 18.01.1996 instead of 11.11.1999 on the ground that respondent No. 3 i.e. Sh. Dharamvir Singh, who was junior to the petitioners has been promoted w.e.f. 18.01.1996.


Whereas, earlier under Service Rules, 1955, a separate promotion quota was provided for Male and Female employees. One Smt. Sujita was promoted w.e.f. 18.01.1996 against a vacancy under the Female quota.

Whereas, Sh. Dharamvir Singh and Sh. Jitender Kumar were given ante-dated promotion on the ground that Smt. Sujita was junior to them, despite the fact that Smt. Sujita was promoted under the Female quota and Sh. Dharamvir Singh and Sh. Jitender Kumar were offered promotion under the Male quota as per their seniority.

Whereas, a Show Cause Notice has been issued to Sh. Dharamvir Singh and Sh. Jitender Kumar vide order No. 15/142-2017 PGT-I (3) dated 13.07.2021 and 15/29-2020 PGT-I (3) dated 13.07.2021 respectively for cancellation of their ante-dated promotion as their promotion was done giving wrong facts of Smt. Sujita and Smt. Kanta Devi, who were promoted under Female quota as per Service Rules, 1955.

Therefore, keeping in view the above said facts and documents on record, the promotion of the petitioners vide order No. 15/166-1999E-IV (5) dated 11.11.1999 is as per their seniority. Consequently, the claim of the below mentioned incumbents for ante-dated promotion is hereby rejected being devoid of merits.

It is ordered accordingly.

Whereas, Sh. Anup Singh filed writ petition no. 14046 of 2021 before the Hon'ble Punjab & Haryana High Court, Chandigarh challenging the Department order dated 22.07.2021 qua his transfer/posting from District Nuh (Mewat) to District Ambala. The Hon'ble High Court on dated 29.07.2021 passed the following interim orders:-

"Inter alia submits that the petitioner is due to retire on 31.05.2022 and has been transferred within 7 months of his earlier posting at Nuh as District Elementary Education Officer, vide the impugned order dated 22.07.2021 (Annexure P-5). It is, thus, submitted that there is a violation as such of the guidelines issued by the State dated 19.11.1998 (Annexure P-7).

Notice of motion.

Mr. Gaurav Jindal, Addl. AG, Haryana accepts notice on behalf of the respondents and has placed on record communication dated 29.07.2021 addressed to the Advocate General on behalf of respondent No.2. It is pointed out that the petitioner has already relinquished his charge on 27.07.2021 and the fact that the petitioner has also filed an application for reconsideration dated 26.07.2021 which is also appended with the present petition as Annexure P-9. It has also been brought to the notice of the Court that the petitioner has been posted for the last 6 years and 7 months in Mewat and there are various complaints against him as such.

Keeping in view the above, this Court is of the opinion that respondent No.2 firstly should take a decision on the representation of the petitioner dated 26.07.2021 (Annexure P-9) as such by passing a reasoned order.

Needful be done on or before the next date of hearing i.e. 26.08.2021."


Meanwhile, Sh. Anup Singh without waiting for competent authority's decision, filed Letter Patent Appeal No. 650 of 2021 before the Hon'ble Division Bench against the above said order wherein, the Hon'ble Division Bench on dated 05.08.2021, dismissed his appeal with following orders:-

"Appellant has posed a challenge to his transfer from District Nuh Mewat to District Ambala. His only ground for challenge of transfer is that appellant has about 9 months to retire. According to him, as per the Government Policy, he ought not to have been transferred at this stage. We find no merit in this plea. The Transfer Policies are directory in nature and cannot always give a right to seek a mandamus on that basis. In our considered view the order dated 29.07.2021 passed by learned Single Judge calls for no interference. Present appeal is hereby dismissed."

of right. He can be transferred anywhere in public interest. Moreover, in the present matter, the incumbent is facing enquiries in which serious allegations.

Keeping in view of the above said complaints, allegations leveled against him and documents on record, there is no merit in the representation made by him. Therefore, the representation of the incumbent is not tenable in the interest of subordinate staff as well as in the interest of department. Hence, the claim of Sh. Anup Singh as prayed in his representation dated 26.07.2021 is hereby, rejected being devoid of merits.

It is ordered accordingly.
