Whereas, the petitioner namely Kamla has filed the CWP No. 18132 of 2020 titled as Kamla Vs State of Haryana & others, praying therein for issuance of a writ in the nature of mandamus directing the respondents-department to compute the contract period from 01.04.1993 to 31.12.2012 as qualifying service for pension and pensionary benefits while considering the case of the petitioner under OLD PENSION SCHEME.

The above-said Civil Writ Petition came up for hearing on 30.10.2020 before the Hon'ble High Court & the same was disposed of by the Hon'ble High Court with the following orders:-

*"The petition is disposed of with a direction to respondent No. 3 to consider and decide the legal Notice (Annexure P-9) in the light of the afore noted judgments and other relevant material in accordance with law with-in a period of four months from the date of receipt of certified copy of this order."*

In-compliance to the aforesaid directions of the Hon'ble High Court, the legal notice dated 16.03.2020 of the petitioner was duly examined and it has been found that the petitioner was initially engaged as Part-time class IV on 01.04.1993 through direct recruitment method (i.e. without employment Exchange) in Govt. Girls Primary School, Barwa District Bhiwani against non-sanctioned post for a short span of 01:30 Hours daily (w.e.f. 01.04.1993). However, after working for 01:30 Hours daily, the petitioner was free to do any work/job.

Whereas, the Education Department has its own regularization policy dated 30.12.1998/25.02.1999 and thereafter superseded by the



new regularization policy of dated 11.11.2003 (herein after called the department specific policy) instead of policy dated 01.10.2003 (General Policy). Further Services of the petitioner were regularized w. e. f. 31.12.2012, as per her seniority and eligibility as and when regular sanction post was available, under the regularization policy of 11.11.2003 (department specific policy), wherein the seniority list of part time class IV employees was made at District level and accordingly the petitioner stands at Seniority Number 215. So, the petitioner is entitled to get the benefit as regular employee w.e.f. 31.12.2012 onwards and not prior to that.

Whereas the policy dated 01.10.2003 (General Policy) was formulated by the State Government for regularization of Adhoc/contractual and daily wages employees who had been engaged before 31.01.1996 vide notification dated GSR24/Const./article309/2003 dated 01.10.2003. Thus the case of the petitioner is not covered under the regularization policy dated 01.10.2003 (General Policy), as the same is applicable to Adhoc/work-charge & Daily wage employees and not to the matter Part-time employees whereas the employees working under the Education Department are regularized under the department specific policy. Further as per regularisation policy dated 30.12.1998/25.02.1999, only those part time class IV employees are entitled to be regularized who have requisite experience mentioned in the policy on sanctioned post. But, the petitioner does not fulfil the condition of the policy dated 30.12.1998/25.02.1999 being working as part time class IV employee against non sanctioned post. In this manner, the claim of the petitioner for the regularization under the policy 30.12.1998/25.02.1999 or 01.10.2003 is not tenable as per law.

Whereas, as per State Govt. notification dated 18.08.2008, NEW PENSION SCHEME came-in-to force, which is applicable to the employees, who has joined as regular employee on or after 01.01.2006 and the petitioner Smt. Kamla had joined as regular employee on dated 31.12.2012. Therefore, on the basis of "NEW PENSION SCHEME", the PRAN Number was allotted to her and she had also deposited her share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable to her.

Further, Rules 3.17 - A(a) & 3.17 A(g) (iii) of Civil Service Rules Volume-II the service period rendered as "PART TIME" employee cannot be computed for pension & pensionary benefits. Relevant portion of the same is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (i) Such service is followed by regular employment.
- (ii) There is no interruption in the two or more spells of services or the interruptions fall with-in condonable limits: and
- (iii) Such services is a whole time employment and not part-time or portion of day.


In-view of the above-mentioned facts, the case of the petitioner cannot be considered under OLD PENSION SCHEME as the petitioner was entitled for regularization from 31.12.2012, therefore she is entitled to get the benefits of NEW PENSION SCHEME which was prevalent at the time of regularization of the petitioner and accordingly, the benefits of NEW PENSION SCHEME have already been granted/ released to the petitioner.

Further, for the purpose of getting benefits under the OLD PENSION SCHEME the person has to serve as a regular employee within the

prevalence of OLD PENSION SCHEME and the same is discontinued from 1-1-2006 onwards and the petitioner was regularized after the said date. Therefore, she is not entitled to get the benefits of OLD PENSION SCHEME.

Whereas, LPA No. 1892 of 2019 in CWP No. 1048 of 2016 is pending for adjudication before the Hon'ble High Court of Punjab and Haryana at Chandigarh and the same is fixed for 24.08.2021. So, the claim of the petitioner demanded through legal notice dated 16.03.2020 is hereby rejected to the extent of regularization under the Policy of 01.10.2003 or 30.12.1998/25.02.1999. Further considering the case of the petitioner under old pension scheme is kept pending till final adjudication of LPA No. 1892 of 2019 in CWP No. 1048 of 2016. As and when decision in LPA No. 1892 of 2019 in CWP No. 1048 of 2016 will come, the department will act accordingly.

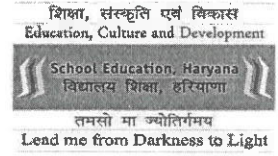

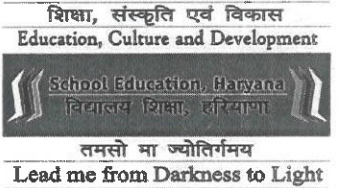

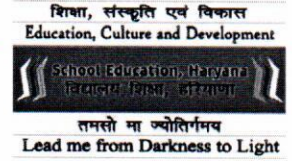
