Subject: - Guidance for principal promoted on 04.08.2021 and retired while awaiting posting.

Kindly refer to this office order no. 4/4-2021 HRG-I(1) dated 06.08.2021 and 10.08.2021 on the subject cited above.

In pursuance with order dated 02.07.2021 passed in CM-6745-CWP2021 in CWP No 19403 of 2019 titled as Baljit Singh V/s State of Haryana, the cases for promotion amongst Headmasters from seniority no. 1307 to 1480 (as stood on 01.06.2015) and Post Graduate teachers from seniority no. 1646 to 2800 (as stood on 08.07.2019) were invited in pursuance with Haryana State Education School Cadre,(Group B) Service Rules, 2012 amended in 2014 subject to final outcome of aforementioned writ petition. Thereafter, promotion orders of Principals were issued on 04.08.2021 .

It is relevant to mention here that these newly promoted officers were allowed to join in their respective DEOs and you were directed to allow joining of these newly promoted officer in your office and draw salary of these officers against the vacant post of Principal available in your district. It is worth to mention here that transfer drive has not attained maturity till date and some officers have retired on 31.08.2021.

In this regard, you are directed that lien of newly promoted principals retired during the pendency of transfer drive may be shifted against the vacant posts in the your district and pension case/retirement orders be processed from such school so that such retiree(s) may not face any hardship. It is made clear that this letter is restricted to the retired principals only i.e. principal retired after promotion order dated 04.08.2021 without posting.
