**Order No. 13/69-2020 HRME-I (6) Dated, Panchkula, 2/9/2021**

Whereas, the petitioner namely Sh. Satyavir and others had filed the CWP No. 18568 of 2019 titled as Satyavir & others Vs State of Haryana & others, praying therein for the issuance of a writ in the nature of Mandamus directing the respondents to consider the case of petitioners and to decide the legal notice dated 7.1.2019 (P-5) by passing a speaking order within a stipulated period.

The above mentioned Civil Writ Petition was came up for adjudication before the Hon'ble High Court of Punjab & Haryana at Chandigarh on 18.10.2019 and the same was disposed of by passing the following orders:-

**"In view of statement made by learned counsel for the petitioner and without going into merit of case or commenting thereon, present writ petition is disposed of with a direction to respondent No.2 to decide the legal notice dated 07.01.2019, (Annexure P-5) in terms of order dated 10.01.2017 and 04.09.2014, Annexure P-7 (collectively) by passing a well reasoned and speaking order within a period of two months from the date of receipt of certified copy of this order.**

**In case, legal notice is not decided within aforementioned specified time, there shall be costs of Rs. 25,000/- to be paid by the concerned officer to the petitioners".**

In compliance of the above said orders of the Hon'ble High Court, the case record and legal notice dated 07.01.2019 of the petitioners was minutely examined with the help of committee made at district level headed by concerned District Education Officer, Narnaul and it has been found that the petitioners were engaged as

Further the petitioners were regularized as per regularization policy dated 11.11.2003 according to their eligibility as well as their seniority Nos. in the seniority list of 2003, prepared at District level.

As per the record available with concerned District Education Officer i.e. Narnaul, no junior to the petitioners has been regularized before the petitioners in the District Narnaul. Further, the example of employees quoted by the petitioners in the writ petition belongs to District Panipat.

Whereas, the petitioners quoted the example of CWP No. 14131 of 2015 titled as Mukesh Kumar and others Vs State of Haryana and others and CWP No. 18296 of 2014 titled as Sanjay and others Vs State of Haryana and others who belongs to other Districts i.e. Hisar and Panipat respectively. Therefore, the example quoted by the petitioners is not tenable, being the seniority of separate District, because each and every district has its own seniority. As per regularization policy dated 11.11.2003, **the District Level common seniority list of part time Class-IV employees shall act only as a**

reference point for sponsoring the names of the senior most persons for regularization against the regular sanctioned Class-IV posts in the field offices/schools of the Education Department. The cadre of the Class-IV employees will not become a district cadre simply because such a district level common seniority list has been prepared.

There were some discrepancies in the documents of some petitioners, therefore they are regularized after clearance of the discrepancies in a fair and just manner.

Therefore, as per the above facts, the claim sought by the petitioners in their legal notice dated 7.1.2019 is not tenable.

Keeping in view of the above facts and circumstances of the case, the claim of the petitioners is not tenable and hence demand through legal notice dated 07.01.2019 is rejected.

I, order accordingly.



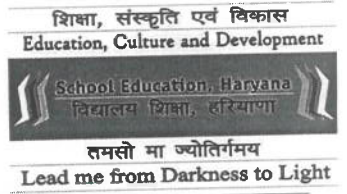

Whereas, Shri Muni Ram [011087], the then Principal, Government Senior Secondary School, Kadipur [774] (Gurugram) [now posted at GGSSS Badli [3225], Jhajjar] was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 19.06.2020/24.06.2020 and the following allegation was leveled against him:-

**"That Smt Saroj Yadav, Lecturer made a complaint dated 28.07.2017 alleging that Shri Muni Ram, Principal had sexually harassed her. In this regard, the District Education Officer, Gurugram was directed on 10.08.2017 to submit report on the said complaint. The District Education Officer, Gurugram submitted its report vide letter no. Complaint/2017/601 dated 06.09.2017 while enclosing the enquiry report dated 26.07.2016 conducted by the Local Complaints Committee Gurugram constituted under the Sexual Harassment of Women at Workplace Act, 2013 and FIR No. 161 dated 11.08.2016. As per said report dated 26.07.2016, he i.e. Sh. Muni Ram was found guilty and the said committee vide its report dated 26.07.2016 recommended to pay compensation of Rs. 50,000/- from the pay of Muni Ram to Smt. Saroj Kumari as per provisions of Sexual Harassment of Women at Workplace Act, 2013. Further vide said report it was also recommended to suspend him i.e. Sh. Muni Ram with immediate effect and to reinstate Smt. Saroj Kumari. Apart, FIR NO. 161 dated 11.08.2016 under sections 354(A)(I), 506 of Indian Penal Code, 1860, was also found to be registered against him i.e. Shri Muni Ram in Women Police Station, Gurugram. As such, he i.e. Sh. Muni Ram had defamed the department as well as such reputed profession of teaching by his such acts".**

The delinquent submitted his reply dated 30.06.2020 to the charge sheet and denied the allegations leveled against him. The reply of the delinquent was not found satisfactory. Consequently, Shri O P Langyan, IAS (Retd) was appointed Inquiry Officer on 06.08.2020 to conduct regular departmental enquiry. Inquiry Officer submitted his report dated 14.09.2020 wherein charges were found proved against him. In this context, the operative part of findings of the Inquiry Officer is reproduced as under:-

"I have gone through the statements of the witnesses of the Department and perused the document submitted by the department with regard to the enquiry under reference. I have also perused the statement and documents submitted by the delinquent. It is quite clear that FIR No. 161 dated 11.08.2016 has been registered against the delinquent and the delinquent is on bail. Although the delinquent is an accused but he cannot be called a convict unless the verdict of the Court is given. It is a fact that FIR has been registered against him and he has admitted this fact, therefore, charge levelled against the delinquent is proved".

Thereafter, the findings of the Inquiry Officer were conveyed to the charged officer on 08.10.2020/12.10.2020 under rule 7(C)(I) of Haryana Civil Services (Punishment & Appeal) Rules, 2016 awarding opportunity of 30 days to make representation on the findings of I.O. Consequently, due to spread of Nobel COVID-19 Pandemic, an opportunity of personal hearing was granted to the charged officer thorough video conference on 26.02.2021. During the course of hearing, Shri Muni Ram reiterated the same facts as



mentioned in his replies. The delinquent officer further stated that the allegations of sexual harassment against him by the said woman lecturer were due to personal vendetta and based on the false & frivolous facts. He further prayed that in the interest of justice, the said charge sheet be dropped against him

Keeping in view above said facts, reply of delinquent officer inquiry report and the documents on record and considering a criminal case based on FIR no. 161 dated 11.08.2016 under section 354 and 506 of Indian Penal Code, 1860, is still pending in the court of Ld Chief Judicial Magistrate, Gurugram, the punishing authority ordered to keep the disciplinary proceedings 'Sine Die' for final disposal until the outcome of the above said criminal case against Shri Muni Ram (011087) by passing the order dated 26.03.2021.

Aggrieved of the order dated 26.03.2021, the delinquent made representation dated nil before Hon'ble Education Minister and prayed for necessary action and promotion to the post of Block Education Officer. Thereafter, the delinquent was heard by Hon'ble Education Minister on 09.06.2021 and ordered that present case is in pre-mature stage in the Hon'ble Court which still not decided till now and hence, the present charge sheet is dated 24.06.2020 is dropped subject to final outcome of the decision of the Hon'ble Court.

It is ordered accordingly.

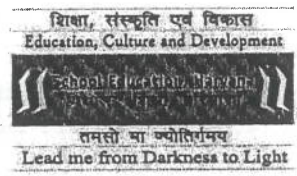

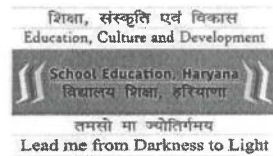

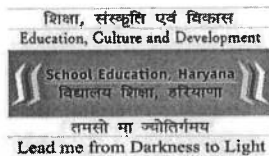
