ORDER

ORDER No. 5/215-2019 HRG-I (1)

Dated, Panchkula, the 07/09/2021

Whereas, Shri Ram Pal [072285], the then Principal, Government Girls Senior Secondary School, Kanina Mandi [3875], Mahendergarh was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 14.07.2020/17.07.2020 and the following allegations were leveled against him:-

"That Hon'ble High Court passed an interim order dated 10.07.2019 in Civil Writ Petition No. 4326 of 2015 titled Nar Dev Versus State of Haryana & others and sought information on re-fixation of salary of the petitioner i.e. Shri Nar Dev, Post Graduate Teacher posted in Government Girl Senior Secondary School, Kanina Mandi, Mahendergarh. In this context, he i.e. Shri Ram Pal was summoned at Directorate on 07.11.2019 and directed him i.e. Shri Ram Pal to comply with the said order dated 10.07.2019 within one week but he i.e. Shri Ram Pal failed to take any action in the matter even though period of one month was elapsed. Further, he i.e. Shri Ram Pal was directed telephonically on 06.11.2019 to appear before the Director, Secondary Education, Haryana, Panchkula on 07.11.2019 with complete record of the case but he i.e. Shri Ram Pal failed to appear till 5.00 PM on 07.11.2019. Thus, he i.e. Shri Ram Pal had not paid any heed in this matter inspite of so many reminders i.e. 15.10.2019, 17.10.2019 and verbal order dated 06.11.2019 as well as telephonic messages by the department on account of which the officers of the department, have to faced embarrassing position before the Hon'ble high Court".

The delinquent officer submitted his reply on dated 29.07.2020 to the above said charge sheet and denied the allegations leveled against him. The delinquent officer mentioned in his reply that Hon'ble High Court passed direction dated 10.07.2019 and the delinquent officer joined in the school on 24.08.2019. He further submitted that he did not receive any information to appear at Directorate on 06.11.2019 although he visited the directorate on 08.11.2019 & 11.11.2019 with complete record.


The reply of the delinquent officer was found un-satisfactory. Resultantly, Shri R P Bhasin, District & Sessions Judge (Retd) was appointed as Inquiry officer vide order dated 04.09.2020/16.09.2020 to conduct regular departmental enquiry. The Inquiry Officer submitted his report on dated 11.11.2020 wherein charges were proved against him. The findings of Inquiry Officer were conveyed to the delinquent officer on 22.12.2020/24.12.2020 under rule 7(C) (I) awarding opportunity of 30 days to make representation on the findings of Inquiry Officer. The delinquent officer made representation dated 16.01.2021. Thereafter, he was personally heard on 04.08.2021 wherein the delinquent officer reiterated that he never intended to disobey the orders of higher authority and visited the Directorate as and when directed. Further, he tendered his unconditional apology & assured to remain more vigilant in future.

Keeping in view the above facts, finding of Inquiry Officer, submissions made by delinquent officer during the course of hearing and documents available

on record, it is observed that though there was omission on his part but there was no such intention to defy the directions of higher authority rather he visited Directorate at the earliest possible opportunity. Moreover, no prejudice and loss has been caused to the state exchequer due to such omission of the delinquent officer.

Therefore, taking a lenient view, the Governor of Haryana is pleased to convert the present charge sheet into rule 8 & the minor punishment of "*Censure*" is hereby inflicted upon him and the suspension period i.e. 21.11.2019 to 16.04.2021 be treated as the time spent on duty.

It is ordered accordingly.

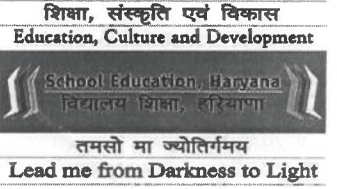

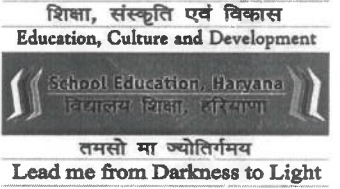

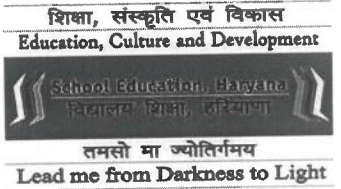
