1. Their appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
 2. They are also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.
3. They will be required to take the prescribed oath of allegiance to the constitution of India.

4. In case they are married, they will produce the following certificate to his/her Head of office:-
 "That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case they are unmarried, they will have to furnished a declaration to the Head of the Department that they have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
9. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
10. If they have not been vaccinated within last twelve months they should have get it done before reporting themselves for duty.
11. No TA/DA and joining time will be paid to them for joining this post.
12. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
13. Their appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
14. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" and amended in the year 2013.
15. Their services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.

16. That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.

Whereas, Shri Anil Sharma [000146] the then Principal, Government Model Senior Secondary School, Sector-32, Chandigarh and having Drawing & Disbursing Powers of Government Senior Secondary School, Police Line (Ambala) [retired on 31.03.2020] was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 12.09.2019/26.09.2019 and the following allegations were allegation was leveled against him:-

1. That while exercising the Drawing and Disbursing Powers of Government Senior Secondary School, Police Line, Ambala and Government Senior Secondary School, Baldev Nagar, Ambala he i.e. Shri Anil Sharma purchased the steel almirha worth Rs. 10642/- from Super Bazar without any approval of the committee i.e. School Management Committee or any resolution passed by the committee i.e. School Management Committee.
2. That he i.e. Shri Anil Sharma paid Rs 4000/- and 2000/- to the labourer on account of construction of slab for science lab at school Government Senior secondary School, Baldev Nagar, Ambala City without making muster roll and approval of the committee i.e. School Management Committee.
3. That he i.e. Shri Anil Sharma had also purchased steel (on loan basis) pigeon box amounting to Rs 14040/- from health fund unnecessarily without following due procedure.
4. That an amount of Rs 13928 was incurred by him i.e. Shri Anil Sharma on purchase of chairs from 'Consolidated Child Welfare Fund' without obtaining the financial approval of the competent authority.
5. That he i.e. Shri Anil Sharma had purchased furniture amounting to Rs 7,786/- from 'Parents Teacher Association' fund which in violation of the 'Parents Teacher Association' Rules.
6. That while he i.e. Shri Anil Sharma was working on deputation with Chandigarh Administration committed various irregularities for which he i.e. Shri Anil Sharma was charge-sheeted under rule 8 of the Punjab Civil Services (Punishment and Appeal) Rules, 1970, vide order memorandum no. DPI-UT-SI-11(125) 2004 dated 07.11.2014 by the Chandigarh Administration.

Whereas, the charged officer submitted his reply on dated 17.10.2019 to the said chargesheet and denied the allegations leveled against him. The reply of the delinquent was found un-satisfactory. Consequently, Shri O P Langyan, IAS (Retd) was appointed as the inquiry officer on 28.02.2020/11.03.2020 to conduct regular departmental enquiry. The inquiry officer submitted his report on dated 24.08.2020 in which charges no. 2 & 4 were proved against charged officer. The operative part of said findings are reproduced as under:-

2. Construction work in science labs of GSSS Baldev Nagar, Ambala city was carried out but no muster roll was prepared which is violation of the instructions issued by the Education Department as the Haryana Education Code Rule 15 (iv) says that Muster Rolls: in case of minor work or repair of value not exceeding Rs. 500/- muster roll shall be maintained in two parts in form B.F.III part I showing the attendance of the labour engaged on the work and part II showing the progress of

the work. Therefore this charge is proved as no muster roll was prepared by the charged official.

4. *It is a fact that chairs worth Rs. 13228/- were purchased from CCWF from the cooperative store but the charged official failed to prove to produce any minutes/recommendation of the School Management Committee for the purchase of these chairs. Therefore this charge is proved.*

Thereafter, the findings of Inquiry Officer were conveyed to the charged officer vide letter dated 22.09.2020/28.09.2020 under rule 7(C)(I) awarding opportunity of 30 days to make representation on the findings of inquiry officer. The charged officer made his representation dated 26.10.2020 denying the findings of the inquiry officer on the above said charges.

Thereafter, the charged officer was granted an opportunity of personal hearing on 27.08.2021. During the course of hearing, the charged officer admitted that he made procedural lapse inadvertently but wages were paid to the labour in time. In respect of charge no. 4, he produced copy of resolution dated 29.04.2015 for purchase of chairs from Child Welfare Fund. It was also stated by the charged officer that he could not provide the copy of resolution dated 29.04.2015 during regular departmental enquiry, as the same was not in his possession at that time & now the same has been obtained through RTI.

Keeping in view the above said facts & circumstances, finding of inquiry officer, reply of charged officer and documents on record, it is observed that wages were paid to labour & there was no complaint to this effect. He admitted his fault in this regard. He also produced the copy of resolution dated 29.04.2015. He also stands retired from the service now.

Therefore, the Governor of Haryana is pleased to convert present proceedings under rule 7 into rule 8 & minor punishment of 'Censure' is hereby inflicted upon Shri Anil Sharma, Principal (Retd.).

It is ordered accordingly.
