Terms & Conditions:

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. **This promotion orders are subject to final outcome of Civil Writ Petitioner No. 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana.**
3. The promote will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
4. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
5. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
6. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

7. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014', the said incumbent(s) shall be reverted without issuing any notice.
8. In case the promote officer found ineligible for the feeder post or unsuitable for appointment/promotion as Post Graduate Teacher/Headmaster on account of any reason, such officer shall stand reverted without any notice.
9. In the case of candidates whose inter se seniority as PGT/ Lecturer is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as PGT/ Lecturer and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
10. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
11. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.
12. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.
13. The District Education Officer concerned shall ensure compliance of above conditions before letting the promoted Principal to join.

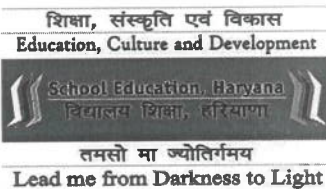

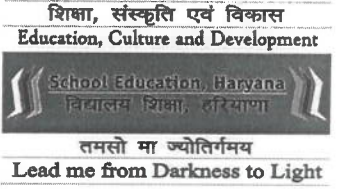

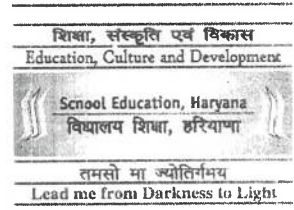

Sh. Anil Kumar, ESHM and others had filed CWP No.27463 of 2018 titled as Anil Kumar and others V/s State of Haryana and others in the Hon'ble Punjab and Haryana High Court, praying therein to promote the petitioners over and above their junior counterparts with all consequential benefits. The civil miscellaneous application No.9834-9835/9838 in CWP-27463 of 2018 which was fixed for hearing on 04.08.2021 and on that day, the Hon'ble High Court was pleased to dispose of the CM No.9834 of 2021 with a direction to complete its pleadings on or before the next date of hearing. After examination of their case minutely it has been found that the claim of the petitioners is liable to be accepted to grant the ante-dated promotion to the petitioners in HES-II Cadre in officiating capacity w.e.f. 10.02.2014 notionally from the date when their junior TGTs have already been promoted as per the seniority of ESHM/TGT Cadre in the Pay Scale of Rs.9300-34800-GGP-5400 on terms and condition mentioned below. Terms and Conditions:-

1. That the petitioners mentioned as above are entitled for benefits of promotion i.e. pay and seniority w.e.f. 10.2.2014 notionally and actually from the date of actual joining duty on post of Headmaster.
2. If the integrity of the promotee is found doubtful, he would be reverted without giving any notice.
3. The inter-se-seniority of the promotee is subject to the claim of their seniors, who have not been promoted in this order due to unknown/various reasons.
4. If any official/master is found senior to the above candidates at any stage due to rectification in seniority, the junior promotee shall be reverted without giving any notice or opportunity of personal hearing.

5. If at any stage, it is found that any official has been promoted in these orders inadvertently who was otherwise actually not fit or eligible for promotion or he has concealed true facts of his service, he would be reverted to feeder cadre post without any notice.
6. That these promotions are subject to the condition that all the particulars and data supplied by the concerned candidates and by the field offices are correct. Eventually, it is found that information is found factually incorrect, erroneous or mis-represented, the promotion so granted shall be withdrawn forthwith without affording any further opportunity.
7. That if the seniority of any official is fixed later on in accordance with the instructions contained in Govt. letter No. 22/73/92-3GS-III, dated 14.10.1999, he/she would be entitled to seniority accordingly.
8. That the candidates would remain on probation for a period of one year from the date of joining on promotional post i.e. Headmaster which may be extended, if there service is not found satisfactory as under service rules.
9. That after joining at the school allotted herein, the candidate shall proceed on a School Leadership Training Programme to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana subject to three weeks training as per schedule fixed by SCERT. The detail programme in this respect would be communicated by the SCERT, Haryana.
10. That the District Education Officer concerned shall personally ensure the following:-
 - (a) That these promotion orders are being issued against vacant post. The Headmaster so promoted is advised to report in the Directorate through the concerned District Education Officer if he finds that the post against which he is appointed is not vacant then he be adjusted at some other place.
 - (b) That the Headmaster is not being posted at any Urban Area by default or any oversight on the part of Directorate.
 - (c) That these promotions are subject to the condition that there is no adverse remark pertaining to integrity in the ACRs of the candidate/employee.
 - (d) That the concerned District Education Officers will not allow the promotee to join duties if any complaint/enquiry under Rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules-1987 is found pending against him/her.
